Whereas, Blair Hamilton and his life partner and public policy partner Beth Sachs helped to establish energy-related organizations in California and Montana, and then founded the Memphremagog Group in Newport, and

Whereas, in 1986, they established the Vermont Energy Investment Corporation (VEIC), which provides consultancy services to both the public and private sector around the globe, and

Whereas, VEIC has facilitated the implementation of creative and successful energy efficiency policies and projects that have reduced the consumption of fossil fuels and introduced more efficient use of energy resources, and

Whereas, Blair Hamilton was the individual most responsible for the formation of Efficiency Vermont, our state's vibrant energy efficiency utility, which has served as a model for other states, and

Whereas, his pioneering work in promoting energy efficiency has been honored repeatedly, including the American Council for an Energy-Efficient Economy's naming Blair Hamilton a "Champion of Energy Efficiency" and Harvard University's Kennedy School of Government granting VEIC an innovation award which Blair Hamilton accepted on the organization's behalf, and

Whereas, in 2010, Vermont Law School conferred upon him an honorary doctor of law degree, and

Whereas, in the moments he was not focused on matters related to energy efficiency, Blair Hamilton enjoyed singing folk songs, skiing, and living in Burlington with Beth Sachs, and

Whereas, Blair Hamilton lived a vigorous life despite having been diagnosed in 1991 with non-Hodgkin's lymphoma, but on Friday April 8, his valiant effort to live life to the fullest ended with his death at age 61, and his survivors include Beth Sachs, son Ben, his parents, and his siblings Bruce,

Ann, and Lynne, and many persons who have lost a special friend, now therefore be it

award until an official announcement was released, but such great news proved impossible to keep secret in the closely knit Lake Region community, and

Whereas, once the news was leaked, the school conducted a special honor assembly that everyone except Andre Messier knew was scheduled, and the challenging logistics included the students figuratively, if not literally, tiptoeing to the event, and the vice principal summoning Andre Messier to the event via a walkie-talkie transmitted request, and

Whereas, born in Marlboro, Massachusetts in September 1917, his ties to Vermont date to the late 1930s when he attended the Vermont Academy in Saxtons River, and

Whereas, Will Curtis and his wife, Jane, who was a close partner and collaborator in all his life's endeavors, operated a dairy farm in Hartland, and

Whereas, his active participation in agricultural associations expanded his civic horizons, and he served as the member from Hartland in the House of Representatives during the 1963 Biennium, and

<u>Whereas</u>, Will and Jane Curtis's literary passions served them well during their proprietorship in the 1960s of the Yankee Bookstore in Woodstock, and

Whereas, their love of books, and special interest in Vermont's cultural heritage, motivated them to celebrate our state as coauthors of a number of volumes, including ones on historic Woodstock, George Perkins Marsh, Calvin Coolidge, and military sites in the Champlain Valley, and looking beyond the state's borders, they were among the authors of a monograph on the artists of Monhegan Island, Maine, and

Whereas, Will Curtis's volunteer work with the Vermont Institute of Natural Sciences served as the springboard for his best know role as the host of "The Nature of Things" radio series, aired for many years on Vermont Public Radio and distributed nationwide for listeners to enjoy and to learn about our natural environment, and his writings about Jane Curtis's and his journeys to exotic locations and his scripts were compiled into two anthologies, and

Whereas, Will Curtis was an active and avid member of the Ottaquechee Section of the Green Mountain Club who, with his wife, led outdoor excursions ranging from historic walks to mountain ascents, and they were coauthors of the Green Mountain Club's 75th anniversary volume, *Green Mountain Adventure: Vermont's Long Trail*, and

Whereas, Will Curtis's long and well-lived life has now concluded at the age of 93, and his survivors include his wife, Jane, now therefore be it

Whereas, the Manchester and the Mountains Regional Chamber of Commerce is inviting every Vermont town to stage a pumpkin carving event that will serve as a substantial local economic driver, and

Whereas, in order to celebrate the art of pumpkin carving and as an incentive to encourage the economically important Columbus Day holiday weekend visitors to linger in Vermont just a little longer, a mid-October statewide pumpkin carving day would encourage other communities to conduct pumpkin carving festivities, now therefore be it

House concurrent resolution commemorating the 250th anniversary of the establishment of the town of Pawlet

Offered by: Representative Malcolm of Pawlet

Whereas, on August 26, 1761, New Hampshire Royal Governor Benning Wentworth granted to Jonathan Willard and other proprietors a charter for the town of Pawlet that encompassed an area not to be greater than six miles square, "Begining the North West Corner of Rupert from thence runing due North Six Miles Thence due East Six Miles thence Due South Six Miles to the North East Corner of Rupert . . .", and

Whereas, Jonathan Willard visited the site in either 1761 or 1762 and cleared some land but he remained only briefly, and

Whereas, although the first known meeting of the proprietors occurred in 1764, the first settler, Dr. Simon Burton, arrived in 1768, and he became Pawlet's first town clerk in 1769, and

Whereas, Pawlet's citizens fought bravely during the Revolutionary War, and

Whereas, the first religious congregation organized in Pawlet was the Congregational Church founded in 1781, and

Whereas, due to the fertility of the land in the Mettowee River Valley, agricultural pursuits were central to Pawlet's early economy as was the production of potash and maple sugar, and

Whereas, several mills operated in Pawlet during the 19th century by deriving water power from either the Flower Brook or the Mettowee River, and

Whereas, the opening in 1851 of the Rutland and Washington Railroad through West Pawlet spurred the opening of slate quarries and the arrival of a sizeable community of Welsh and other immigrants with mining backgrounds, and

Whereas, musically speaking, in 1855, Pawlet's Joshua Stoddard was granted a patent for a steam calliope, and

Whereas, during the Civil War, Pawlet native Marcellus Jones fired the first shot at the Battle of Gettysburg, and

Whereas, while Pawlet's brave men were defending the union at great risk to their own lives, the Consider Bardwell farm in West Pawlet opened Vermont's first cheese factory in 1864, and

Whereas, in 1881, construction commenced on Pawlet's town hall, which has served the citizenry well for over century, and

Whereas, to celebrate the 250th anniversary of its charter, Pawlet is planning a festive day of celebratory events on August 26, 2011 at which a parade, a barbecue, a street dance, a ghost walk, fireworks, and the appearance of Daniel Webster, no less, are planned, now therefore be it

Whereas, the GIA enables American high school students at three selected schools to partner with their peers at a high school in the Middle East or North Africa on a service-learning environmental studies project, and

Whereas, three videoconferences, each featuring all three teams offering project presentations, serve as a direct link for the students on both sides of the globe and as a digital forum for environmental experts to judge each team's presentation, and

Whereas, after the third videoconference, students from the winning team are awarded a trip to visit their counterpart school across the sea, and

Whereas, the SoRo students had an assignment of water quality for which they used technological resources to gather international ideas and conduct research, and they consulted professionals to guide them, and

<u>Whereas</u>, in their dream of preserving water quality, the SoRo students collaborated with the White River Partnership and other experts in the planning of a riparian buffer zone that on April 29 will be planted along the White River with community participation in the event, and

Whereas, the SoRo team was partnered with the Shevah Mofet School in Tel Aviv, Israel where the students are working to improve water quality in the Yarkon River, and

Whereas, after two of the three videoconferences, the SoRo–Sheva Mofet team is in the lead in the GIA competition, and

Whereas, the entire SoRo GIA roster, consisting of Callan George, Skye Lockwood, Sarah Caron, Ellen Manby, Parker Audsley, Jesse James, Alexander Berk, Maggie Dakin, Emma Honigford, Leif Johnson, Dylan Orechovesky, Rebecca Paige, Moriah Post-Kinney, Barbara Timian, and Callie Wuttke, hopes to accomplish its project goals and have its water quality message reach a large audience, and

Whereas, one of the most respected citizens in the town of Shaftsbury was Dr. Arthur Faris, whose medical expertise, role as a public education leader, and civic engagement left a lasting beneficial impact on his community, and

Whereas, a World War II veteran, he graduated from Princeton University and from Albany Medical School, and

Whereas, he and his late wife, Dr. Elizabeth Faris, jointly operated a family medicine practice in Shaftsbury for nearly 40 years, and

Whereas, their commitment to serving all patients who knocked on their door led them to accept nontraditional forms of compensation, and

Whereas, he and his wife built the Shaftsbury Medical and Dental Center and provided practicum experiences for second-year medical students, and when they retired from practice, the town honored them for their medical service, and

Whereas, Bennington County called upon Dr. Arthur Faris's expertise during his tenure as the county's medical examiner, and he also served as the Shaftsbury town health officer and the physician for the Vermont Veterans' Home, and

Whereas, the Vermont Academy of Family Physicians benefited from his leadership as the organization's president and presented him with its Physician of the Year Award in 1993, and

Whereas, as one of the original members of the Mount Anthony Union School District board, Dr. Arthur Faris was a leader in the effort to create a regional secondary education center, and

Whereas, in the town of Shaftsbury, he assumed elected and appointed leadership positions including selectboard chair, town auditor, lister, and zoning board member, and

Whereas, his political interests led him to serve as vice chair of the Shaftsbury Town Democratic Committee, and

Whereas, on March 7, 2011, this esteemed resident of Shaftsbury died, leaving three sons, Tom, Chris, and Greg, a daughter Ann, and a grandson Jaalid, now therefore be it

Resolved by the Senate and House of Representatives:

House concurrent resolution congratulating the town of Dorset on its 250th anniversary

Offered by: Representative Komline of Dorset

Offered by: Senators Hartwell and Sears

Whereas, the town of Dorset was established, in accordance with a 1761 charter that New Hampshire Governor Benning Wentworth granted, to 64 grantees, of whom 17 were named Lyman, though none of the family's members ever arrived in Dorset, and

Whereas, the town was probably named in honor of an English nobleman, Lionel Cranfield Sackville, the first duke of Dorset, and the town's boundaries commenced "At the North West Corner of Manchester . . . ," and

Whereas, the first known Dorset records recording a town meeting date from 1797, but other documents make reference to the election of Asa Baldwin at a town meeting convened on March 8, 1774, and

Whereas, the four Dorset Conventions convened in 1775 and 1776, all held at Cephas Kent's tavern, were significant events in the progression toward the establishment of Vermont as an independent state, and

Whereas, the Dorset Congregational Church was founded on September 22, 1784 as the first religious body in Dorset, and its meetinghouse was built in Maple Hill, and

Whereas, the long association between Dorset and marble began in 1785 when the nation's first marble quarry was started, and the establishment of the Fenton (later Bennington) Potteries in the early 19th century brought a second important industry to the town, and

Whereas, in 1977, Father Don took on a new triple parish assignment that included Holy Cross Parish in Morrisville, St. Teresa Parish in Hyde Park, and St. Gabriel Parish in Eden, and

Senate concurrent resolution commemorating the 25th anniversary of the Chernobyl nuclear disaster with thoughts of the current nuclear crisis in Japan.

Whereas, on April 26, 1986, an explosion knocked the cap off reactor #4 at the Chernobyl nuclear power station, 100 kilometers north of the Ukrainian capital of Kyiv (Kiev) with a multimillion population in its metropolitan area, and

Whereas, the Chernobyl accident was the largest unintentional radiation release which had occurred to that date, and

Whereas, the explosion immediately killed a number of station personnel, and some estimates of the overall death toll from the catastrophe range in the many thousands, and

Whereas, at least 600,000 personnel were sent into the most contaminated zone to manage clean-up and rescue operations, and a significant number of these individuals reportedly died within several years of the operation, and

Whereas, approximately nine tons of radioactive material were shot into the atmosphere which is 90 times more radiation than was released by the atomic bomb dropped on Hiroshima, and

Whereas, radioactive particles rained down on places thousands of miles from Chernobyl, including much of Europe and the United Kingdom, and

Whereas, as the world commemorates the 25th anniversary of this horrible event in the history of nuclear power generation, the destruction of the cooling systems at the Fukushima I (Fukushima Dai-ichi) nuclear power facility in Japan that resulted form the recent Japan earthquake and tsunami is a matter of concern, and

Whereas, the cooling systems' destruction has led to the steady leaking of radiation and forced the evacuation of the immediate area, and

Whereas, although none of the nearly 14,000 deaths to date attributed to the recent earthquake and tsunami has been directly tied to the nuclear facility

damage, any long-term health impact of the continued radiation leaks is impossible to determine, and

Whereas, regulatory authorities in Japan have now classified the nuclear disaster at Fukushima Dai-ichi as a Level 7, the most severe on the International Nuclear Event Scale, and only Chernobyl had previously been rated as a Level 7 event, now therefore be it

That the General Assembly commemorates the 25th anniversary of the Chernobyl nuclear disaster with thoughts of the current nuclear crisis in Japan, and be it further

Whereas, two of the individuals who were largely responsible for the success of VPQHC were its former medical director, Dr. Cyrus Jordan, and executive director, Helen Riehle, and

Whereas, for 18 years, Dr. Cyrus Jordan contributed his medical expertise to the work of the VPQHC, assuring that the organization observed the highest professional and technical standards in all of its consulting, evaluation, and reporting activities, and

Whereas, during her decade as the executive director of the VPQHC, Helen Riehle carefully managed and oversaw all administrative aspects of the organization and its programs, and

Whereas, under their joint leadership, VPQHC served a major leadership role in developing the diabetes collaboratives and the pilot sites for the Blueprint for Health that enabled the Blueprint to evolve into a cornerstone of Vermont's health care reform initiatives, and

Whereas, they directed VPQHC's publication of an annual Quality Report on Vermont health care that the federal Agency for Healthcare Research and Quality has used as a model for its own National Health Care Quality Report, now therefore be it
