House concurrent resolution congratulating the Cambridge municipal emergency and highway officials on their superb response during the 2011 spring floods

Whereas, on the night of April 26, 2011, an extremely heavy rain fell on the town of Cambridge, and

Whereas, a combination of this large and sudden onslaught of precipitation plus the seasonal snow melt resulted in a rapid rise in the water levels of the Lamoille River and its tributaries, and

Whereas, the high water levels led to flooding in areas that had not been under water in more than a decade, and

Whereas, the flood waters isolated local businesses and residences and trapped individuals in their own homes, and

Whereas, for a period of time, routes to hospitals were blocked, and the village of Jeffersonville, the commercial heart of Cambridge, became totally isolated, and

Whereas, emergency service personnel were suddenly confronted with multiple requests for assistance, all of which justified quick attention, including emergency rescue operations, evacuations, assisting highway officials, and responding to medical situations, and

Whereas, during the period of the flood emergency, 113 persons were evacuated from their homes and they either were placed in shelters or arranged

to stay with family or friends, and 150 homes were checked for safety purposes, and

Whereas, as the waters began to recede, local firefighters were required to remove water from flooded basements and clear debris that was blocking previously flooded homes, and

Whereas, highway crews were required to make emergency repairs to local roadways to make them passable until more long-term repairs could be arranged, and

Whereas, all of the Cambridge municipal emergency and highway officials worked diligently and effectively to alleviate the many problems that arose during the flood and after the waters of the Lamoille River and its tributaries had receded, now therefore be it

Whereas, a native of Maine, Al Moulton served in the United States Navy during World War II and graduated from the University of Maine with a degree in journalism, and

Whereas, after working as a journalist in Maine, he relocated to Vermont, leading both the Brattleboro and Rutland chambers of commerce, and

<u>Whereas</u>, in 1964, Governor Philip Hoff asked Al Moulton to serve as the chief economic development officer for the state of Vermont, and

Whereas, Al Moulton served governors Philip Hoff, Deane Davis, Richard Snelling, and Madeleine Kunin most ably regardless of their partisan affiliation, and

Whereas, his ability to work successfully for governors of both political parties was a testament to his professionalism, and

Whereas, he was personally a staunch Republican who while state party chair once rode an elephant into a party dinner, and at the same dinner, two

persons dressed as Governor Phil Hoff and Lieutenant Governor John Daley followed behind carrying shovels, and

Whereas, in the environmental arena, in 1968, Al Moulton played a pivotal leadership role in the enactment of Act 333, the state's billboard law, and two years later, he performed the same function with equal effectiveness in helping to rally support for Act 250, and

Whereas, in recognition of his contemporaneous achievements on the economic and environmental fronts, Al Moulton earned the honorary title of Mr. Vermont, and

Whereas, after an illustrious life, Al Moulton has died at the age of 85, and survivors include his daughter, Deputy Secretary of Commerce and Community Development Patricia Moulton Powden, three sons, Robert of Duxbury, David of Whitingham and Dan of Calgary, Alberta, now therefore be it

House concurrent resolution congratulating the town of Reading on its 250th anniversary

Whereas, the picturesque town of Reading was established in accordance with a charter which New Hampshire Royal Governor Benning Wentworth issued to a group of proprietors on July 6, 1761, and

Whereas, the territory of the town measured "Six Miles square, and no more" with boundaries "Beginning at the South West Corner of Winsor from thence North Seventy four degrees West Six Miles...," and

Whereas, a decade would pass before Andrew Spear arrived from Walpole, New Hampshire to become the first settler in Reading in approximately 1772, and

Whereas, the town of Reading was organized on March 30, 1780 at a meeting held at the home of John Weld, and

Whereas, in 1790, the year before Vermont was admitted to the Union, the United States Census recorded that the town of Reading was home to a population of 747 persons residing in 137 households, and

<u>Whereas</u>, the town of Reading comprises the villages of South Reading which Ebenezer Robinson settled in 1788; Felchville, an area in which William Felch began to construct homes in 1827; and Hammondsville, named for David Hammond who operated a shoe store, and

Whereas, among the industries and trades that were established during the early years of Reading were woolen mills, a chair manufacturer, a map maker, and the Budd Hawkins Seed Company in the 1815 house, and

Whereas, with respect to public education, the first documented class of instruction was held in 1827 in one room of an unfinished hotel under the directorship of one Miss P. Wentworth, and according to Gilbert Davis's 1874 history of Reading, Salmon P. Chase, who served as the sixth Chief Justice of the United States Supreme Court, once taught school in District No. 7 (the Chase District), and

Whereas, during the 1830s, Levi Bailey constructed a brick home and other structures that served a variety of commercial purposes, including various mills, and his home may have served as a stop on the Underground Railroad, and

Whereas, the Forrest House served as a grange hall, the home of a spiritualist, and a dance hall described during the stage coach era as the best tavern between Boston and Derby Line, now therefore be it

Whereas, the professional editorial leadership and *The Commons*'s continuously improving journalistic output established the foundation for the publication winning six New England Newspapers and Press Association awards for journalism excellence, and

<u>Whereas</u>, increasing the number of community-based writers published in *The Commons* is being realized through the paper's distinctive Voices section that welcomes and features letters, essays, viewpoint commentary, and other original material from around the county and, when relevant, the state, and

Whereas, *The Commons* is considered a model for a successful local weekly newspaper, and the editorial staff was featured in the recent Vermont Public Television documentary, "Headline Vermont," on the history of newspapers in the state, and this television documentary has been nominated for a New England/Boston regional Emmy Award, and

Whereas, VIM has also started a media mentoring project to teach journalism skills to adults and to children in schools, and

Whereas, on May 11, 2011, *The Commons* will proudly publish its 100th issue, now therefore be it

Whereas, for over a century, young boys have spent a memorable summer life at the renowned Camp Keewaydin on the shores of Lake Dunmore in Salisbury, and

Whereas, for 36 years as co-owner and 54 years in a leadership role, Alfred Hare lovingly devoted his creativity and energy to this idyllic New England youth retreat, where outdoor adventure and the formation of lasting friendships are paramount, and

Whereas, Alfred Hare was born in Philadelphia in 1914, and

Whereas, in 1923, Alfred Hare spent his first summer as a Keewaydin camper, and the bond he formed with the camp endured for a lifetime as a camper, counselor, director, and owner, and

Whereas, Alfred Hare was called "Waboos," an Ojibwe language word for "white rabbit," by a counselor during Alfred's first Keewaydin summer, and the term accurately described this tow-headed boy, and

<u>Whereas</u>, "Waboos" became Alfred Hare's special nickname by which he was affectionately known for the balance of his life, and

Whereas, at the close of World War II, while stationed in Paris on military duty, Waboos Hare ran into a friend and former Camp Keewaydin counselor, Abbott Fenn, and along with another former Camp Keewaydin counselor, Harold "Slim" Curtiss, they purchased the camp which was then up for sale, and

Whereas, the Hare-Fenn-Curtiss trio embarked on an ownership partnership, and they also served as the camp's codirectors, perpetuating its great traditions of summer pleasure for young boys, and

Whereas, in 1982, they sold Camp Keewaydin to the nonprofit Keewaydin Foundation Inc., and Waboos Hare remained the camp's summer director until the year 2000, when his son Peter succeeded him, and
