Whereas, Michael J. Garofano's death robbed the community of a unique public servant whose dedication to his job and personal work ethic were truly amazing, and

Whereas, each work day, he would be on the job at 6 a.m. in order to monitor the city's water supply to the maximum extent possible, and

Whereas, Michael J. Garofano's concern that the reservoir should be protected from gasoline and similar contaminants was the primary motivation for the installation of a hydrocarbon alarm system, which he faithfully maintained for 17 years, and

Whereas, he personally assisted in the cutting of lumber at a local sawmill for a new supply shed, minimizing the project's supply costs, and

Whereas, Michael J. Garofano was the protector of the Rutland City reservoir, and the fierceness of his demeanor when speaking about the water system represented his constant focus on the special responsibility with which the city had entrusted him, and

Whereas, Michael G. Garofano had accompanied his father on the fateful day of August 28 to assist him in any way that might be of service in guaranteeing the safety of the water system, and

Whereas, both men had graduated from Vermont Technical College, had deep roots in the community, and were members of a closely knit family, and

Whereas, on September 9, 2011, a well-attended hero's funeral was conducted for Michael J. Garofano while the search for his son went on for a further two weeks, and

Whereas, two months later, a benefit pasta dinner raised \$3,000.00 for the Garofano family's memorial fund, now therefore be it

Whereas, after her freshman year, she decided to enter the Sisters of Mercy, but Sister Elizabeth's life was not typical of most nuns' lives, and

Whereas, seeking to advance her own education, Sister Elizabeth studied at Fordham University in New York, earning master's and doctoral degrees in medieval English language and literature, and

Whereas, after graduation, she taught at both Mount Saint Mary Academy and the Cathedral Grammar School, excelling as a teacher, and

Whereas, as a faculty member at Trinity College, Sister Elizabeth taught the works of Chaucer and Shakespeare and for over 50 years would teach at least one course each semester, and

Whereas, Sister Elizabeth was honored to serve for a decade (1966–1976) as president of Trinity College, participated in many civic and educational organizations, especially those advocating women's empowerment, and was the recipient of eight honorary doctoral degrees from Vermont colleges and universities, and

Whereas, Sister Elizabeth broke new ground when she took her heartfelt advocacy for the poor and underprivileged into state government, serving as Governor Richard Snelling's dedicated secretary of the agency of human services from 1977 to 1983, and

Whereas, she then resumed her life at Trinity College as a special assistant to the president and, of course, as a teacher of literary classics, and

Whereas, Sister Elizabeth was a daring woman who at the age of 76 took a rafting trip on the Colorado River through the Grand Canyon, and

Whereas, the Boston Red Sox and New England Patriots had no more devoted a fan than Sister Elizabeth, and she was known to wear red socks to display her loyalty to the men of Fenway, and

Whereas, during the closing months of her life, Sister Elizabeth was heartened to share this special time with her many friends, who brought her much joy until her death at the age of 90 on February 1, 2012, now therefore be it

Whereas, Tong Chen studied English in China with extensive reading and writing lessons but minimal conversational practice, and consequently she provides her classes with frequent opportunities to speak Chinese, and

Whereas, she is a leader in organizing her school's Journey East Art and Cultural Exchange Program, volunteers at the University of Vermont's Asian Studies Outreach Program, serves as an interpreter for Chinese immigrants in New England, and is studying for a doctoral degree in educational leadership, and

Whereas, in recognition of her exemplary success as a teacher, Tong Chen has been honored as Vermont's 2012 Teacher of the Year, and the award was presented to her at a ceremony at which her students, parents, and local and state educational officials attended, and

Whereas, for nearly 100 years, the University of Vermont Extension (UVM Extension) has offered Vermonters enriching educational opportunities that focus on agriculture and other worthy topics, and

Whereas, UVM Extension was established on February 15, 1913 when Governor Allen M. Fletcher signed into law Act 83, which provided funds to "be expended solely for work in agricultural extension, including the establishing of extension schools . . . the support of district field agents in co-operation with the United States department of agriculture, and kindred enterprises . . . ," and

Whereas, the first agents traveled at times to their educational demonstrations by horse-drawn carriage, and today they use the latest online computer and telecommunications technology, and

Whereas, by 1915, the 4-H youth educational programs, still a vital part of UVM Extension today, were in full operation, and the local organizations that evolved into the Vermont Farm Bureau were established in the nine counties to which UVM Extension agents had been assigned, and

Whereas, since the 1920s, UVM Extension has maintained a close association with the Vermont Maple Sugarmakers Association, and this relationship has promoted the improvement and expansion of Vermont maple sugaring, and

Whereas, in 1922, radio station WCAX (standing for Cooperative Agricultural Extension) received its federal license and took to the air with broadcasts that the UVM College of Agriculture produced, and

Whereas, improving the well-being of the dairy industry has long been a major focus of UVM Extension, and

Whereas, another important mission of UVM Extension is its support for agricultural diversity in Vermont, including the cultivation of berries and vegetables and the production of cheese and wool, and

Whereas, UVM Extension is celebrating its centennial anniversary year with an update of its historical volume *Highlights of the Vermont Extension Service: From the Beginning* under the new title 100 Years of UVM Extension in Pictures, 1913–2013, and

Whereas, today, February 15, 2012, the 99th anniversary of the signing of Act 83, representatives of UVM Extension are visiting the State House to inaugurate the centennial anniversary festivities, now therefore be it

Whereas, Vermont is not usually known as the locale where America's greatest golfers first tee off, but Keegan Bradley, originally from Woodstock, has now shattered that assumption, and as a youngster expressed a strong preference for golf over wintertime sports, and

Whereas, Keegan Bradley's affinity for swinging a golf club was perhaps inherent as his aunt, Pat Bradley, is a member of the sport's hall of fame, and his father is a golf pro who has worked in Woodstock, Wilmington, and Springfield, and

Whereas, the Woodstock Union High School team was a beneficiary of Keegan Bradley's golfing talent until his family moved to Hopkinton, Massachusetts where he graduated from the local high school, and

Whereas, as a proud member of the St. John's University Red Storm golf team, Keegan Bradley was known as the player who always wanted to practice at every opportunity, including school vacations, a work ethic that resulted in his clinching nine individual titles and establishing a school record for a three-round championship, and

Whereas, in 2008, he graduated from St. John's with a degree in sports management and set off to pursue his dream of a professional golfing career, and

Whereas, as a recent recipient of his PGA Tour Card, this past August, he played in the prestigious 2011 PGA Championship at Johns Creek, Georgia, ranked 81st among his colleagues, and

Whereas, in October, he triumphed once again, winning the 2011 PGA Grand Slam tournament in Bermuda, and

Whereas, chronic obstructive pulmonary disease (COPD) is a term used to describe airflow obstruction that is associated mainly with emphysema and chronic bronchitis, and

Whereas, COPD affects an estimated 24 million people including 13,000 Vermonters, 12 million remain undiagnosed, COPD kills more than 120,000 Americans every year, and one person dies from COPD approximately every four minutes, an alarming statistic for a disease many have not learned about, and

Whereas, in 2010, the National Center for Health Statistics released a report stating that in 2008, COPD became the third leading cause of death in the United States and is the second leading cause of disability, and pulmonary experts predict that by 2020, COPD will become the third leading cause of death worldwide, and

Whereas, COPD accounts for 1.5 million emergency room visits, 726,000 hospitalizations, and eight million physician office and hospital outpatient visits, all of which are detrimental to the U.S. economy; up to 70 percent of the costs of COPD are due to hospitalizations, which can largely be prevented, and

Whereas, COPD costs the nation an estimated \$42.6 billion in direct and indirect medical costs annually, and

Whereas, research has identified a hereditary protein deficiency called alpha-1 antitrypsin; people with this deficiency tend to develop COPD, even without exposure to smoking or environmental triggers, and

Whereas, recently, the death rate for women with COPD has surpassed the comparable rate for men, and women over the age of 40 are the fastest-growing segment of the population affected, and

Whereas, there is currently no cure for COPD, but spirometry testing and medical treatments exist to address symptom relief and possibly slow the progression of the disease, and

Whereas, the United States Senate, the United States COPD Coalition, and the National Heart, Lung and Blood Institute recognize November as COPD Month, now therefore be it

<u>Whereas</u>, several of these projects involved the expansion of correctional and library complexes, including the Northeast State Correctional Facility in St. Johnsbury and the Caledonia Community Work Camp, and

Whereas, he was especially proud of the two capital complex projects in Montpelier for which he served as clerk of the works, one of which was the renovation of the Vermont Supreme Court and the expansion of the Pavilion Office Building that provided much-needed new space for several state departments and that connected the two buildings, and

Whereas, perhaps one of his most important assignments was serving as clerk of the works for the State House expansion in the 1980s that created new office, meeting, and cafeteria space in the building, and

Whereas, he took pride in performing his duties in accordance with the best professional practices and standards, and
