<u>Whereas</u>, the demand for registered nursing services will be greater than ever because of the aging of the American population, the continuing growth of life-sustaining technology, and the explosive growth of home health care services, and

Whereas, the cost-effective, safe, and quality health care services that registered nurses provide will be an ever more important component of the U.S. health care delivery system in the future, and

Whereas, the American Nurses Association and the Vermont State Nurses' Association have declared the week of May 6–12 as National Nurses Week 2012 with the theme "Nurses: Advocating, Leading, Caring" in celebration of the ways in which registered nurses strive to provide safe and high-quality patient care and to map out the way to improve our health care system, and

Whereas, one of Vermont's pioneer alpine skiing destinations was established in 1936 when Fred Pabst opened the Bromley Mountain Ski Resort in Peru, and

<u>Whereas</u>, Bromley Mountain is New England's only major ski resort with a sunny southern exposure, and

Whereas, accessing the top of the trail became easier in 1939 when the first uphill lift was installed, and many more advanced skier transportation systems have succeeded the original, and

Whereas, Bromley's commitment to families was established in 1946 when the first slopeside fully certified children's nursery at a ski resort was opened, and

Whereas, in the 1960s, Bromley became the world's largest snowmaker at the time, being the first ski resort to spend one million dollars on snowmaking, and

Whereas, summertime recreation was introduced in 1976 with the opening of the Alpine Slide, and other warm weather activities, including the recently added Sun Mountain Flyer ZipRider, have been installed with great success, and

Whereas, in the 1980s, the Blue Ribbon Quad, Havoc, and Pabst Panic were opened and snowmaking was further expanded; in the 1990s, a highlight was the introduction of the high speed detachable quad; and many improvements have been introduced in recent years, both on the slopes and slopeside, and

Whereas, the Bromley Outing Club (BOC) was the creation of Fred Pabst's wife, Sally Pabst, and her colleague, Ruth Fowler, who sought to provide

low-cost skiing instruction to local area residents, and

Whereas, the BOC's Junior International Ski Program has been a BOC mainstay since the club's establishment and provides skiing, and now also snowboarding, instruction to schoolchildren in 14 nearby communities, and

<u>Whereas</u>, on a more advanced level, BOC operates a training program for young persons aspiring to race competitively on and off its 46 trails and glades, now therefore be it

Whereas, all of the many wintry days these young Nordic skiers accelerated and glided across meadows and through wooded terrain served as preparation for the state championship meet, and

Whereas, this capstone of the secondary Nordic skiing season is a two-day event, and

Whereas, in 2012, the opening free-style day was skied at Jericho and the second championship determining day of classic competition took place at Grafton Ponds, and

Whereas, in Division I girls' competition, the classic events consist of individual racing in the morning followed by a team relay in the afternoon, and

Whereas, the CVU girls excelled as individuals, exhibiting both speed and comfort on the course, and

Whereas, a Redhawk proved the fastest, as a CVU skier crossed the finish line first with a time of 20 minutes and 18.58 seconds, and

Whereas, her teammates were not far behind, as the Redhawks captured six of the top 15 finishing slots including third and sixth, and

Whereas, in the afternoon, the CVU girls proved that they are equally proficient skiing as a team, as the Redhawks won the relay competition, and

Whereas, these combined great performances on the course totaled a mere 54 points, giving CVU an overwhelming overall lead and the 2012 Division I girls' Nordic championship, as the Redhawks topped their nearest rival Mount Anthony, which earned 141 points and second-place honors, and

Whereas, this wonderful team of CVU Nordic skiers who raced gracefully and successfully included Sienna Searles, Taylor Spillane, Autumn Eastman, Cally Braun, Kathryn Maitland, Emma Hamilton, Kayla Servin, Ellie Stone, and Isabelle Unger, and

Whereas, Head Coach Sarah Strack and Assistant Coaches James Donegan and Eli Enman were an inspiration for the team and skillfully mentored the skiers throughout the season, now therefore be it

Whereas, for nearly 60 years, the Open Door Mission has been a welcoming destination for the needy and homeless, especially veterans, in the Rutland area, and

Whereas, the Open Door Mission originally opened in 1963 on Pine Street, but by the middle 1980s, that building was no longer a sustainable place for the organization to remain, and

Whereas, the city of Rutland voted in 1986 to lease the shuttered former Park Street School to the mission, but the process of finalizing this move was not simple, as a court battle and difficult political discussions ensued before the agreement was finalized, and

Whereas, community generosity then became the order of the day as General Electric, which has a Rutland manufacturing plant, donated a new boiler, and a private contributor paid for the removal of asbestos from the school building, and individual and corporate support has continued, and

Whereas, once overcoming all of the legal, political, and physical barriers to completing the relocation, the Open Door Mission moved in on March 9, 1987, serving its first meal, featuring donated kielbasa, on St. Patrick's Day, and

Whereas, over the past 25 years, the staff of the Open Door Mission estimates that it has served a million meals, and

Whereas, 50 individuals find shelter and support as temporary residents at the mission, and the facility serves 120 meals a day, and

Whereas, in celebration of the Open Door Mission's 25 years of invaluable community service at its Park Street location, the mission hosted a commemorative dinner and ceremony on Friday, March 23, 2012, and

Whereas, in attendance were many dignitaries including Governor Peter Shumlin, Rutland Mayor Christopher Louras, Rutland Board of Aldermen President David Allaire, the Reverend Richard Tinney, the chair of the mission's board of directors, Mary Murphy, who served the first meal in 1987, and most importantly, veterans, current residents at the mission, and members of the public in need of a meal, and

Whereas, while celebrating its accomplishments of the past quarter century, the Open Door Mission continues to focus on its vital community service commitment, now therefore be it

House concurrent resolution in memory of Allyn Seward of East Wallingford

Whereas, Allyn Seward was closely associated with municipal governance in the town of Wallingford, where he resided throughout his life, and

Whereas, his interest in public service began at an early age when he served as a legislative page during the 1927 session of the general assembly, and

Whereas, a lifelong farmer, he offered his commonsense wisdom on many areas of concern to the local citizenry, and

Whereas, for a decade, Allyn Seward sat on the Wallingford selectboard and ably chaired this panel for three years, and

Whereas, among the other positions he held during his public service career were town lister (three years), overseer of the poor (four years), and road commissioner (two years), and

Whereas, firefighting was a responsibility which Allyn Seward viewed as an important personal obligation, and

Whereas, for 20 years, he was the capable fire warden for the town of Wallingford, and

Whereas, the voters of the Wallingford Fire District #2 elected him to the prudential committee, on which he served for 34 years including several as the chairman, and

Whereas, his hands-on fire-fighting skills were often called upon, as Allyn Seward was a member of the East Wallingford Volunteer Fire Department for 35 years, and

Whereas, in 1966 he was appointed to the Maple Grove Cemetery Association, and, four years later, he was elected president and commissioner, and he remained active in the association for the next 42 years, and

Whereas, for nearly three quarters of a century, Allyn Seward was a Master Mason of the Mount Moriah Lodge #96, and

Whereas, after a long life of farming and public service, Allyn Seward died on March 28, 2012 in East Wallingford, the same community where he had been born on June 11, 1914, and

Whereas, surviving Allyn Seward are his daughters Anne and Judy, sons Chuck and Mike, 11 grandchildren, 14 great-grandchildren, and his brother Stanley, now therefore be it

Whereas, 30 of the youngsters are selected to join the adventure of a 70-show tour through the northeastern United States, staged in a 750-seat performance tent, keeping the 200-year tradition of the traveling circus alive and thriving, and, despite unforeseen events, no scheduled performance has ever been canceled, and

Whereas, for the most dedicated and talented of the young troupers, Circus Smirkus tours are no mere summer frolic, as 15 percent of the performers will continue on to professional circus careers, and visits from scouts representing Cirque du Soleil and major European circuses provide a special audition opportunity, and

<u>Whereas</u>, Circus Smirkus has traveled to the International Children's Festival in Vienna, Virginia, across the Atlantic to Sweden, Russia, and the Ukraine, and the organization is now working with the National Circus School of Cuba in anticipation of an artistic cultural exchange, and

Whereas, a special performer was the late renowned mime Marcel Marceau, who broke his traditional silence to speak from under the big top on behalf of Circus Smirkus, and

Whereas, Circus Smirkus has provided the center ring for nonprofit fundraising totaling \$2.5 million, and

Whereas, thousands of persons have watched Circus Smirkus in action in the Disney Channel series *Totally Circus*, a new award-winning film, *Circus* 

*Dreams*, will be broadcast on PBS, and many articles have been written about the circus, and

Whereas, tomorrow, Saturday, April 21, 2012, circus fans around the globe will celebrate the third World Circus Day, and this observance is a fitting occasion to commemorate the 25th anniversary of Circus Smirkus, now therefore be it

Whereas, for 35 years, she taught at the Riverside Middle School, and her retirement from this position opened up the opportunity for Marita Johnson to pursue a life that is the antithesis of the typical retiree's lifestyle, and

Whereas, her love of teaching did not end with her departure from the middle school classroom, as Marita Johnson is now a videographer for: Springfield Area Public Access Television on whose behalf she has filmed many programs for cablecast including the Osher-UVM Lifelong Learning Series, of which separately she is a founding board member and program director; a program on the B-29 bomber crash site in Weathersfield; a presentation on Crown Point Road travels; and many programs for the town's sesquicentennial observances, and

Whereas, aside from her filming role, Marita Johnson served other duties in connection with Springfield's 250th anniversary including creating an 18-month town history calendar and planning and organizing numerous

activities including historic cemetery walks and activities associated with Fair Day, and

Whereas, at the Miller Art Center, Marita Johnson has assisted with the restoration of the gardens and other efforts to maintain the property, and

Whereas, the Springfield Garden Club has called upon Marita Johnson to fill many offices including historian, publicity chair, and scholarship chair, and she has been available for any other duties required, such as planting and weeding and making wreaths for the annual Festival of the Trees, and

Whereas, Marita Johnson has promoted river cleanup as a member of the Black River Action Team, assists with the community projects of both the Alpha Delta Kappa (an honorary organization of women educators) and the Retired Teachers Association, and is an ideal recipient of citizen of the year recognition, now therefore be it

House concurrent resolution honoring Brian Lowe for his volunteer ornithological protection activities

Offered by: Representatives French of Randolph and Townsend of Randolph

Whereas, kestrels are small hawks native to the state of Vermont whose population has been declining in recent years, possibly due to the disappearance of suitable nesting locations, and

Whereas, one Randolph Center resident, Brian Lowe, has taken on the challenge of attempting to preserve these birds, and

Whereas, he is extremely dedicated to this project, spending approximately six hours nearly every week on this endeavor, and personally assuming all costs associated with this unusual project, and

Whereas, for 15 years, he has been building breeding homes, which are large birdhouses, and then attaches them to a high location on trees and nonutility poles primarily on private property in the Randolph area for which he obtains the owner's permission, and

<u>Whereas</u>, once the breeding homes are built and constructed, Brian Lowe settles in for many hours of careful observation and recordation of the number of new birds born that season, and

Whereas, typically, these efforts of patience and love will yield 70 new birds each season, and

Whereas, the valuable data he meticulously collects are then transmitted via the Internet to the Cornell Laboratory of Ornithology and the Vermont department of fish and wildlife, and

Whereas, at the end of each nesting season, he cleans each breeding house which is an especially unpleasant task because kestrels do not clean their nesting areas as do other birds, and

Whereas, he also does similar work to protect bluebirds, and

Whereas, Brian Lowe gained valuable knowledge for his work with kestrels and bluebirds while volunteering for six years at the Vermont Institute of Natural Sciences, and

Whereas, the commitment Brian Lowe has given to his special work is even more amazing when considering his full-time job at Vermont Castings assembling stoves is mostly hard manual labor, and

<u>Whereas</u>, Brian Lowe has been nominated for the CVPS-Zetterstrom Environmental Award in recognition of his extraordinary volunteer ornithological role, now therefore be it

That the General Assembly honors Brian Lowe for his volunteer ornithological protection activities, and be it further

#### H.C.R. 361.

House concurrent resolution congratulating the Woodstock Union High School Wasps on winning their third consecutive Division II boys' Nordic skiing championship

Offered by: Representatives Clarkson of Woodstock, Bartholomew of Hartland and Zagar of Barnard

Offered by: Senators Campbell, McCormack and Nitka

Whereas, as the 2010 and 2011 boys' Nordic Division II skiing champions, the Woodstock Union High School Wasps were triple crown contenders, and

Whereas, at the opening individual freestyle race at the two-day state championship Nordic ski meet held in Jericho, the top three finishers in Division II all wore the Woodstock uniform, and

Whereas, when the clock ticked into the afternoon, the Wasps extended their morning lead, winning the relay race in the fastest time in either Division I or II, departing Jericho with a 24–57 lead over the second-place team, and

Whereas, when the competing teams reconvened at Grafton for the second day's focus on classic style skiing, the Wasps were again the winners, and

<u>Whereas</u>, in the individual race, Woodstock won in both divisions as Wasps skied across the finish line in first, second, third, and 15th places, and

Whereas, to conclude this two-day skiing extravaganza, the Wasps bested their 2011 second-place classic relay finish as they won the event with over a minute to spare, and

Whereas, Woodstock was the overwhelming overall winner, actually in either division, with 74 points compared to runner-up U-32 at 184, and

Whereas, the team's 2012 record shines even brighter as three freshmen qualified to represent Vermont at the New England J2 championships held in Rumford, Maine; three Wasps led Vermont to its second straight victory at the Eastern High School championships skied in Chittenden, and this same contingent of three, the only team members from a public high school, earned places on the New England Junior Nationals team, and Woodstock's superb coach, Nick Mahood, guided the New England team to its fourth consecutive Alaska Cup (as the top regional team in the country) at Junior Nationals competition in Utah; and based on the combined scores of the three Wasp participants, Woodstock was ranked as the seventh best high school Nordic team in the United States, and

Whereas, Woodstock Nordic boy skiers Jordan Fields, Josh Bassette, Jeff Tucker, Harry Linowski, Griffin Boswell, Zane Fields, Campbell Boswell, Graham Melville, Sam Linowski, Kent Dalton, and Luke Jacobs all skied to win, now therefore be it

House concurrent resolution honoring the educational and community leadership of Jerry Sullivan

Offered by: Representatives French of Randolph, Townsend of Randolph, Ancel of Calais, Buxton of Tunbridge, Davis of Washington, Donahue of Northfield, Grad of Moretown, Haas of Rochester, Jewett of Ripton and Winters of Williamstown

Whereas, Jerry Sullivan is a professional chef and educator whose credentials for teaching the culinary arts are impeccable, and

Whereas, a graduate of the prestigious Culinary Institute of America, he has been employed in the kitchens of Yale University, the Marriott Corporation, several private schools, and at Dartmouth-Hitchcock Medical Center where he worked as a chef, and

Whereas, through his initiative, the prepared food department at the Hanover Coop was established, and it has been extremely popular with customers and highly profitable for the coop, and

Whereas, a desire to teach the next generation of chefs prompted Jerry Sullivan to become a culinary arts instructor at the Randolph Technical Career Center (RTCC), and

Whereas, students at RTCC are trained to prepare food in a professional and attractive manner that is appealing to the dining public, and

Whereas, part of the training that Jerry Sullivan wishes to impart to his students is how to manage the serving of large group meals, and

<u>Whereas</u>, his membership on the board of the White River Craft Center (WRCC), which includes a meeting space rented to private groups, will provide his RTCC students the opportunity to meet this educational objective, and

Whereas, on joining the WRCC board, Jerry Sullivan immediately examined the cooking opportunities and discovered equipment for this purpose but not a formally organized kitchen capable of serving as the facility for preparing group meals, and

Whereas, he began a community campaign to build a functional commercial kitchen at the center which could serve as the hub for WRCC's hosting group events at which full-course meals are served, and

Whereas, the University of Vermont Extension has established Operation Military Kids (OMK), which seeks to fill in the real-life gaps that even the most well-intentioned law cannot, and

Whereas, the extension's 4-H state program director, Sarah Kleinman, OMK coordinator Stephanie Atwood, and a group of OMK youth are visiting the state house on April 24 to educate legislators about the challenges of being a military child and the beneficial role of the OMK program, and

Whereas, in the middle 1950s, Blanche Lamore turned her attention to the conduct of elections as she assumed the role of a ballot clerk, and

Whereas, in 1965, Blanche Lamore won election as a justice of the peace, and she has held this office for 47 years, making her at nearly 100 years old probably the oldest person in the state holding an elected office, and

Whereas, the citizens of Cabot appreciate the many decades of public service she has contributed to town government, and at town meeting in March, they honored her with a certificate of achievement from the secretary of state to commemorate her civic service, and

Whereas, in 2008, he completed the command and general staff course at Ft. Leavenworth, Kansas and was scheduled to be deployed to Iraq or Afghanistan, and

Whereas, he was the recipient of both the Army Commendation and Army Achievement medals, and

Whereas, aside from his military expertise, Major Jonathan Weaver was a talented vocalist, and

Whereas, as a gifted boy soprano growing up in New York, Jonathan Weaver sang leading roles in several operas, including *Amahl and the Night Visitors* at Avery Fischer Hall under the direction of composer Gian Carlo Menotti, and he also performed in the children's choruses of the Metropolitan Opera and the New York City Opera, and

Whereas, as an adult, Major Jonathan Weaver was an ardent church chorister, and wherever he was stationed, he found a church choir to sing in, including the Presbyterian Church in Leavenworth, Kansas, where he met his future wife, Meredith Cox, and

Whereas, although lupus strikes mostly women of childbearing age, no one is immune from lupus, and African Americans, Hispanics, Asians, and Native Americans are two to three times more likely to develop lupus, a disparity that remains unexplained, and

Whereas, lupus can be particularly difficult to diagnose because its symptoms are similar to those of many other illnesses, and major gaps exist in understanding the causes and consequences of lupus; more than one-half of all

people with lupus take four or more years and visit three or more doctors before obtaining a correct diagnosis, and

Whereas, the U.S. Food and Drug Administration has not approved a new drug for lupus in 50 years, and current treatments for the disease can have damaging side-effects, and

Whereas, roughly 3,090 Vermonters are affected by lupus, now therefore be it
