The following joint concurrent resolutions have been introduced for approval by the Senate and House and will be adopted by the Senate unless a Senator requests floor consideration before the end of the session of the next legislative day. #### **Senate Concurrent Resolutions**

#### S.C.R. 5.

By Senator Brock,

**S.C.R. 5.** Senate concurrent resolution designating March 31, 2011 as Congenital Diaphragmatic Hernia Awareness Day.

Whereas, a congenital diaphragmatic hernia birth defect occurs in one in 2,000 live births in the United States and accounts for eight percent of all major congenital anomalies in the country, and

Whereas, based on the National Center for Health Statistics' tally of 4,115,590 live births in 2004, the annual number of babies born with congenital diaphragmatic hernia birth defect is approximately 1,800, and

Whereas, the comparable number of annual numbers for two far better known diseases—cystic fibrosis and spina bifida—is one in 3,000 live births and seven in 10,000 live births respectively, and

Whereas, although not nearly as well known as these other physical maladies, congenital diaphragmatic hernia can be equally dangerous and potentially fatal, and

Whereas, congenital diaphragmatic hernia is a low-profile birth defect that has not received the attention and awareness it certainly merits, and

Whereas, families of children with congenital diaphragmatic hernia and adults with this birth defect are joining forces to have March 31 proclaimed in all 50 states as Congenital Diaphragmatic Hernia Awareness Day, and

Whereas, since March 31, 2008, Congenital Diaphragmatic Hernia Awareness Day has been proclaimed by 36 states and many cities and counties in the United States, and

Whereas, greater public knowledge in Vermont of a congenital diaphragmatic hernia birth defect will provide those with this malady with a special opportunity to educate Vermonters concerning their health difficulties, now therefore be it

That the General Assembly designates March 31, 2011 as Congenital Diaphragmatic Hernia Awareness Day, *and be it further*

**S.C.R. 6.** Senate concurrent resolution recognizing Gerald Myers for his outstanding accomplishments in the United States military and in local and state government.

Whereas, one of the city of Winooski's native sons, Gerald Myers has distinguished himself as an officer in the United States Air Force and as a municipal and state government administrator, and

Whereas, Gerald Myers earned an undergraduate degree at Norwich University and was later awarded a master's degree from Troy State University, and

Whereas, on being commissioned as an officer in the United States Air Force, Gerald Myers quickly proved himself to be a capable and energetic leader during his 22 years of military service, and

*Whereas*, Gerald Myers was chosen as one of the elite officers to attend the Air War & Air Command and Staff College, and

Whereas, upon his military discharge, Lieutenant Colonel Gerald Myers returned home to Winooski, and his hometown offered him a new challenge to serve as Winooski town manager, the city's professional staff director, and

Whereas, during his seven years at Winooski City Hall, he played a major role in the redevelopment of downtown Winooski as modern residential and office spaces were constructed, revitalizing the economic center of this industrial city, and

Whereas, his success in municipal government attracted the attention of Governor Douglas who in 2007 appointed Gerald Myers to serve as Commissioner of Buildings and General Services at an especially critical time when the severe problems at the Bennington state office complex were at the top of the department's agenda, and

Whereas, over the following three years, he dedicated extensive time and effort to the Bennington reconstruction project while simultaneously

overseeing all aspects of state building management and future facilities planning, and

Whereas, in every assignment he tackled, Gerald Myers was always a leader who inspired confidence and demonstrated commendable administrative skills, now therefore be it

**S.C.R.** 7 Senate concurrent resolution congratulating the Waitsfield-Fayston Volunteer Fire Department on its centennial anniversary.

*Whereas*, the town of Waitsfield was incorporated in 1782 and encompasses both lowlands in the Mad River Valley and adjacent mountainous terrain, and

Whereas, although fires periodically erupted in Waitsfield during the town's first 128 years, the responses to these flames were ad hoc as the community lacked a formally organized fire brigade, and

Whereas, as the 20th century began, many rural Vermont municipalities recognized that organizing a volunteer fire department to quell flames threatening village centers and agricultural buildings was a civic priority, and

Whereas, the citizenry in Waitsfield proved no exception to this evolving local commitment to fire protection, and

Whereas, in 1910, a group of concerned Waitsfield freemen met to establish the community's first volunteer firefighting company, and

Whereas, from this original company emerged a commitment to dousing flames and minimizing the impact of fire damage to life and property, and

Whereas, over the past century, this local firefighting service, located in the heart of the Mad River Valley and staffed with a well-trained supply of always-available volunteers, has evolved into the modern-day Waitsfield-Fayston Volunteer Fire Department that provides reliable and

timely fire protection to each of these towns, and, on a more limited basis, to other nearby communities through the mutual aid system, and

Whereas, on July 31, 2010, the Waitsfield-Fayston Volunteer Fire Department commemorated its centennial anniversary with celebratory activities held in the town of its birth, and

Whereas, the Waitsfield-Fayston Volunteer Fire Department, under the expert leadership of Chief Delbert Palmer, is a community resource that has enormously benefited the Mad River Valley and provided the public with the highest quality fire protection coverage, now therefore be it

**S.C.R. 8.** Senate concurrent resolution commemorating the 20th anniversary of the enactment of the federal Americans with Disabilities Act and the Vermont Center for Independent Living's celebration of this landmark legislation.

Whereas, Americans who, because of a mental or physical disability, require additional assistance to participate fully in societal activities, have long faced difficult challenges, and

*Whereas*, historically, in the United States, there were no legal requirements that public accommodations and services be made accessible to the disabled to the greatest extent possible, and

Whereas, government and commercial buildings and multifamily housing units that were not accessible to the physically disabled were common, and

Whereas, students in classrooms, litigants in courts, and other persons engaged in other government-funded activities were not entitled to support services such as sign language interpretation or documents in Braille, and

Whereas, Congress addressed this fundamental inequity when it enacted the Americans with Disabilities Act (ADA) that President George H.W. Bush signed into law on July 26, 1990, and which became Public Law 101-336, and

Whereas, this historic federal legislation prompted the states to enact their own complementary laws, and Vermont's ADA was enacted as Act 243 of 1992, and

Whereas, in commemoration of the 20th anniversary of enactment of the federal ADA, on Thursday, July 22, the Vermont Center for Independent Living in Montpelier held a special celebratory event under a big tent located on the State House lawn, and a community dance followed later that afternoon, and

Whereas, the enactment of the federal ADA marked an historic occasion in the long effort and struggle of disabled Americans to be treated as truly first-class citizens, now therefore be it

#### S.C.R. 9.

**S.C.R. 9.** Senate concurrent resolution congratulating Onion River Community Access Media on its silver anniversary.

Whereas, in the Cable Communications Act of 1984 (Pub. L. 98-549), Congress provided in section 2 that a cable television "franchising authority may establish requirements in a franchise with respect to designation or use of channel capacity for public, educational or governmental use" (known as PEG channels or services), and

*Whereas*, in 1985, Cox Cable, the owner of the cable television system serving Montpelier, began hosting a PEG production and transmission facility at its Berlin offices, and

Whereas, after Adelphia Cable assumed ownership of Montpelier's cable system, it continued managing the PEG services, but the trend was emerging nationwide for PEG production and transmission centers to be operated independently of a cable company, and

Whereas, in September 2003, Onion River Cable Access Media Inc. (ORCA Media) was established, and on February 3, 2004, this new organization was granted a contract to serve as the PEG operator in Montpelier, and

*Whereas*, just weeks later, on March 13, 2004, ORCA Media Inc. moved all aspects of the Berlin PEG operation to a more publicly accessible new home at City Center in downtown Montpelier, and

Whereas, in addition to the city of Montpelier, ORCA Media Inc. now serves as the PEG provider for cable viewers in Berlin, Bethel, Braintree, Calais, Duxbury, East Montpelier, Middlesex, Moretown, Randolph, Rochester, Waterbury, and Worcester, and

Whereas, ORCA Media Inc.'s three channels, 15, 16, and 17, provide multiple types of programs, including in-studio productions, live coverage of Montpelier City Council and other capital city governance panels, artistic, athletic, and governmental (including state legislative) programs, as well as externally created videos and program services, and

Whereas, through the Vermont Media Exchange, ORCA Media Inc. can transmit programs to other Vermont PEGS, and the Internet is becoming an increasingly important technical tool for receiving and transmitting programs to viewers, and

Whereas, the great work of Executive Director Kenric Kite, Technical Director Madhavan S. Nair, Office Manager Joanne Crowley-Watkins, and Outreach Coordinator Tim Tavcar, and the supportive guidance of board chair John Bloch and his colleagues, Mike Abadi, Senator Bill Doyle, Mike Doyle, Esther Farnsworth, and Frederick Weston, have enabled ORCA Media Inc. to become one of Vermont's premier PEG systems, and

Whereas, on Saturday, July 10, 2010, ORCA Media Inc celebrated its silver anniversary with festivities on the Vermont College of Fine Arts field, now therefore be it

# S.C.R. 10.

By Representatives Kitzmiller and Hooper of Montpelier,

**S.C.R. 10.** Senate concurrent resolution congratulating Capitol Stationers of Montpelier on its 60th anniversary.

Whereas, historically, Vermont's downtowns frequently featured a locally owned stationers, but in recent years, they have been permanently closing their doors, and

Whereas, given this commercial climate, it is wonderful to celebrate the 60th anniversary of Montpelier's Capitol Stationers, and

Whereas, Capitol Stationers' tale is that of the Bigglestone family's six decades of maintaining a highly respected and appreciated stationery store in the heart of downtown Montpelier, and

Whereas, Bill Bigglestone, known to one and all as Mr. B, had labored long hours as a traveling salesman who serviced stationery stores throughout New England, and

Whereas, in 1950, deciding to end his grueling travel schedule, Mr. B purchased the Richmond Office Equipment Company in Montpelier, which he initially renamed Capitol City Stationers and soon thereafter changed to Capitol Stationers as it has been known for nearly 60 years, and

Whereas, Mr. B and his wife, Nora, operated this highly respected retail establishment until their retirement in 1982, and

Whereas, originally headquartered on State Street, in 1962, the same year Mr. B's son, Don, became a full-time employee, Capitol Stationers moved to Main Street into a building next to the fire station, and later that same year, Mr. B expanded his business, opening a second location back on State Street that sold office furniture and equipment, and

Whereas, he subsequently opened a gift shop on State Street in 1964, and, in 1967, consolidated the three locations into a new home on Main Street next to City Hall, where the store remained until 1996 when the family moved it across Main Street to its current location, and

Whereas, responsibility for managing this still family-operated enterprise passed from Mr. B to his son, Don, in 1982, and more recently, the leadership of the store has been transferred to Mr. B's grandsons, Eric, who came on board in 1991, and Kent, whose tenure started in 1993, and

Whereas, through the years, the family owned stationery stores in Barre, Berlin, Burlington, St. Johnsbury, and in Ponte Verde, Florida, but after the 1992 Montpelier flood destroyed much of the inventory, the Bigglestones decided to consolidate their business into the downtown Montpelier store and a satellite location, "Mr. B's," at the Berlin Mall, and

Whereas, Capitol Stationers' 60th anniversary in June 2010 was celebrated in the Montpelier Historical Society's newsletter, and the store is now thriving as the place in town to purchase office supplies, maps, novelty gifts, and greeting cards, now therefore be it

Whereas, among the organizations that benefited from her expertise in health-related matters were the Lynn (Massachusetts) Community Center, the Vermont Department of Health, Planned Parenthood, the American Cancer Society, Kaiser Permanente, Pennsylvania State University, and the Massachusetts Department of Health, and

Whereas, during the past decade, Tracy Gallo assumed major program leadership and organizational responsibilities in Vermont state government, first at the Vermont Department of Education, and more recently, from April 2007 until July 2010, at the Department of Human Resources, and

Whereas, at the Department of Education, her duties extended beyond the traditional classroom environment as she directed a statewide HIV/AIDS education program designed to educate Vermonters in ways to prevent the spread of this serious form of infection, and

Whereas, after constructively contributing to the enhancement of HIV/AIDS education in the state, Tracy Gallo demonstrated her great versatility, assuming new responsibilities at the department, first overseeing career and technical education competency and development throughout the state, and then for three years directing the Division of Lifelong Learning which affects all educational sectors under the department's jurisdiction, and

Whereas, her outstanding work at the Department of Education attracted the attention of the Department of Human Resources which in 2007 hired her to serve as its Director of Workforce Development and Wellness, and

Whereas, under the broad rubric of Tracy Gallo's responsibilities in this key role was executive branch state employee training, including implementation of an online training program and coordination of the performance measurement program; creation of a succession planning project in anticipation of retiring baby boomer state employees; and drawing on her vast experience

in health education, developing a highly praised wellness agenda for state employees, featuring free flu vaccinations and incentives to increase physical fitness activities, and

Whereas, she brought enormous enthusiasm and creative and innovative ideas to her work at the Department of Human Services, continuously earning the respect and admiration of her colleagues until concluding her state service in July 2010, now therefore be it

## S.C.R. 12.

**S.C.R. 12.** Senate concurrent resolution congratulating the Central Vermont Tennis Association on its 40th anniversary.

Whereas, the promotion of amateur, and broadly inclusive, local tennis competition has been the primary goal of the Central Vermont Tennis Association (CVTA) since the organization was established in 1970, and

Whereas, the CVTA has, throughout its existence, sponsored a summer of community tennis competition that opens with a series of matches organized in the format of a ladder, and

Whereas, in late August, a committee reviews the ladder standings which serve as the basis for a tournament played from late August through Labor Day weekend and that was originally held at the Montpelier High School tennis courts, and

Whereas, the tournament features singles and doubles competition for junior players and these categories plus a mixed players category for adults, and

*Whereas*, by the middle 1970s, this annual summertime tennis competition had grown to include nearly 100 participants, each of whom was considered a CVTA member, and

Whereas, for several years, the CVTA also hosted the Cho Lee Tournament in Barre as part of that community's Heritage Days in honor of a respected Barre tennis player and court caretaker, and

Whereas, the Barre tournament, and much of the administrative work associated with the CVTA in the 1970s and 1980s, was conducted under the expert auspices of Maria Broggini, the CVTA's first treasurer and a perennial champion in multiple events at the Montpelier tournament, and

Whereas, Maria Broggini's solo efforts kept the tournament alive during its lower participation years during the 1980s, and by the end of that decade, Dana McCarthy had added her invaluable administrative support, and

Whereas, in memory of Maria Broggini, who died from colon cancer in 1999, the CVTA named the Montpelier tournament for her, and the association annually contributes a donation to the People's Health and Wellness Clinic in Barre with the request that the funds help finance colon cancer screenings, and

Whereas, the CVTA has decided not to associate with the United States Tennis Association in order to retain the community-based ambiance of the Montpelier tournament, and

Whereas, 2010 marks the 40th anniversary of the CVTA, and the recently completed refurbishment of the Montpelier High School tennis courts will enable some of the matches to be played at that location, as well as the Montpelier Recreation Field and U-32 High School in East Montpelier, and

Whereas, in commemoration of this special anniversary in the history of this outstanding athletic organization, the CVTA celebrated in grand style on Saturday, September 18, 2010, with a festive event at the Montpelier Recreation Field that included participants from the 1970 tournament, several generations of players using wooden rackets and old style draw sheets, and a display of newspaper articles from throughout the four decades, now therefore be it

## H.C.R. 46.

House concurrent resolution honoring Shaftsbury town clerk Judith Stratton and resident Florence Beebe for their comprehensive cataloguing and historical annotating of veterans' grave sites in Shaftsbury

Whereas, the men and women who serve in our nation's armed forces frequently make life-altering sacrifices that can result in permanent injuries and sadly, on occasion, even death, and

Whereas, all of Vermont's military veterans deserve lasting recognition when they are laid to their eternal rest, and

Whereas, as a final homage to their military service, some Vermont veterans are buried in a designated veterans cemetery, but many others, including those interred in the cemeteries located in the town of Shaftsbury, are not, and

Whereas, Shaftsbury town clerk Judith Stratton and local resident Florence Beebee embarked on an ultimately five-year-long volunteer project to catalogue each veteran's grave located in the community's cemeteries, and

Whereas, the project, initially intended to identify all grave sites' occupants in Shaftsbury, assumed a special and intensive focus on veterans buried in the cemeteries' plots after the tally of veterans proved more numerous than anticipated, and

Whereas, the women created an on-site recognition of each interred veteran with the placement of a flag by the grave, and

Whereas, through diligent research, in an endeavor they described as a labor of love, they sought genealogical and military service information on each veteran, and the lives of these deceased military personnel became more vivid and directly connected to the town of Shaftsbury, and

Whereas, in addition to new records surveying all of the cemetery plots in Shaftsbury, three files now exist, documenting Shaftsbury's interred veterans: one comprehensive in scope that includes a picture of each veteran's grave site, and two war-specific files, one for the Revolutionary War and one for the Civil War, and

Whereas, all of this information, both narrative and pictorial, is on permanent deposit in the office of the Shaftsbury town clerk and serves as a major historical resource for the town, now therefore be it

Whereas, for 40 years, Leo Nadeau has served as an outstanding police officer in the town of Essex, and

<u>Whereas</u>, he was educated at the Community College of Vermont, Champlain College, and the University of Vermont, and

Whereas, from 1965 to 1967, Leo Nadeau served his country in Vietnam as a member of the United States Army, and

Whereas, his illustrious law enforcement career began in 1970 when he joined the village of Essex Junction police department as a patrol officer, and when the Essex Junction police department was merged into the Essex town force in the early 1980s, by then Sergeant Leo Nadeau remained on the force, and

Whereas, in 1985, Leo Nadeau was raised to the rank of lieutenant, and in 1998, he was designated as a captain, and

Whereas, during the years 1998–1999, he was elevated to executive leadership on an interim basis, being named acting police chief, and

Whereas, in 2005, Leo Nadeau was designated the deputy chief of the Essex police department with responsibility for both the patrol and detective divisions, and

Whereas, once again in 2007, he was named as the acting chief and later that year was selected as chief on a permanent basis, and

Whereas, Leo Nadeau has been a leader in the local and Vermont law enforcement communities, having served as president of the Vermont Police Association, chair of the Vermont Special Olympics Law Enforcement Torch Run, vice chair of the town of Essex office of emergency management, and chair of the Essex school public safety committee, and

Whereas, Leo Nadeau is the recipient of many honors, including the Essex Grange Community Citizen Award and the Doug Holland Community Service Award from Essex CHIPS, and Essex Rotary has named him a prestigious Paul Harris Fellow, now therefore be it

Whereas, in 1980, Charles (Charlie) Gingo, his wife, Chris, and their children moved to Bennington in order that he could begin a new role as the Bennington County district director of the department of social and rehabilitation services, and

Whereas, Charlie Gingo was always extremely supportive of his staff, crafted creative drawings which brought a personal touch to his work-family, and was truly a model supervisor, and

<u>Whereas</u>, he was a leader in the delivery of social services, always pulling together needed governmental resources around issues and the clients his department serves, and

Whereas, Charlie Gingo gained great respect for his handling of sensitive and difficult challenges, sometimes referred to as red rockets, and he is known for always having defused the most difficult of situations, and

Whereas, in May 2001, because of Charlie Gingo's insightful leadership, his district departmental office was presented the Governor's Award for Excellence in Juvenile Services, and

Whereas, over the years, he has been a respected mentor, a leader in restructuring, transformation, or any other reorganization, and when the agency of human services was structurally changed in 2004, Charlie Gingo became the agency of human services' field director in Bennington, and

Whereas, his staff has referred to him as an advocate, a good listener, a doer, a displayer of common sense, caring, well-respected, and an individual who truly made a difference in the lives of children and families, and Bennington County has been extremely fortunate to have benefited from his leadership, and

Whereas, on December 31, 2010, Charlie Gingo concluded 30 years of public service dedicated to helping those with fundamental societal support needs, and
