Dear Don:

I am writing to submit my resignation from the House of Representatives, effective January 7th, 2011, in order to serve within the administration of Governor Peter Shumlin.

It has been a tremendous honor to serve in the Vermont House for the past six years, as the representative of Waterbury, Duxbury, Huntington and Buels Gore. The decision to resign is not an easy one, and I write this letter with mixed emotions – sad to be leaving the "People's House", yet excited to be participating in government in a new way.

I have learned so much during my tenure in this body -- about issues, budgets, process, protocol and teamwork. I am grateful to everyone here for being my teachers. My experience serving in the General Assembly has made me proud of Vermont's democracy. Our small state sets an example for others, particularly in this time of partisan divisions across the country.

Vermont has an accessible government, where its citizens care passionately and become engaged within the debates of the day. While never perfect, Vermont's legislative process enables civil and inclusive debate, with multiple voices at the table, and a committee process that strives toward consensus. Significantly, while members advocate for their viewpoints, when the debate is over, they can also treat one another as friends. An overriding spirit of working together, in spite of the deep differences between and among us, is, I believe, what helps our small state succeed, and lead.

This is a pivotal time in our nation and across the globe. It is a time when cooperation and understanding is critical to our common future. It requires strong leadership, members with an open mind, and a respected process for debate and decision-making. My hope is that our House can continue to be accessible, and become more transparent, as we confront the deepening challenges of the future.

I want to thank you, Don, and your entire staff for the dedication, integrity and professionalism you exhibit in carrying out your duties to the members and the body as a whole.

I submit this letter with a lingering sadness, but I know my seat will be filled with promise. I am ever grateful for the experience I have had in this House -- the tremendous people I have met, the education I've had, and the great debates I have participated in. I will forever treasure the family I have found here.
