House Bill Introduced

H. 429

Rep. Condon of Colchester introduced a bill, entitled

An act relating to capital gain exclusion for sale of a business to employees

Which was read the first time and referred to the committee on Ways and Means.

Committee Bill Introduced

H. 430

Rep. Donovan of Burlington, for the committee on Education, introduced a bill, entitled

An act relating to providing mentoring support for new principals and technical center directors

Which was read the first time and, under the rule, placed on the Calendar for notice tomorrow.

Senate Bill Referred

S. 48

Senate bill, entitled

An act relating to prohibiting a sex offender from using a false name when creating a social networking website profile;

Was taken up, read the first time and referred to the committee on Judiciary.

Joint Resolution Adopted in Concurrence

J.R.S. 21

By Senators Carris and Mullin,

J.R.S. 21. Joint resolution relating to weekend adjournment.

Resolved by the Senate and House of Representatives:

That when the two Houses adjourn on Friday, March 11, 2011, it be to meet again no later than Tuesday, March 15, 2011.

Was taken up read and adopted in concurrence.

Bill Recommended**H. 120**

House bill, entitled

An act relating to commemorative Boy Scout motor vehicle plates

Appearing on the Calendar for action, was taken up and pending third reading of the bill,. **Rep. Bissonnette of Winooski** moved to recommit the bill to Transportation, which was agreed to.

Third Reading; Bills Passed

House bills of the following titles were severally taken up, read the third time and passed:

H. 13

House bill, entitled

An act relating to deer doing damage to forest resources;

H. 143

House bill, entitled

An act relating to the taxation of certain Internet sales;

Bill Read Second Time; Third Reading Ordered**H. 426**

Rep. Donahue of Northfield spoke for the committee on Human Services.

House bill entitled

An act relating to extending the state's reporting concerning transportation of children in state custody and transportation of individuals in the custody of the commissioner of mental health

Having appeared on the Calendar one day for notice, was taken up, read the second time and third reading ordered.

Bill Amended; Third Reading Ordered**H. 79**

Rep. Waite-Simpson of Essex, for the committee on Judiciary, to which had been referred House bill, entitled

An act relating to uniform adult guardianship and protective proceedings jurisdiction

Reported in favor of its passage when amended as follows:

First: In Sec. 1, 14 V.S.A. § 3155(a)(7), after the word “amended” by inserting the following: “, but any information so disclosed may be admitted in a proceeding in this state only in accordance with the laws of this state”

Second: In Sec. 1, 14 V.S.A. § 3155(b), after the word “request” by inserting the following: “in accordance with the laws of this state”

Third: In Sec. 1, 14 V.S.A. § 3161(a), by striking subdivision (1) in its entirety and inserting in lieu thereof a new subdivision (1) to read:

(a)(1) “Emergency” means a circumstance that likely will result in serious and irreparable harm to a respondent’s physical health, safety, or welfare, and for which the appointment of a guardian is necessary because no other person has authority and is willing to act on the respondent’s behalf.

The bill, having appeared on the Calendar one day for notice, was taken up, read the second time, report of the committee on Judiciary agreed to and third reading ordered.

Bill Recommitted**S. 2**

Senate bill, entitled

An act relating to sexual exploitation of a minor and the sex offender registry

Appearing on the Calendar for action, was taken up and pending reading of the report of the committee on Judiciary, **Rep. Lippert of Hinesburg** moved to recommit the bill to the committee on Judiciary, which was agreed to.
