Statement of purpose of bill as introduced: This bill proposes to revise the

statutes on the designation of new town centers and growth centers.

An act relating to designation of new town centers and growth centers

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 24 V.S.A. § 2791 is amended to read:

§ 2791. DEFINITIONS

As used in this chapter:

* * *

(11) “New town center” means the area planned for or developing as a
community’s central business district, composed of compact,
pedestrian-friendly, multistory, and mixed use development that is
characteristic of a traditional downtown, supported by planned or existing

1 urban infrastructure, including curbed streets with sidewalks and on-street
2 parking, stormwater treatment, sanitary sewers and public water supply.

3 (12)(A) ~~“Growth center” means an area of land that contains the~~
4 ~~characteristics specified in subdivision (B) of this subdivision (12) and that is~~
5 ~~located in one or a combination of the following:~~

6 (i) ~~A designated downtown, village center, or new town center;~~

7 (ii) ~~An area of land that is in or adjacent to a designated~~
8 ~~downtown, village center, or new town center, with clearly defined boundaries~~
9 ~~that have been approved by one or more municipalities in their municipal plans~~
10 ~~to accommodate a majority of growth anticipated by the municipality or~~
11 ~~municipalities over a 20 year period. Adjacent areas shall include those lands~~
12 ~~which are contiguous to the designated downtown, village center, or new town~~
13 ~~center. In situations where contiguity is precluded by natural or physical~~
14 ~~constraints to growth center development, adjacent areas may include lands~~
15 ~~lying close to and not widely separated from the majority of the lands within~~
16 ~~the designated growth center. Noncontiguous land included as part of a growth~~
17 ~~center must exhibit strong land use, economic, infrastructure, and~~
18 ~~transportation relationships to the designated downtown, village center, or new~~
19 ~~town center; be planned to function as a single, integrated growth center; and~~
20 ~~be essential to accommodate a majority of growth anticipated by the~~
21 ~~municipality or municipalities over a 20 year period.~~

1 ~~(B) A growth center contains the following characteristics:~~

2 ~~(i) It incorporates a mix of uses that typically include or have the~~
3 ~~potential to include the following: retail, office, services, and other~~
4 ~~commercial, civic, recreational, industrial, and residential uses, including~~
5 ~~affordable housing and new residential neighborhoods, within a densely~~
6 ~~developed, compact area;~~

7 ~~(ii) It incorporates existing or planned public spaces that promote~~
8 ~~social interaction, such as public parks, civic buildings (e.g., post office,~~
9 ~~municipal offices), community gardens, and other formal and informal places~~
10 ~~to gather.~~

11 ~~(iii) It is organized around one or more central places or focal~~
12 ~~points, such as prominent buildings of civic, cultural, or spiritual significance~~
13 ~~or a village green, common, or square.~~

14 ~~(iv) It promotes densities of land development that are~~
15 ~~significantly greater than existing and allowable densities in parts of the~~
16 ~~municipality that are outside a designated downtown, village center, growth~~
17 ~~center, or new town center, or, in the case of municipalities characterized~~
18 ~~predominately by areas of existing dense urban settlement, it encourages in fill~~
19 ~~development and redevelopment of historically developed land.~~

20 ~~(v) It is supported by existing or planned investments in~~
21 ~~infrastructure and encompasses a circulation system that is conducive to~~

1 ~~pedestrian and other nonvehicular traffic and that incorporates, accommodates,~~
2 ~~and supports the use of public transit systems.~~

3 ~~(vi) It results in compact concentrated areas of land development~~
4 ~~that are served by existing or planned infrastructure and are separated by rural~~
5 ~~countryside or working landscape.~~

6 ~~(vii) It is planned in accordance with the planning and~~
7 ~~development goals under section 4302 of this title, and to conform to smart~~
8 ~~growth principles.~~

9 ~~(viii) It is planned to reinforce the purposes of 10 V.S.A. chapter~~
10 ~~154 “Growth center” shall have the same meaning as under section 2793c of~~
11 ~~this title.~~

12 (13) “Smart growth principles” means growth that:

13 (A) Maintains the historic development pattern of compact village
14 and urban centers separated by rural countryside.

15 (B) Develops compact mixed-use centers at a scale appropriate for
16 the community and the region.

17 (C) Enables choice in modes of transportation.

18 (D) Protects the State’s important environmental, natural, and historic
19 features, including natural areas, water quality, scenic resources, and historic
20 sites and districts.

1 (E) Serves to strengthen agricultural and forest industries and
2 minimizes conflicts of development with these industries.

3 (F) Balances growth with the availability of economic and efficient
4 public utilities and services.

5 (G) Supports a diversity of viable businesses in downtowns and
6 villages.

7 (H) Provides for housing that meets the needs of a diversity of social
8 and income groups in each community.

9 (I) Reflects a settlement pattern that, at full build-out, is not
10 characterized by:

11 (i) scattered development located outside of compact urban and
12 village centers that is excessively land consumptive;

13 (ii) development that limits transportation options, especially for
14 pedestrians;

15 (iii) the fragmentation of ~~farm-~~ farmland and ~~forest land~~
16 forestland;

17 (iv) development that is not serviced by municipal infrastructure
18 or that requires the extension of municipal infrastructure across undeveloped
19 lands in a manner that would extend service to lands located outside compact
20 village and urban centers;

1 (v) linear development along well-traveled roads and highways
2 that lacks depth, as measured from the highway.

3 (14) "Important natural resources" means headwaters, streams,
4 shorelines, floodways, rare and irreplaceable natural areas, necessary wildlife
5 habitat, wetlands, endangered species, productive ~~forest lands~~ forestlands, and
6 primary agricultural soils, all of which are as defined in 10 V.S.A. chapter 151.

9 § 2793b. DESIGNATION OF NEW TOWN CENTER DEVELOPMENT

10 DISTRICTS

11 (a) A municipality, by its legislative body, may apply to the State Board for
12 designation of an area within that municipality as a new town center
13 development district, provided no traditional downtown or new town center
14 already exists in that municipality. ~~An application by a municipality shall~~
15 ~~contain a map delineating the district, evidence that the regional planning~~
16 ~~commission and the regional development corporation have been notified of~~
17 ~~the municipality's intent to apply, and information showing the district meets~~
18 ~~the standards for designation established in subsection (b) of this section.~~

19 (1) The State Board shall not approve an application filed by a
20 municipality on or after July 1, 2014 unless the municipality has stated in its
21 town plan that it intends to apply for designation under this section, and the

1 town plan explains how the designation would further the plan's goals and the
2 goals of section 4302 of this title.

3 (2) A preapplication meeting shall be held with Department staff before
4 an application is filed to review the program requirements and to identify
5 possible designation boundaries. The meeting shall be held in the municipality
6 unless another location is agreed to by the municipality.

7 (3) An application for designation shall contain a map that delineates the
8 boundaries of the proposed district and is consistent with the guidelines
9 produced by the Department under subsection 2792(d) of this title. The
10 application shall also demonstrate that the proposed district meets the
11 requirements set forth in subdivision 2791(11) of this title, as well as the
12 standards for designation established in subsection (b) of this section. The
13 application shall verify that the regional planning commission and the regional
14 development corporation have been notified of the municipality's intent to
15 apply for designation.

16 (b) Within 45 days of receipt of a completed application, the State Board
17 shall designate a new town center development district if the State Board finds,
18 with respect to that district, the municipality has:

19 (1) ~~a~~ A confirmed planning process under section 4350 of this title, ~~and~~
20 developed a municipal center plan, and adopted regulations to implement the

1 plan, including an official map, and a design review district created under this
2 title; and all other applicable regulations.

3 (2) ~~provided~~ Provided a community investment agreement that has been
4 executed by authorized representatives of the municipal government,
5 businesses, and property owners within the district, and community groups
6 with an articulated purpose of supporting downtown interests, and contains the
7 following:

8 (A) A map of the designated new town center. The total area of land
9 encompassed within a designated new town center shall not exceed 125 acres.
10 In a municipality with a population greater than 15,000, the total area of land
11 encompassed within a designated new town center may include land in excess
12 of 125 acres provided that the additional area is needed to facilitate the
13 redevelopment of predominately developed land in accordance with the smart
14 growth principles defined under subdivision 2791(13) of this title and shall not
15 exceed 175 acres.

16 (B) Regulations enabling high densities that are greater than those
17 allowed in any other part of the municipality.

18 (C) Regulations enabling multistory and mixed use buildings and
19 mixed uses which enable the development of buildings in a compact manner.

20 (D) A capital improvement program, or a capital budget and program
21 under this title, showing a clear plan for providing public infrastructure within

1 the center, including facilities for drinking water, wastewater, stormwater,
2 public space, lighting, and transportation, including public transit, parking, and
3 pedestrian amenities.

4 (E) A clear plan for mixed income housing in the new town center.

5 (F) Evidence that civic and public buildings do exist, or will exist in
6 the center, as shown by the capital improvement plan or the capital budget and
7 program, and the official map.

8 (G) ~~[Deleted.]~~ [Repealed.]

9 (H) Evidence that any private or municipal sewage system and
10 private or public water supply serving the proposed new town center are in
11 compliance with the requirements of 10 V.S.A. chapters 47 and 56, and that
12 the municipality has dedicated a portion of any unallocated reserve capacity of
13 the sewage and public water supply necessary to support growth within the
14 proposed new town center. Any municipality proposing a municipal sewage
15 system and public water supply to serve the proposed new town center shall
16 provide evidence to the ~~state board~~ State Board of a commitment to construct
17 or maintain such a system and supply in compliance with requirements of
18 10 V.S.A. chapters 47 and 56, or a commitment to construct, as applicable, a
19 permissible potable water supply, wastewater system, indirect discharge, or
20 public water supply within no more than ten years. A commitment to construct
21 does not relieve the property owners in the new town center from meeting the

1 applicable regulations of the Agency of Natural Resources regarding
2 wastewater systems, potable water supplies, public water supplies, indirect
3 discharges, and the subdivision of land. In the event a municipality fails in its
4 commitment to construct a municipal sewage system or public water supply, or
5 both, the State Board shall revoke designation, unless the municipality
6 demonstrates to the State Board that all good faith efforts were made and
7 continue to be made to obtain the required approvals and permits from the
8 Agency of Natural Resources, and failure to construct was due to
9 unavailability of sufficient State or federal funding.

10 (c)(1) Upon designation by the State Board under this section as a new
11 town center, a new town center and projects in a new town center shall be
12 eligible for the authority to create a special taxing district, pursuant to chapter
13 87 of this title, for the purpose of financing both capital and operating costs of
14 a project within the boundaries established through new town center
15 designation.

16 (2) Whenever the Commissioner of Buildings and General Services or
17 other State officials in charge of selecting a site are planning to lease or
18 construct buildings suitable to being located in a new town center after
19 determining that the option of utilizing existing space in a downtown
20 development district, pursuant to subdivision 2794(a)(14) of this title, is not
21 feasible, the option of utilizing existing space in a designated new town center

1 shall be given thorough investigation and priority, in consultation with the
2 community.

3 (d) The ~~state board~~ State Board shall review a new town center designation
4 every five years and may review compliance with the designation requirements
5 at more frequent intervals. The State Board may adjust the schedule of review
6 under this subsection to coincide with the review of a related growth center. If
7 at any time the State Board determines the new town center no longer meets
8 the standards for designation established in subsection (b) of this section, it
9 may take any of the following actions:

10 (1) ~~Require~~ require corrective action;₂

11 (2) ~~Provide~~ provide technical assistance through the Vermont
12 Downtown Program;₂

13 (3) ~~Limit~~ limit eligibility for the benefits pursuant to subsection (c) of
14 this section without affecting any of the new town center's previously awarded
15 benefits;₂ or

16 (4) ~~Remove~~ remove the new town center's designation without affecting
17 any of the town center's previously awarded benefits.

19 § 2793c. DESIGNATION OF GROWTH CENTERS

20 (a)(1) Definition. As used in this section, "growth center" means an area of
21 land that:

1 (A) is within or adjoining a downtown, village center, or new town
2 center designated under this chapter; and

3 (B) has clearly defined boundaries that can accommodate a majority
4 of commercial, residential, and industrial growth anticipated by the
5 municipality or municipalities over a 20-year period.

6 (2) Development and redevelopment within any growth center shall
7 support Vermont's traditional land use pattern of compact centers separated by
8 rural lands and shall meet the requirements set forth in subsection (b) of this
9 section.

10 (b) Requirements. To achieve the purposes and goals set forth in section
11 4302 of this title and conform to smart growth principles, a growth center shall
12 meet each of the following requirements:

13 (1) Size. The size of the growth center shall be sufficient to
14 accommodate a majority of the projected development within each applicant
15 municipality over a 20-year planning period, and:

16 (A) shall be no larger than the area necessary to accommodate:

17 (i) 150 percent of the projected dwelling units in the municipality
18 over the period; and

19 (ii) no more than 100 percent of the projected commercial and
20 industrial development in the municipality;

1 (B) shall not encompass an excessive area of land that would involve
2 the unnecessary extension of infrastructure to service low-density development
3 or automobile-dependent strip development; and

4 (C) may include undevelopable land and land planned for green
5 space or open space, as well as areas designed for infill and redevelopment.

6 (2) Location. The area of land proposed for the growth center shall be
7 located within or shall adjoin, a designated downtown, village center, or new
8 town center. If the growth center is to be adjoining, then the applicant shall
9 demonstrate that an existing designated downtown, village center, or new town
10 center located within each applicant municipality reasonably cannot
11 accommodate the growth proposed to occur in the growth center.

12 (3) Uses. The growth center shall support and reinforce any existing
13 designated downtown, village center, or new town center located in the
14 municipality or adjacent municipality by accommodating concentrated
15 residential neighborhoods and a mix and scale of commercial, civic, and
16 industrial uses that are consistent with the anticipated demand for those uses
17 within the municipality and region. The growth center shall incorporate a mix
18 of uses that typically includes or is planned to include the following: retail,
19 office, services, and other commercial, civic, recreational, industrial, and
20 residential uses, including affordable housing and new residential
21 neighborhoods, within a densely developed, compact area.

1 (4) Density. The land use bylaws of the municipality shall allow net
2 residential densities within the growth center greater than or equal to four
3 single-family detached dwelling units per acre, exclusive of accessory dwelling
4 units, or no fewer than the average existing density of the surrounding
5 neighborhood, whichever is greater. A municipality may use bylaws that
6 regulate adequately the physical form and scale of development to demonstrate
7 compliance with this requirement.

8 (5) Design and form. The municipality shall adopt land use bylaws,
9 regulations, and policies applicable to the growth center that conform with
10 design guidelines developed by the Department pursuant to subdivision
11 2793c(d)(3) of this title, and that:

12 (A) ensure that all investments contribute to a built environment that
13 enhances the existing and planned character and supports pedestrian use;

14 (B) ensure sufficient floor area ratio, density, building heights, and
15 building coverage;

16 (C) minimize the required lot sizes, setbacks, and parking and street
17 widths;

18 (D) require conformance with “complete streets” principles as
19 described under 19 V.S.A. § 309d, and street and pedestrian connectivity
20 throughout the growth center;

1 (E) organize the proposed growth center development around one or
2 more central places or focal points that will establish community identity and
3 promote social interaction, such as prominent buildings of civic, cultural, or
4 spiritual significance or a village green, common, or square; and

5 (F) prohibit linear, automobile-dependent strip development along
6 heavily traveled roads within and extending outside the growth center.

7 (6) Capital budget. The applicant has adopted, in accordance with
8 section 4430 of this title, a capital budget and program that includes existing
9 and planned wastewater treatment, water, stormwater, and transportation
10 infrastructure; public spaces; other infrastructure necessary to support growth
11 center development; and a reference map.

12 (7) General infrastructure. The existing and planned infrastructure shall
13 be adequate to implement the growth center and meet the municipality's
14 20-year growth needs. The municipality shall have adopted policies on the
15 extension of water and wastewater lines that include a defined service area and
16 allocation plan to support the growth center.

17 (8) Public spaces. The growth center shall incorporate existing or
18 planned public spaces that promote social interaction, such as public parks,
19 civic buildings such as a post office or municipal offices, community gardens,
20 and other formal and informal places to gather.

1 (9) Transportation. Existing or planned transportation infrastructure
2 servicing the growth center shall be adequate to implement growth center
3 development over the 20-year period, and shall conform with “complete
4 streets” principles as described under 19 V.S.A. § 309d; shall establish
5 multi-modal access to the downtown, village center, or new town center;
6 incorporate, accommodate, and support the use of public transit systems; and
7 shall encompass a circulation system that is conducive to pedestrian and other
8 nonvehicular traffic. The applicable municipal plans and bylaws shall include
9 provisions that will result in street connectivity and aim to create a
10 comprehensive, integrated, connected network for all modes.

11 (10) Natural resources within growth centers. The growth center shall
12 avoid or minimize the inclusion of important natural resources and identified
13 flood and fluvial erosion hazard areas. If an applicant includes an important
14 natural resource or flood or fluvial erosion hazard area within a proposed
15 growth center, the applicant shall identify the resource or area, explain why the
16 resource or area was included, describe any anticipated disturbance to the
17 resource or area, and describe how the municipality’s land use bylaws will
18 avoid or minimize impacts to the resource or area. If impacts to the resource
19 or area are necessary to achieve all other growth center goals, the applicant
20 shall provide justification for why the disturbance cannot be avoided or
21 minimized.

1 (11) Natural resources outside growth centers. The applicant shall plan
2 the growth center to minimize conflicts of development with agricultural and
3 forest industries and to minimize the conversion and fragmentation of
4 farmland, forestland, or significant areas of habitat connectivity. The approved
5 local plan and implementing bylaws shall provide reasonable protection for
6 important natural resources and historic resources located outside the proposed
7 growth center. A municipality may use regulatory tools such as those
8 described in section 4410 of this title to demonstrate reasonable protection of
9 these resources.

10 (12) Historic resources. The growth center shall be compatible with and
11 reinforce the character of sites that are listed or eligible for listing on the
12 National or State Register of Historic Places, and other significant cultural and
13 historic resources identified by local or State government in or adjacent to the
14 growth center.

15 (c) Application for designation of a growth center.

16 (1) The decision to apply for growth center designation shall be made by
17 a vote of the municipal legislative body, according to the procedure established
18 under sections 1972 and 1973 of this title.

19 (2) The application for designation as a growth center shall:

20 (A) be based on a 20-year plan for growth that is reflected in the
21 municipal plan of the municipality involved;

1 (B) include regional and local growth projections and shall identify
2 targets for 20-year growth in various sectors;

3 (C) include an inventory map and analysis of growth and
4 development potential in the designated downtown, village center, or new
5 town center that connects to the proposed growth center; and

6 (D) shall quantify the type and amount of development and land area
7 needed to support the proposed growth center beyond what is available in the
8 designated downtown, village center, or new town center.

9 (3) Each municipality involved in the application shall have a duly
10 adopted and regionally approved municipal plan that describes the proposed
11 growth center and a planning process that is confirmed in accordance with
12 section 4350 of this title.

13 (4) Each municipality involved in the application shall have adopted
14 bylaws and regulations under sections 4414, 4418, and 4422 of this title and
15 nonregulatory programs that will support and implement the growth center
16 requirements of subsection (b) of this section.

17 (5) Each application for designation as a growth center shall include:

18 (A) a description from each relevant regional planning commission
19 of the role of the proposed growth center in the region, and the relationship
20 between the proposed growth center and neighboring communities;

1 (B) written confirmation from each relevant regional planning
2 commission that the proposed growth conforms with the regional plan;

3 (C) a concept plan depicting the character of the streets and public
4 spaces within the growth center, and depicting the size and placement of
5 buildings envisioned in the municipal plan; and

6 (D) one or more maps that accurately delineate the boundaries of the
7 growth center, and an official map of the growth center. The map or maps
8 shall identify:

9 (i) growth center boundaries in relation to the associated
10 designated downtown, village center, or new town center;

11 (ii) important natural resources, identified flood hazard and fluvial
12 erosion hazard areas, National Register Historic Districts, National or State
13 Register Historic Sites, and other significant cultural and natural resources
14 identified by local or State government within the municipality;

15 (iii) existing slopes of 25 percent or greater; and

16 (iv) existing and planned public facilities, including public
17 buildings, public spaces, wastewater and water services, roads, sidewalks,
18 paths, transit centers, parking areas, parks, and schools within the growth
19 center boundaries.

20 (d) Designation process.

21 (1) Preliminary application and meeting process.

1 (A) Before submitting an application pursuant to subsection (c) of
2 this section, a municipality shall submit a preliminary application to the
3 Department, consisting of a draft growth center map, and a brief explanation of
4 the planning and implementation policies the municipality plans to enact prior
5 to submitting an application under subdivision (B) of this subdivision (1).
6 These planning and implementation policies will be used to guide
7 development within the growth center and preserve the rural character of
8 the surrounding area.

9 (B) The Department shall solicit comments on the preliminary
10 application from State agencies and regional planning commissions. The
11 Department shall evaluate the preliminary application for compliance with the
12 requirements of subsection (b) of this section, identify potential issues related
13 to the growth center boundary and implementation tools, and make
14 recommendations to address those issues through adjustment of the growth
15 center boundaries and revised or alternative implementation plans.

16 (C) The Department shall schedule and conduct a preapplication
17 meeting with the applicant.

18 (2) Regional planning commission technical planning assistance.
19 Regional planning commissions, pursuant to section 4345a of this title, are
20 uniquely positioned to assist municipalities with growth center planning. To
21 this end, at the request of a municipality contemplating growth center

1 designation, the regional planning commission shall provide technical
2 assistance in support of that designation.

3 ~~(1)(A)~~ Technical support shall include:

4 ~~(A)(i)~~ preparing population, housing, and employment growth
5 projections for a period of not less than 20 years;

6 ~~(B)(ii)~~ GIS mapping, including identification of development
7 capacity, land use, existing and planned infrastructure and service areas,
8 important natural resources and historic resources, and physical constraints to
9 development and associated features; and

10 ~~(C)(iii)~~ build-out analyses for potential growth centers to document
11 analysis of whether the geographic area of proposed growth centers will
12 accommodate a majority of the projected growth over a 20-year period in a
13 manner that is consistent with the definition under subdivision 2791(12) of
14 this title.

15 ~~(2)(B)~~ These projections and ~~build-out~~ analyses may be prepared on a
16 municipal or regional basis.

17 ~~(b) Growth center designation application assistance.~~

18 ~~(1) A subcommittee of the State Board, to be known as the Growth~~
19 ~~Center Subcommittee, shall develop and maintain a coordinated preapplication~~
20 ~~review process in accordance with this subdivision (1). The members of the~~
21 ~~Growth Center Subcommittee shall be the members of the State Board~~

1 ~~described under subdivisions 2792(a)(1), (6), (7), (9), and (10) of this title and~~
2 ~~the member designated by the Vermont League of Cities and Towns under~~
3 ~~subdivision 2792(a)(8) of this title. The Growth Center Subcommittee shall~~

8 downtowns and village centers whenever feasible. The provisions in this
9 section and elsewhere in law that provide and establish priorities for State
10 assistance and funding for designated growth centers are not intended to take

6 center in accordance with the Agency's rules regarding priority for pollution
7 abatement, pollution prevention, and the protection of public health and water
8 quality.

9 (ii) Technical and financial assistance for brownfields remediation
10 under the Vermont brownfields initiative.

11 (iii) Community development block grant (CDBG) program
12 implementation grants.

13 (iv) Technical, financial, and other benefits made available by
14 statute or rule.

15 (B) Whenever the Commissioner of Buildings and General Services
16 or other State officials in charge of selecting a site are planning to lease or
17 construct buildings suitable to being located in a designated growth center after
18 determining that the option of utilizing existing space in a downtown
19 development district pursuant to subdivision 2794(a)(13) of this title or within
20 a designated village center pursuant to subdivision 2793a(c)(6) of this title or
21 within a designated new town center pursuant to subdivision 2793b(c)(2) of

1 this title is not feasible, the option of locating in a designated growth center

4 (4) State investments. The State shall:

5 (A) Expand the scope of the downtown transportation fund, as funds
6 are available, to include access to downtowns with the first priority being
7 projects located in designated downtowns, the second priority being projects
8 located in designated village centers, and the third priority being projects
9 located in designated growth centers.

10 (B) Extend priority consideration for transportation enhancement
11 improvements located within or serving designated downtowns, village
12 centers, and growth centers.

13 (C) Grant to projects located within designated growth centers
14 priority consideration for State housing renovation and affordable housing
15 construction assistance programs.

16 (5) Regulatory incentives.

17 (A) Master plan permit application. At any time while designation of
18 a growth center is in effect, any person or persons who exercise ownership or
19 control over an area encompassing all or part of the designated growth center
20 or any municipality within which a growth center has been formally designated
21 may apply for a master plan permit for that area or any portion of that area to

1 the district commission pursuant to the rules of the Natural Resources Board.
2 Municipalities making an application under this subdivision are not required to
3 exercise ownership of or control over the affected property. The district
4 commission shall be bound by any conclusions or findings of the Natural
5 Resources Board, or any final adjudication of those findings and conclusions,
6 pursuant to subsection (f) of this section but shall consider de novo any of the
