Whereas, in 1996, Molly Barker started the first Girls on the Run with 13 girls in Charlotte, North Carolina, and

Whereas, her objective was to inspire young girls to live healthy lives and recognize their extraordinary potential through a series of running activities, and

Whereas, today, Girls on the Run activities occur in over 200 cities in the United States and Canada, and its Vermont presence began in 1999, and

Whereas, Girls on the Run of Vermont, Inc., a nonprofit organization was incorporated in 2001 and envisions a Vermont where every girl knows and activates her limitless potential and is free to pursue boldly her dreams, and

Whereas, starting with its first running event, 25,000 young Vermont girls have participated either in grades 3–5 in Girls on the Run, or in grades 6–8 in the associated Girls on the Track, and

Whereas, over 2,000 volunteer coaches have served as mentors for young Vermont girls participating in this exciting and worthwhile activity, and

Whereas, in 2013, over 200 groups in 144 schools, an estimated 3,000 girls, and over 600 volunteer coaches who encourage and guide these young girls in their running activities are participating, and

Whereas, the 2013 Girls on the Run season started between March 11 and March 25, depending on the specific locality, and

Whereas, this spring, Girls on the Run of Vermont, Inc. will host three regional five-kilometer events at Brattleboro Union High School on May 25, at the Vermont State Fairgrounds on June 1, and at the Champlain Valley Expo on June 8, and

Whereas, it is anticipated that among the three events, a total of over 8,000 persons, including girls, parents, and community members, will attend, and

Whereas, Girls on the Run helps young girls develop confidence and instills in them the desire to succeed while living healthy lives, now therefore be it

Whereas, each week, he chooses a topic or theme such as Fifty Years Ago, Singing With Your Kids, Hello Songs, or Songs About Radio, and

Whereas, listeners to public radio expect erudite commentary about the music they are hearing, and Joel Najman does not disappoint, and

Whereas, before his desire for a broadcasting career became irresistible, Joel Najman nearly completed a doctorate in experimental psychology at the University of Vermont, and he applies this academic background when

researching the anthropological, historical, musicological, and psychological aspects of the music presented on his weekly VPR broadcast, and

Whereas, the enormity of Joel Najman's effort is reflected in his recording several hours of material for a My Place episode that he edits down to a concise one hour, and

Whereas, Joel Najman began his broadcasting career at WRMC, the Middlebury College radio station, and while still a student at the college commuted on a ferry boat across Lake Champlain to his first professional radio job at WIPS in Ticonderoga, New York, and

Whereas, his radio career has included serving as a morning announcer, program director, and news director at different radio stations in Vermont, and

Whereas, Joel Najman derives much enjoyment and satisfaction from his role as the host and producer of VPR's My Place, and

Whereas, he writes about rock music and has even hosted a My Place rock and roll evening at the Barre Labor Hall at which he served as a combination DJ and rock historian, and

Whereas, since 1982, My Place has earned a special place on the VPR schedule, and Joel Najman is proud to have brought the sounds of rock and roll to music fans in Vermont, now therefore be it

Whereas, in 1912, Louis Gandin, an immigrant from Italy, purchased a granite manufacturing business in South Ryegate, and

Whereas, from the start, Louis Gandin and his family have striven to operate their business with the goals of quality, service, and customer satisfaction always in mind, and

Whereas, in 1921, Tony Gandin, the younger brother of Louis, immigrated to the United States to join his brother and learn about the Vermont granite industry, and

Whereas, when Louis Gandin died at an early age, Tony and his sister-in-law Rose assumed control of Gandin Brothers and operated the business through the Great Depression, and

Whereas, the family's management of the business continued as Tony's son Allen Gandin, who joined the company in 1948, took over Gandin Brothers following his father's death in 1969, and Allen's younger brother Butch, who became a Gandin employee in 1964, became President following his older brother's retirement in 1994, and

Whereas, in 1990, after graduating from college, Butch's son Tom joined the family's granite business, representing the third generation to participate in the family enterprise, and

Whereas, the family leadership of Gandin Brothers in 2013 includes Butch Gandin serving as President, Tom Gandin as Vice President, and Butch's wife Judith as Secretary and Treasurer, and

Whereas, a group of extended family members is also employed at Gandin Brothers, making this truly a family enterprise, and

Whereas, Tom Gandin has expanded the family's involvement in the Vermont granite industry beyond South Ryegate, as he has served as President of the Barre Granite Association and currently sits on the Association's Board of Trustees, and

Whereas, Gandin Brothers is a granite industry company known for the excellence of its work due to the century-long commitment of the Gandin family and to careful attention to the quality of its products, now therefore be it

That the General Assembly congratulates Gandin Brothers, Inc. of South Ryegate on its 100th anniversary, and be it further

### **H.C.R. 103.**

House concurrent resolution commemorating the semiquincentennial anniversary of the Town of Westford

Offered by: Representative Heath of Westford

Whereas, the Town of Westford traces its origins to June 8, 1763 when New Hampshire Royal Governor Benning Wentworth granted a charter to 66 proprietors for a tract of land of 23,040 acres, described as “Begining at the North Easterly Corner of Milton from thence Runing Southerly by the Easterly Line of said Milton six Miles to the South Easterly corner thereof which is the North Westerly corner of Essex . . . ,” and

Whereas, on March 25, 1793, the first Westford Town Meeting was convened, at which Francis Northway was elected as Moderator, Martin Powell as Town Clerk, and Jeremiah Stone as State Representative, and

Whereas, on August 7, 1801, a Congregational Church was organized in Westford, and

Whereas, the Rev. John H. Woodward, pastor of the Westford Congregational Church in the mid-19th century, served as Chaplain of the First Vermont Cavalry Regiment during the Civil War and was patriotic, brave, and often traveled directly to the battle front, earning him the name “the fighting chaplain,” and

Whereas, in recognition of his extraordinary military service and in honor of the 109 Westford residents who served during the Civil War, including his son who died in a military skirmish in Hagerstown, Maryland, a statue bearing his personal likeness stands on the Westford Common, and

Whereas, this is the only Civil War monument in Vermont that includes a statue bearing the likeness of a specific person, and

Whereas, the Browns River Covered Bridge, a kingpost truss with a Burr arch in the town center, was constructed in 1837–1838 and was restored in 1965 and again more recently, and

Whereas, a highlight of Westford’s 250th anniversary celebration is the Westford Historical Society’s exhibits on schools, war participants, tractors, clothing, Morehouse baskets, stone walls, and foundations, and

Whereas, any resolution commemorating Westford’s 250th anniversary should honor the late Westford Town Historian, Irene E. Allen (1904–1985), who wrote *Westford, Vermont, From 1913 approximately to 1963*, and the Westford section of the 1972 publication, *Look Around Jericho, Underhill and Westford*, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the semiquincentennial anniversary of the Town of Westford, and be it further

Resolved: That the Secretary of State be directed to send a copy of this resolution to the Westford Town Clerk and the Westford Historical Society.

Whereas, the National Endowment for the Arts and the Poetry Foundation, in partnership with the Vermont Arts Council, sponsor the Vermont state competition of the Poetry Out Loud: National Recitation Contest, and

Whereas, 37 high schools participated in the 2013 Vermont semifinal and final rounds at the Barre Opera House on March 13, and

Whereas, St. Johnsbury Academy English Department Assistant Chair Angela Drew, with the cooperation of the entire St. Johnsbury Academy English Department, coordinated the Academy's participation, and

Whereas, Christian DeKett from Wheelock, who has excelled in the dramatic arts at the Academy, was his school's Poetry Out Loud champion and advanced to the state competition, and

Whereas, Christian recited "I Am the People, the Mob" by Carl Sandburg and "Ultima Thule" by Linda Bierds in the semifinals, and

Whereas, he was selected as a regional semifinalist and proceeded to compete in the finals with nine other competitors, and

Whereas, the new final-round judges selected four competitors to advance to an even more selective championship round in which Christian DeKett recited the poem "Experience" by Ralph Waldo Emerson, and

Whereas, Christian DeKett recited beautifully and passionately and was named the 2013 Vermont Poetry Out Loud Champion, and

Whereas, as the Vermont champion, Christian DeKett was awarded a \$200.00 prize, and St. Johnsbury Academy was presented a \$500.00 allowance to purchase poetry books, and

Whereas, Christian DeKett with an all-expense-paid trip will represent Vermont at the Poetry Out Loud National finals in Washington, D.C. on April 29, now therefore be it

*Whereas*, locally owned MuseArts owns iBrattleboro, and its staff organizes the presentation of content, sets broad policy parameters to assure that a degree of civility is maintained, ensures that plagiarism is avoided and copyrights are respected, and assists contributors experiencing technical difficulties posting their contributions, and

*Whereas*, the front page highlights include summaries of the latest stories, lists of the most read and discussed stories of the day, and direct links to the full text of all items posted, and

*Whereas*, the stories are organized according to categories, including news and information, culture, living, opinion, the region, and iBrattleboro, and

*Whereas*, iBrattleboro offers readers the opportunity to comment on stories, and

*Whereas*, contributors have established descriptively named reader groups, including Totalitarianism Watch, Bookworms, Foodies United, Knitting and Handwork, and The Groups Group, an instructional forum on how to start an iBrattleboro readers' group, and

*Whereas*, iBrattleboro recently introduced an updated website featuring improved story organization, enhanced story capabilities, better navigation across the site, and a reorganized weather page, and

*Whereas*, the editors provide a convenient and informative portal to place advertisements on iBrattleboro, and

*Whereas*, since iBrattleboro's entry into the digital universe, the public has completed 46 million page views, submitted 22,000 stories, offered 103,000 comments, announced 9,300 events, and participated in 475 polls, all indicators of a successful and informative 21st century venture, *now therefore be it*
