Whereas, advocates at the 14 member programs of the Vermont Network Against Domestic and Sexual Violence work tirelessly around the clock, every day of the year, to support survivors of domestic violence and sexual assault and to prevent violence in our communities, and

Whereas, in 2012, these advocates served more than 10,000 survivors from every corner of Vermont, and

Whereas, the crimes of domestic violence and sexual assault tear at the very fabric of our communities, and it is the role of advocates to hear these stories, witness pain and violence over and over again, and hold onto hope for a different future for the individual survivors they support and for our society as a whole, and

Whereas, domestic violence and sexual assault are not easy to talk about, although they affect millions of women, children, and men every year, and

Whereas, because of the stigma and shame, these issues often remain hidden in our society, and

Whereas, the national NO MORE campaign seeks to bring domestic violence and sexual assault into the national spotlight to generate more attention, resources, and action to prevent them, and

Whereas, NO MORE aims to empower bystanders of domestic violence and sexual assault in every community to break their silence around these issues and get involved, and

Whereas, no one individual can do everything required to end domestic violence and sexual assault, but we can all do something, and, working together, we can create communities where domestic and sexual violence are not tolerated, now therefore be it

Whereas, after she and her future husband, Kurt Pettinga, returned to Vermont in 1991, Marcia LaFountain earned a master's degree in cellular and molecular biology from the University of Vermont, and

Whereas, with her enhanced academic specialization, she worked as a chemist at the Vermont Forensics Laboratory for 17 years and since 2011 as the laboratory's senior forensic chemist, and

Whereas, her special continuing personal project was the renovation of her home, an old Duxbury farmstead, drawing on her architectural knowledge, and

Whereas, when not focused on home improvements, Marcia LaFountain's many personal pleasures ranged from the athletic, including equestrian activities and snowboarding, to the more sedate, such as cooking, gardening, and knitting, and

Whereas, both she and her husband liked to travel to new and interesting destinations and had visited Africa, Central America, Europe, and Iceland, and

Whereas, Marcia LaFountain was a compassionate, fun-loving, and wonderful person whose life ended far too soon at age 55 on April 4, 2013 following a brief illness, and

Whereas, her survivors include her husband, Kurt Pettinga, her mother, Barbara LaFountain, her brother, Robert, her sister, Lisa, and extended family members, and all of them, along with many friends and colleagues, will miss her, now therefore be it

# H.C.R. 125.

House concurrent resolution commemorating the sestercentennial anniversary of the Town of Sudbury

Offered by: Representatives Shaw of Pittsford and Carr of Brandon

Offered by: Senators Flory, French, and Mullin

Whereas, the Town of Sudbury is located in the northeastern corner of Rutland County, and its "fourteen thousand four Hundred & Twenty four Acres" or "near five miles square" size, as described in the charter that New Hampshire's Royal Governor Benning Wentworth issued to a group of proprietors on August 6, 1763, is perhaps the smallest of any town established under his authority, and

Whereas, the boundaries of Sudbury were described as "Begining at the South West Corner of Neshobe from thence North four deg<sup>8</sup> West five Miles & Two hundred rods to a Stake & Stones from thence North Eighty five deg<sup>8</sup>

West to the Easterly Side Line of Shoreham from thence South five Miles & Two hundred rods to a Stake & Stones . . . ," and

Whereas, the proprietors assembled soon after the issuance of the charter at the home of Silas Brown in Sudbury, Massachusetts, and

Whereas, the town may have been named for the Massachusetts town, for

Sudbury, England, or for Baron Sudbury, the title of Wentworth's kinsman Augustus Henry Fitzroy, and

Whereas, in 1772, a military road was constructed from Ft. Warren in Castleton to the Crown Point Road in Sudbury, which itself had been constructed from 1759 to 1760, as was the Ft. Ti Branch road, and

Whereas, the proprietors met in 1775 and drew a range map supposedly showing both the Crown Point and Ft. Ti Branch military roads, and

Whereas, the first recorded Sudbury Town Meeting was held on January 15, 1789, but it may not have been the organizational meeting, although it is documented that John Hall was elected that day as moderator, and

Whereas, an unaffiliated religious group conducted services in 1791 at the Hawkins farm, and

Whereas, the group affiliated with the Congregational Church in 1803, and a Federal style meeting house for worship and public days was opened in 1807 and still stands, and

Whereas, the Town of Sudbury is celebrating the 250th anniversary of its establishment with festivities on the 10th of August, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the sestercentennial anniversary of the Town of Sudbury, and be it further

Whereas, after 40 years of newspaper or wire service reporting or editing, Candace Page will be retiring from the full-time *Burlington Free Press* staff in April 2013 but plans to keep her pad and pencil at hand as a freelance writer, and

Whereas, Candace Page, her husband, their children, and grandchildren all look forward to outdoor adventures, and she also hopes to continue satisfying her passion for cooking, now therefore be it

Whereas, a group of artistically and civically concerned individuals was formed in 1997 to purchase it and restore architectural luster while simultaneously retrofitting it as a first-class, 21st-century performance, exhibition, and meeting venue, and

Whereas, with the assistance of the Bread Loaf Corporation, the Endeavor Fund, Middlebury College, and the State of Vermont as well as hundreds of local contributors, the supporters of this worthy endeavor were able to purchase the building in the year 2000, and

<u>Whereas</u>, the improvements included stabilization of the structure, restoration of the bell tower, renovation and modernization of the theater space, installation of new seating and modern technical systems, including HD satellite reception and video projection, and the addition of the Jackson Gallery, and

Whereas, Town Hall Theater is now the home of the Middlebury Community Players, The Maiden Vermont Chorus, the Middlebury Actors Workshop, and the Opera Company of Middlebury and hosts the After Dark Music Series, Point Counterpoint, the Vermont Bookshop Authors Series, Night Fires, the Champaign Philharmonic Orchestra, and fundraising events for area nonprofits, and

Whereas, since opening in 2008, the theater has presented a wide range of events, including nationally known performers, Middlebury College presentations, weddings, teen dances, town meetings, memorial celebrations, educational events, live broadcasts from the Metropolitan Opera, and the Middlebury Union High School Junior Prom, and

Whereas, the Will and Carolyn Jackson Gallery at Town Hall Theater presents eight exhibitions each year of the work of Vermont artists, and

Whereas, Town Hall Theater now presents over 165 events every year and was presented a Preservation Trust of Vermont Award, and

Whereas, on June 22, 2013, the Town Hall Theater will celebrate its fifth anniversary with a performance cavalcade of memorable past events as part of a festive birthday party, now therefore be it

Offered by: Senators Campbell, McCormack, and Nitka

Whereas, the community-managed system of cross-country skiing and snowshoeing trails in Hartland originated in the early 1970s when Henry Merritt sought a backyard recreational activity to keep his daughter, who suffered from cystic fibrosis, as healthy as possible, and

Whereas, when several high school students sought a practice course for Nordic skiing, they collaborated with adjacent landowners to extend the Merritt trail system to five kilometers, and

Whereas, in the years that followed, other landowners sought to expand the trail system onto their property, eventually necessitating a formal organization to manage this growing winter recreational resource, and

Whereas, in 1995, a group of the trail system's landowners established Hartland Winter Trails (HWT), a nonprofit and user-supported organization, and artist Gloria Charney designed a logo for the group depicting a skier in a descending glide with a mountain range in the background, and

Whereas, HWT's four core goals are "to provide a community resource for families and individuals of all ages; to foster community participation; to promote respect for and appreciation of the natural environment; and to enhance the physical and mental well-being of those who participate," and

Whereas, HWT is now a part of the Hartland Recreation Department, which provides liability insurance and accounting services, but it remains self-governing and dependent on private financial support through individual donations and occasional fundraisers, and

Whereas, HWT now encompasses 25 kilometers of well-maintained winter pathways, an array of sophisticated grooming equipment, and approximately 30 cooperating private landowners, and

Whereas, the Hartland Nordic Club, formed in 2012, is teaching youngsters to ski, and they can take advantage of HWT's new map, and

Whereas, the volunteers of HWT, including Gary Trachier, Jan and Mike Fisher, George and Carol Little, Lorraine Nichols, Theodore and Andrea Ambros, who is the HWT volunteer director, and Roger and Clydene Trachier, along with the skiers and snowshoers of Hartland continue to enjoy this 40-year-old local recreational resource, now therefore be it

Whereas, his wife, Eileen, and he arrived in Bellows Falls in July 1974, and he established a medical practice at the Hospital Professional Offices, and

Whereas, this newly arrived physician soon became affectionately known as Dr. Wally within months of starting his Vermont medical practice, and

Whereas, Dr. Wally has provided medical services to a broad age spectrum of local residents, serving for over two decades as the Bellows Falls Union High School football team doctor, and, in recognition of his many older patients, earning board certification in geriatric medicine from the Dartmouth Medical School in 1988, and

<u>Whereas</u>, in a reverse educational direction, Dr. Walter Griffiths mentored Dartmouth Medical School students, and

Whereas, on the top of Griswold Drive in Bellows Falls, Dr. Wally developed a conservation tree farm, including a series of hiking trails which are open to the public, and

Whereas, for 20 years, a Halloween tradition in Bellows Falls was for youngsters to visit Dr. Wally's home which he outfitted as a haunted house for the children's enjoyment, and

<u>Whereas</u>, in the business sector, he sat for a decade on the Bellows Falls Trust Company's Board of Directors, and

Whereas, for 35 years, his fraternal association has been as a member of the Bellows Falls Elks, and

Whereas, a New Zealand organization similar to Doctors Without Borders benefited from Dr. Walter Griffiths' professional expertise during his visits to that nation, where he gave respite relief to physicians in small rural towns, and

Whereas, by the year 1911, all the classrooms in the Pittsford school district were full, necessitating the assignment of 17 seventh-grade students to a temporary classroom established at the Otter Creek Inn, and

Whereas, in response, the voters of Pittsford at the March 7, 1911 Town Meeting approved the motion of Rev. C. H. Smith that "the town erect an eight room brick school building according to the recommendation of the school house committee, to accommodate High, Grammar, Village and Mills Intermediate Schools," and

Whereas, the Pittsford electorate, upon a motion of A. D. Tiffany, established a building committee to oversee this construction project, of which Ernest Hitchcock was designated chair, and

Whereas, upon motion of Albert Brouseau, the voters decided to name the school the Lothrop School in honor of the financial generosity of Henry E. Lothrop, and

Whereas, 96-year-old William Barton Shaw laid the cornerstone on August 15, 1911, the 150th anniversary of the granting of the Pittsford town charter, and

Whereas, the building committee hired Henry L. Rourke as the architect, and P. E. Mooney built the foundation, and

Whereas, the new building, which some residents considered far too grand, featured electric lights, slate blackboards, window screens, and an Italian marble entrance, which the Vermont Marble Company contributed for \$2.00, and

Whereas, the town accepted the finished building, costing \$47,794.29, in August 1912, and classes first met in their new home in September 1912, but at first only high school classes were assigned to the Lothrop School, and

Whereas, by approximately 1920, all 12 grades were assigned to the new building, and this configuration continued until Otter Valley Union High School opened in 1961, when Lothrop became an elementary school, and

Whereas, that same year, four new classrooms were added, more rooms were added in 1985, and further renovations occurred in 2008, and

Whereas, a celebration of the school's 100th anniversary will occur on May 31, 2013, now therefore be it

Whereas, 4.9 percent of Vermonters live in extreme poverty, and

Whereas, according to the Vermont Department of Taxes, an individual earning \$20,000.00 to \$25,000.00 experienced a loss of adjusted gross income of -13.3 percent between 2001 and 2011 while the comparable figure for persons earning \$75,000.00 to \$100,000.00 was a gain of 51.9 percent, and

Whereas, as reported in the *Barre Montpelier Times Argus*, the National Low Income Housing Coalition and the Vermont Affordable Housing Coalition recently released a report, "Out of Reach 2013," which estimated that 63 percent of Vermont renters cannot afford the \$964.00 monthly fair market price for a two-bedroom apartment, and

Whereas, Vermont's childhood poverty rate has increased 50 percent during the past decade, and

Whereas, according to Hunger Free Vermont, 13 percent of all Vermont households are food insecure, 22 percent of the state's children under age 18 live in food insecure households, and 12,290 Vermont children depend on food shelves each month, and

Whereas, individuals who are dedicated to reducing and ultimately eliminating poverty in Vermont are gathered at the State House today, May 1, 2013, to inform legislators about the existence and ramifications of poverty in Vermont, now therefore be it

Whereas, on March 10, 1970, the General Assembly adopted Joint Resolution No. R-79 in support of the Governor's proclamation, and

Whereas, the first Green Up Day, during which the Interstate Highway System was closed for three hours, was an enormously successful event, and

Whereas, Green Up Day now takes place on the first Saturday in May, and

Whereas, Green Up's mission is to promote the stewardship of our state's natural landscape and waterways and the viability of our communities by involving people in Green Up Day and raising public awareness about the benefits of a litter-free environment, and

Whereas, on May 1, Vermont's water levels are traditionally high and the water temperatures are low, making it difficult to perform efficient river cleanup efforts safely, resulting in few waterway cleanup efforts on Green Up Day, and

Whereas, designated waterway cleanup events are dependent on the variations in the weather, and dates should be chosen based on the best conditions for efficiency and safety, and

Whereas, river basin organizations' cleanup events are scattered throughout the summer months without statewide coordination or support, and

Whereas, during the month of September, water levels are usually low and temperatures are warm and colleges and schools are in session, and by involving youths, there is an opportunity for education regarding the importance of clean rivers and lakes, now therefore be it
