House concurrent resolution honoring Dr. Kevin Daniel Crowley

Whereas, Dr. Kevin Crowley was born in 1948 in Northfield while his parents, Frank J. Crowley, a World War II veteran, and Anita O'Connor Crowley, were residing in the town as Frank finished his Norwich degree, and

Whereas, although he spent much of his youth in Wilmington, Delaware, Kevin Crowley returned to Vermont each summer to visit his grandparents in Hardwick where, as a teenager, he met Valerie Thompson, who would later become his wife, and

<u>Whereas</u>, not surprisingly, Kevin Crowley enrolled at Norwich University, and after graduation in 1970 earned a medical degree at Thomas Jefferson University in Philadelphia, and

Whereas, Dr. Kevin Crowley completed a family practice residency at the Womack Army Medical Center at Ft. Bragg, North Carolina, and

<u>Whereas</u>, while Kevin and Valerie Crowley were visiting family in Hardwick, the family car needed servicing, and instead of waiting at the Montpelier auto dealer, Dr. Kevin Crowley decided to hitchhike to Northfield to visit Norwich University, and

<u>Whereas</u>, a local undertaker, George Kingston, was his driver, and their conversation was the first step in Dr. Kevin Crowley's becoming Northfield's new town doctor, and

Whereas, Dr. Kevin Crowley's professional duties consisted of caring for patients from young to old, attending hospital rounds, and serving as the sick call physician on the Norwich University campus, and

Whereas, Dr. Kevin Crowley also served as a medical examiner who was called to the scene of accidents and deaths on many occasions, and

<u>Whereas</u>, he mentored University of Vermont medical students and served in many alumni roles at Norwich University, and

Whereas, this much-admired and respected country doctor retired in September 2012, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Dr. Kevin Daniel Crowley for his dedication as a rural physician in Northfield and for his many years of alumni service at Norwich University, and be it further

Whereas, in 1987, Elizabeth Coleman began her extraordinary quarter-century tenure as the ninth President of Bennington College, and

Whereas, her academic and administrative credentials include: an honors undergraduate degree from the University of Chicago; a PhD with distinction from Columbia University; literary scholarship; and service as the founding Dean of the College of Arts and Sciences at New York's New School for Social Research, and

Whereas, her intellectual foresight, pragmatism, and resolute commitment to the long-term viability of Bennington College were called upon in 1994 when, at the Board of Trustees initiation, she led a decisive and difficult organizational restructuring that has brought fiscal stability and innovative academic programs for students, and

Whereas, among these new educational ventures are a low-residency graduate program in creative writing and the ambitious Center for the Advancement of Public Action (CAPA) which invites students to put the world's most pressing problems at the center of their education, and

Whereas, CAPA exemplifies Elizabeth Coleman's belief that higher education should be an innovative catalyst for reinvigorating society, and

Whereas, the Presidency of Elizabeth Coleman reflects many accomplishments, including an historically high enrollment derived from a record number of applicants; fund raising at a record \$175 million; the construction of six new buildings; and campus renovations, including the implementation of biomass as the primary campus heating source, and

Whereas, under Elizabeth Coleman's leadership, Bennington College has happily relinquished the distinction as the nation's most expensive college,

offering 80 percent of its students institutional grants and scholarships, with lower debt than the national average, and

Whereas, after a tenure of enormous historical significance and unusual longevity, Bennington College President Elizabeth Coleman will retire this June, but will remain to serve as Director of the Center for the Advancement of Public Action until June 2015, now therefore be it

Whereas, BMAC serves as a leader in southern Vermont in engaging schoolchildren through visual art, employing the widely respected methodology known as Visual Thinking Strategies, which enhances students' critical-thinking and literacy skills, and

Whereas, the museum serves as Vermont's affiliate for the prestigious national Scholastic Art & Writing Awards, which recognize and encourage our state's budding young artists and writers, and

Whereas, BMAC is an important New England arts destination and worthy of commendation for a job well done, now therefore be it

House concurrent resolution honoring the military valor of the Shores brothers in defending the Union during the Civil War

Offered by: Representatives Quimby of Concord, Batchelor of Derby, Branagan of Georgia, Fay of St. Johnsbury, Feltus of Lyndon, Johnson of Canaan, Kilmartin of Newport City, Larocque of Barnet, Lawrence of Lyndon, Marcotte of Coventry, Michelsen of Hardwick, South of St. Johnsbury, Strong of Albany, Toll of Danville, and Young of Glover

Offered by: Senators Benning, Kitchel, Rodgers, and Starr

Whereas, in remembering the Civil War, it is important to reflect on the lives of individual Vermonters as well as the battles in which they fought, and

Whereas, two young brothers from Granby, Paschal Shores, age 18, and Ethan Shores, age 20, enlisted together on December 9, 1861 into Company K, 8th Regiment Vermont Volunteers, and their older brother George, age 22, enlisted shortly thereafter on January 1, 1862 into the same company and regiment, and

Whereas, George Shores was discharged on July 4, 1862 after sustaining a hernia while serving in Ship Island, Mississippi and was buried in Granby Village cemetery in 1917, and

Whereas, Paschal Shores was taken prisoner on September 4, 1862, but was able to rejoin his regiment, and

Whereas, on June 14, 1863, he was wounded at the Battle of Port Hudson in Louisiana when a musket ball hit his shoulder, but he refused a discharge, and

Whereas, Paschal Shores' life ended at the Battle of Cedar Creek on October 19, 1864 when a musket ball passed through one of his lungs, and he died at midnight the following night, and his brother Ethan saw him on the

battlefield and spoke to him one last time but, as he was carrying the Vermont colors, he could not stop, and

<u>Whereas</u>, Paschal Shores is now buried at Winchester National Cemetery in Virginia in lot No. 2, grave No. 1,674, and

Whereas, Ethan Shores was subjected to multiple wounds at the Battle of Bayou des Allemands in Bootee Station, Louisiana on September 4, 1862, was promoted to corporal on November 26, 1863, and was promoted to the rank of sergeant on July 1, 1864, and

Whereas, when the Vermont regimental color-bearer at the Battle of Cedar Creek was shot, Sgt. Ethan Shores seized the flag and shot one rebel and bayonetted another when challenged, and he retained the flag for the balance of the day after a corporal of the color guard was shot as Sgt. Ethan Shores passed him the flag, and

Whereas, Sgt. Ethan Shores survived the Civil War, returned to Granby, held various town offices, served in the General Assembly, and was buried at Shores Cemetery in Victory in 1901, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors the military valor of the Shores brothers in defending the Union during the Civil War, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the descendants of these brave Vermonters.

Whereas, sexual assaults in the U.S. military have not been diligently adjudicated, and historically, media reporting was sparse, and

Whereas, the U.S. Department of Defense estimated that 19,300 service members were sexually assaulted in 2010, and

Whereas, documentary film director Kirby Dick and producers Amy Ziering and Tanner King Barklow adapted Columbia University journalism professor Helen Benedict's 2007 *Salon.com* article "The Private War of Women Soldiers" as a documentary film entitled *The Invisible War*, and

Whereas, this revealing documentary film has been honored with several awards and was nominated for an Academy Award in the Best Documentary Feature category, and

Whereas, nine sexually assaulted military personnel, eight females and one male, including U.S. Coast Guard Seaman Kori Cioca; U.S. Air Force Senior Airman Jessica Hinves; U.S. Marine Corps Officer Ariana Klay; U.S. Navy Seaman Trina McDonald; U.S. Marine Corps Second Lieutenant Elle Helmer; U.S. Navy Seaman Hannah Sewell; U.S. Army Sergeant Myla Haider; U.S. Navy Lieutenant Paula Coughlin; and U.S. Air Force Technical Sergeant Michael Matthews bravely agreed to forgo their privacy to tell their stories in this film, and

Whereas, various senior active and retired military officials and civilian experts, including Helen Benedict and eight members of Congress, also appeared in this film, and

Whereas, although the publicity resulting from this film prompted the U.S. Secretary of Defense to initiate changes in the Department's handling of sexual assault allegations, the problem of inconsistent prosecution of military personnel accused of committing sexual assault persists, and

<u>Whereas</u>, in Vermont, the House Committee on General, Housing and Military Affairs has developed legislation requiring the Adjutant and Inspector General to report annually on sexual assault or harassment complaints in the Vermont National Guard, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the importance for U.S. military personnel of the newly released documentary film *The Invisible War*, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Chain Camera Pictures in Los Angeles, to the military personnel named in this resolution, and to Vermont Adjutant and Inspector General Steven Cray.

Whereas, Dianne Jaquith has reported to seven different principals, each of whom recognized the outstanding quality of her work and relied on her to attend to the myriad situations that can arise on a typical school day, and

Whereas, although her office location changed several times, she has been a consistent and welcome presence in the operation of the Barstow Memorial School, and

Whereas, each school day Dianne Jaquith greets students and staff in the morning and then makes sure everyone is home safely in the evening, and

Whereas, her shoulder is ideal for crying on, and students know they can turn to her for support, and she is a woman with amazing patience, and

Whereas, Dianne Jaquith contributes back to the school in many ways with gifts, food, and graduation flowers that show the devotion she has to the school, her colleagues, and the students, and

Whereas, one of her claims to fame is having sung happy birthday to Governor Philip Hoff, and

Whereas, Dianne Jaquith has served in regional and state leadership roles in the Vermont Association of Educational Office Professionals, including president, and was its 2007 Region IV Apple Award recipient as the outstanding office professional of the year, and

Whereas, she has served on the Board of the National Association of Educational Office Professionals and chaired its Elementary Council, and

Whereas, after 37 years of exemplary service, Dianne Jaquith is concluding her special role at the Barstow Memorial School and will be honored at a school assembly on May 30, 2013, now therefore be it

Whereas, the Stafford Technical Center is not shuttered during the summer months as it hosts summer camps including theme camps for ninth and tenth graders focusing on music performance, forestry and ecology, fun with food, crime scene investigation, and digital photography, and

Whereas, in 2001, the Vermont Principals Association (VPA) recognized the special attributes that Lyle Jepson brings to his duties as Director of the Stafford Technical Center when it honored him as the Technical Director of the Year, and

Whereas, in the 12 years since his receipt of this award, Lyle Jepson has continued to distinguish himself as an outstanding technical education leader in Vermont, and in 2013 he has once again been named as the VPA's Technical Director of the Year, an honor that he says reflects on the entire Stafford Technical Center community's accomplishments, now therefore be it

Whereas, more than one-half of all Vermont adults requiring inpatient psychiatric and addiction care are admitted to the Brattleboro Retreat, and

Whereas, the facility's programs provide vital inpatient, partial hospitalization, residential, outpatient, and educational services for those in need, and

Whereas, the Brattleboro Retreat proactively adapts to the changing needs of its clients and today's evolving health care environment, and

Whereas, the Brattleboro Retreat is a significant employer in Vermont, providing more than 700 jobs, and

Whereas, the Brattleboro Retreat is a strong participant in the work to eradicate the stigma associated with mental illness, and

Whereas, the medical philosophy of the Brattleboro Retreat is that compassionate and effective patient care occurs when patients are viewed as being the best source of their own recovery, and

Whereas, when Tropical Storm Irene struck Vermont, and the Vermont State Hospital evacuated its patients on almost instantaneous notice, the Brattleboro Retreat responded immediately and accommodated a large number of these individuals, and

Whereas, the Brattleboro Retreat's vision is to be the highest quality psychiatric hospital in the United States, now therefore be it

House concurrent resolution in memory of retired Vermont State Police Sgt. Harold Ackerman

Offered by: Representatives Quimby of Concord, Fay of St. Johnsbury, Feltus of Lyndon, Higley of Lowell, Johnson of Canaan, Larocque of Barnet, Lawrence of Lyndon, South of St. Johnsbury, Strong of Albany, Terenzini of Rutland Town, and Toll of Danville

Offered by: Senators Benning, Kitchel, Rodgers, and Starr

Whereas, retired Vermont State Police Sgt. Harold Ackerman was a true law enforcement pioneer, and

Whereas, on May 16, 1946, he became a Vermont Highway Patrolman assigned to the Rutland barracks, and

Whereas, the law enforcement authority of the Vermont Highway Patrol was limited to traffic accidents, truck weight enforcement, and speeding tickets, and the county sheriffs oversaw major criminal investigations, and

Whereas, Act 163 of 1947 established the Department of Public Safety and directed the new Department to consolidate law enforcement authority, resulting in the formation of the Vermont State Police, and

Whereas, Harold Ackerman became one of the original 19 State Police troopers, and

Whereas, the transformation in his duties was significant, as he was now investigating major crimes, initially with no specialized training, and

Whereas, Harold Ackerman eventually studied homicide investigation techniques at Harvard Medical School, and

Whereas, at first, the troopers relied on signs posted in gas stations as a notification to call their office, and when the first two-way radio system was installed, Trooper Ackerman needed to drive to the top of Mendon Mountain in order to access the signal from Vermont State Police headquarters in Montpelier, and

Whereas, Harold Ackerman demonstrated his proficiency as a law enforcement professional, was promoted to Trooper First Class, and was put in charge of all of Rutland and Addison Counties, and

Whereas, during his Rutland years, Harold Ackerman gained the nickname "Ace" after solving a Mendon case involving missing lumber, and

Whereas, he later served in White River Junction and eventually in St. Johnsbury, where he served as post commander and retired in 1977, and

<u>Whereas</u>, he was frequently the recipient of commendations for his work, and his most memorable case was the Gibson murder in Newbury, and

Whereas, Sgt. Ace Ackerman, the last surviving original Vermont State Trooper, died in April 2013 in St. Johnsbury at the age of 92 and is survived by his three children, George, Steve, and Robin, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly expresses its condolences to the family of retired Vermont State Police Sgt. Harold Ackerman, and be it further

House concurrent resolution congratulating Mikaela Shiffrin on her international alpine ski racing achievements

Whereas, according to a recent profile in the *New York Times*, since she was seven years old and strove "to ski clean arcs in the snow," Mikaela Shiffrin has been on course to become an internationally top-ranked alpine ski racer, and

<u>Whereas</u>, this personal goal is not surprising as her parents were both ski racers as is her brother who is now attending the University of Denver, and

Whereas, she learned the discipline of ski racing at New Hampshire's small Storrs Hill near Hanover, and

Whereas, Mikaela Shiffrin has skied with the Burke Mountain Academy (BMA) ski racing program since age 11 and has attended BMA since she was in the eighth grade, and

Whereas, at age 14, Mikaela Shiffrin skied on an Italian race course where she won the de facto world championship race for 13- to 14-year-olds with a margin of more than three seconds, and

Whereas, at age 15, she made her first appearance in a World Cup ski race, and at age 16, she placed third in a World Cup race, stepping on to the winners' podium for the first time, and

Whereas, in December 2012, Mikaela Shiffrin at the still young but now experienced age of 17 won her first World Cup victory on the slopes in Are, Sweden, and she followed this victory with a win at the prestigious Snow Queen race near Zagreb, Croatia, and

Whereas, Mikaela Shiffrin won the 2013 World Championship slalom in Austria and, most impressively, the World Cup slalom title in Lenzerheide, Switzerland and ultimately the season-long World Cup title for slalom competition, which was an extraordinary accomplishment, and

Whereas, Mikaela Shiffrin is only the second U.S. woman to win either a World Championship or an Olympic gold medal in slalom and the youngest U.S. alpine athlete since 1985 to win a World Championship gold medal, and

Whereas, through her string of amazing victories, Mikaela Shiffrin has remained a modest and down-to-earth teenager who, despite the travel and training time, is determined to graduate this June with her BMA class, now therefore be it

House concurrent resolution congratulating the Bennington Rural Fire Department on its 60th anniversary

Offered by: Representatives Morrissey of Bennington, Corcoran of Bennington, Campion of Bennington, and Mook of Bennington

Offered by: Senators Hartwell and Sears

Whereas, in 1953, the Bennington Pomona Grange, recognizing the need for more localized fire protection services in rural Bennington, established the Bennington Rural Fire Department, and

Whereas, the Department's first chief was T. Howard Mattison, who commanded a force of 35 firefighters, and

Whereas, by 1956, recognizing that a more substantial financing and support structure was required, the Department was instrumental in organizing the Bennington Fire District No. 1, which geographically encompassed all of rural Bennington and those sections of the town of Bennington not within the boundaries of the village of Bennington, including Old Bennington and North Bennington, and, subsequently, a contractual arrangement was established with the town of Woodford, and

Whereas, the Department consists of four companies, each of which has its own officers, and in addition, the legal voters of the entire district annually elect a chief, first assistant chief, and second assistant chief, and

Whereas, he rose rapidly to political prominence in the Illinois Democratic Party, and

Whereas, in 1843, Stephen A. Douglas was elected to the U.S. House of Representatives, where this 30-year old legislator impressed his colleagues as a hard worker and a gifted speaker, and

Whereas, this short and heavyset congressman soon became known as the "Little Giant," and

Whereas, the Illinois electorate recognized him as a master in the legislative and political arenas, and in 1846 they elected him to the U.S. Senate, and

Whereas, although a contender for the Democratic presidential nomination in 1852 and 1856, he was not nominated because of his controversial advocacy of popular sovereignty in the territories to determine the slavery question, and

Whereas, in 1858, as the highlight of Illinois's U.S. Senate campaign, U.S. Sen. Stephen A. Douglas and Abraham Lincoln participated in a series of famous debates which focused on the slavery issue, and

Whereas, Stephen A. Douglas did secure the 1860 Democratic Presidential Nomination and returned to Brandon for the final time during the campaign, and

Whereas, he died in Chicago of typhoid fever on June 3, 1861, and

Whereas, on what would have been Stephen A. Douglas's centennial birthday, various commemorations were held in Brandon, including the dedication of a new monument in his memory, and

Whereas, with financial assistance from local supporters, George Schmitt purchased a biplane which he hoped to demonstrate at the 1910 Vermont State Fair in Rutland, but unfortunately its altitude gain was minimal, and

Whereas, undeterred, the young pilot took more flying lessons to improve his skills, established an aviation company, and started a successful tour of exhibitions, mostly at fairs in the Northeast, and

Whereas, 1911 proved far more auspicious for George Schmitt's aviation record as he exceeded the 5,000-foot altitude mark, a new record for New York State where this flight occurred, and

Whereas, George Schmitt set a biplane world speed record, traveling 24 miles between two Ohio towns in a mere 16 minutes, and

Whereas, in 1912, he returned to the Vermont State Fair in Rutland for a successful flight and then journeyed to Central America and northern South America, and

Whereas, George Schmitt became the first person to fly from the Atlantic to the Pacific Ocean when he piloted a plane across the Isthmus of Panama, and

Whereas, his feats of aeronautical glory were short-lived as the Fair in Rutland proved his final takeoff site in the summer of 1913, and

Whereas, on a passenger flight, George Schmitt's plane crashed into a nearby field and killed him, but his passenger survived, and

Whereas, a century after his death, the Rutland Historical Society has honored George Schmitt with an historic marker, which it recently dedicated at the Rutland fairgrounds, now therefore be it

Whereas, for 33 years, the Nickwackett Hose Company has conducted two haunted house weekends annually as fundraising events for the department to purchase equipment, to support a scholarship program that was started in 1990 for Otter Valley Union High School graduates, and to make donations to needy individuals or organizations, and

Whereas, looking to the next generation of firefighters, in 1987, the Pittsford Fire Department formed a cadet program for interested students at Otter Valley Union High School, and

Whereas, the Pittsford Fire Department protects approximately 3,000 residents in the towns of Pittsford and Florence, now operates from two fire stations, owns eight pieces of firefighting apparatus, and is a member of the Rutland County Fire Mutual Aid Association, and

Whereas, acquiring the property entailed overcoming legal and practical hurdles, but Joe Giancola surmounted them, and on July 27, 1989, he completed the transaction, paying \$400,000.00 for the property, and the Howe Richardson Scale Company was renamed the Howe Center, and

Whereas, Joe Giancola's son, David, described the buildings as looking like Armageddon, and

Whereas, Joe Giancola persevered, and in September 1989, Rutland Industries became the first tenant, and

Whereas, through the years, a number of diverse business, governmental, and nonprofit organizations, including David Giancola's own Edgewood Studios, a feature film production company, have located to the Howe Center, and

<u>Whereas</u>, the entire Giancola family, including Joseph, his wife, Barbara, and sons, Peter and David, decided to create an informative and colorful written and digital history of this special urban renaissance story, which they published in 2008 as the *Howe-to-Book*, now therefore be it

Whereas, on Memorial Day 1913, a group of older military veterans, who possibly served in the Civil War, laid the cornerstone for the new Joslin Memorial Library, and

Whereas, the library's name was selected in honor of Joseph Joslin, a founder of the town of Waitsfield, and

Whereas, the financing for the building resulted from the generosity of Joseph Joslin's grandson, George A. Joslin, a wealthy newspaper entrepreneur who made his fortune in Nebraska, and

Whereas, the new library building was dedicated on October 30, 1913, and

<u>Whereas</u>, this impressive, yellow-brick edifice features two Indiana Bedford limestone columns at the entrance and a stained glass skylight, and

Whereas, 2013 marks 100 years since the Joslin Memorial Library was built, and it remains a thriving community resource with visits from approximately 8,000 people a year, a collection of over 10,000 books, more than 1,100 patrons, and an annual circulation of more than 14,000, now therefore be it

Senate concurrent resolution honoring Hanford Biron for exemplary public service in the town of Norton.

Whereas, for over 40 years, Hanford (Jack) Biron has served the citizens of Norton as a dedicated public servant, and

Whereas, he began his municipal employment in 1970, working the dual positions of Agent to Defend Suits and Agent to sell Real Estate, and

Whereas, Jack Biron continued to serve in both jobs until 1978 when he worked exclusively as Agent to Defend Suits, and

Whereas, starting in 1979, he resumed his dual office duties and remained in both jobs for the next 21 years, and

Whereas, Jack Biron's days and nights became even busier in 1986 when he added Lister to his employment portfolio, and

Whereas, in 2001, he relinquished the role of Agent to sell Real Estate, and

Whereas, in 2003, at the age of 80, Jack Biron did not work for the town of Norton, but his absence from the town payroll was a mere respite and not retirement, and

Whereas, he returned to the town's workforce in 2004 and continued valuing the worth of Norton's real estate properties as Lister until 2011 when, with 41 years of public service in the town, he retired at the age of 88, and

Whereas, at lunch on Memorial Day weekend 2013, the citizens of Norton will pay tribute to Jack Biron for a job well done in each of his municipal occupations, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Hanford Biron for exemplary public service in the town of Norton, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to Jack Biron in Norton.
