Whereas, they practice in traditional hospital surgical suites, obstetrical delivery rooms; critical access hospitals ambulatory surgical centers; the offices of dentists, podiatrists, ophthalmologists, plastic surgeons, and pain management specialists; as well as U.S. military, Public Health Services, and Department of Veterans Affairs health care facilities, and

Whereas, nurse anesthetists have been the main providers of anesthesia in all wars involving U.S. soldiers, sailors, and airmen, since the Civil War, and

Whereas, CRNAs are the primary providers of anesthesia care in rural America, enabling health care facilities in these medically underserved areas to offer obstetrical, surgical, and trauma stabilization services, and, in some states, CRNAs are nearly the exclusive anesthetic providers in rural hospitals, and

Whereas, nurse anesthetists provide needed anesthesia care in hospitals, medical facilities, including the Vermont Veterans Affairs Medical Center, and to Vermont military personnel serving in Afghanistan, and

Whereas, in Vermont, 45 CRNAs work in nine of the State's 13 hospitals in which surgical services are provided, and are part of the economic solution to health care reform, and
