House concurrent resolution congratulating Devin Logan on winning the silver medal at the first Olympic slopestyle skiing women's competition

Whereas, freeskiing was established in the 1990s and entails tricks, jumps, and different types of obstacles, and

Whereas, slopeside skiing, a form of freeskiing, had its Olympic premiere at the 2014 games in Sochi, Russia, and

Whereas, one of the world's premier slopestyle freeskiers is Devin Logan of Dover who has competed as both a slopestyle and halfpipe skier in freestyle competition, and

Whereas, at 15 years of age, she captured second place in halfpipe skiing at the U.S. freeskiing championships, and

Whereas, in 2011, she won a bronze medal in halfpipe skiing at the European X Games, and

Whereas, the competency and creativity Devin Logan has demonstrated on the slopes earned her the Association of Freeskiing Professionals 2011 and 2012 women's championships, and

Whereas, while undergoing rehabilitation after a knee injury following her victory at the August 2012 New Zealand World Cup halfpipe, she became a freeskiing judge, a role that enabled her to fine-tune her knowledge of the sport, and

Whereas, after healing, Devin Logan returned to the slopes in time to qualify for the 2014 U.S. Olympic team, and

Whereas, Devin Logan's trip to Sochi, Russia, was a most memorable experience as she won the silver medal in the first Olympic women's freestyle event, and

Whereas, in celebration of her special Olympic silver medal victory, Devin Day, featuring a parade through Dover culminating in a welcoming ceremony at Mt. Snow, will take place on Saturday, March 22, 2014, and

Whereas, special recognition is due to the other Vermont Olympic medal winners, including Kelly Clark (Olympic bronze in halfpipe snowboarding), Hannah Kearney (bronze in moguls), Mikaela Shiffrin (gold in slalom), and Alex Diebold (bronze in snowboard cross), as well as all medal-winning members of the 2014 U.S. Winter Olympic team, now therefore be it

House concurrent resolution designating April 9, 2014 as the Battle of Cedar Creek Remembrance

Offered by: Representatives Devereux of Mount Holly, Branagan of Georgia, Jerman of Essex, and Marek of Newfane

Whereas, Virginia's Shenandoah Valley was vital to the Confederate States of America, and

Whereas, Lieutenant General Ulysses Grant created the Army of the Shenandoah, and instructed its commander, Major General Philip Sheridan, to defeat the Confederate Army under Lieutenant General Jubal Early that defended the Valley, and

Whereas, in the new army were the First Vermont Brigade, the First Vermont Cavalry, the Tenth Vermont, and the Eighth Vermont, and

<u>Whereas</u>, in September 1864, the Army of the Shenandoah, with Vermonters playing important roles, twice defeated Early's army, and

Whereas, the Army of the Shenandoah returned in mid-October and dug in on high ground above Cedar Creek, and

Whereas, a confident General Sheridan journeyed to Washington, D.C., for strategy meetings, and

Whereas, before dawn on October 19, 1864, Early's reinforced army launched a surprise attack across Cedar Creek, and

Whereas, the Eighth Vermont Regiment made an heroic and costly stand on a ridge top, and the men of the Tenth Vermont attacked to recapture several cannons, and

Whereas, the Vermont Brigade achieved a hastily formed battleline that finally halted Early's advance, and

Whereas, Major General Sheridan reached his battered army after a 12-mile ride from Winchester, and launched a counterattack that turned the battle into a Union victory, and

Whereas, Vermont units played major roles in the counterattack, with the Vermont Cavalry alone capturing 23 cannons and three battle flags, and

Whereas, the Cedar Creek victory won Union control of the Shenandoah Valley, ensuring Abraham Lincoln's 1864 presidential win, and this epic battle is depicted in Julian Scott's large State House painting, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates April 9, 2014 as the Battle of Cedar Creek Remembrance Day with ceremonies to be held in the Cedar Creek Room, including the unveiling of a Vermont historic marker for the Cedar Creek Battlefield, and be it further

Whereas, Head Coach Jack Carrier tallied his 99th victory with help from assistant coaches Adam Wheatley and Hayden Coon, while player-manager Dylan Hartman and managers Cherish Preti, Meghan Rafferty, Riley Flowers, and Jordan Ashe were all supportive of the team, now therefore be it

Whereas, the Grange, officially known as The National Grange of the Order of Patrons of Husbandry, is the oldest agriculturally based organization in the United States, and

Whereas, the Grange was established in 1867 to help farmers recover from the effects of the Civil War and to organize them to protest the high shipping costs the railroad monopolies had established, and

Whereas, in order to avoid railroad officials' detection, Grange meetings were held in secret, and

Whereas, a few years later, in 1876, the Bridgewater Corners Grange Hall became the first in Vermont, and

Whereas, the Grange led the struggle to establish rural free mail delivery and to expand electricity in rural areas, and today, the Grange supports efforts to improve Internet availability in rural areas, and

Whereas, from the day of its formation, the Grange gave women and young adults equal status within the organization, including the right to vote and hold office at any level, and

Whereas, in the early 20th century, the Grange was a leading force in the women's suffrage movement, and

Whereas, in 2014, the Grange continues advocating for human rights having recently signed a letter to the U.S. Congress calling for the doubling of legal immigration and legalization for illegal immigrants currently in the United States, and

Whereas, local Granges in Vermont serve as the home for a variety of locally based activities including giving dictionaries to students, offering classes on preserving food, and providing space for dances and other community events, and

Whereas, the General Assembly appreciates the community service of Vermont Grange members, and the work of Vermont State Grange President Errol Briggs and of former leaders Everett Willard, Daryl Lowry, Harold Bergeron, Margaret Richardson, Dale Sanderson, Lester Gibbs, Phyllis Mason, Clyde Berry, the late Richard Brouillette, and the late former Representative Kermit Richardson who served as both State Grange President and National Grange President, now therefore be it

Whereas, her training period was not extensive as she was appointed Town Clerk in August 1986 upon the retirement of her predecessor, and

Whereas, on Town Meeting Day in 1987, Joyce Pedone was elected Town Clerk of Clarendon in her own right and has won the approval of the voters ever since, and

Whereas, under her direction, Clarendon has completed a major modernization of its record-keeping systems, and

Whereas, this modernization process has included scanning municipal land records and posting them online to make them more accessible, and

Whereas, the Clarendon Selectboard Chair has commented on Joyce Pedone's efficiency and helpfulness in assisting the panel in performing its duties, and

Whereas, she has served a key role in the orderly conduct of elections in Clarendon, be they on Town Meeting Day or in a presidential election year, and

Whereas, after 27 and one-half years of faithful service as Town Clerk of Clarendon, Joyce Pedone retired on Town Meeting Day 2014, and a farewell party with many expressions of thanks and good wishes was held on Sunday, March 8, 2014, and

Whereas, Joyce Pedone is looking forward to spending more time with her family, including her recently retired husband, and concluding her tenure as Town Clerk of Clarendon will be the start of a new chapter in her life, now therefore be it

Whereas, Governor Peter Shumlin devoted his 2014 State of the State address to the major opiate addiction problem in Vermont, and

Whereas, opiate and heroin addiction has had an especially strong impact on Rutland City, and

Whereas, the Rutland City Police Department has acknowledged that arresting drug users will not, in itself, address the opiate problem because it does not account for the underlying issues, and

Whereas, law enforcement and social service organizations in Rutland City submitted a proposal for a \$1 million U.S. Department of Justice grant to combat the city's opiate epidemic, and

Whereas, although Rutland City was not awarded the grant, the application process spurred the establishment of Project VISION (Viable Initiatives and Solutions through Involvement Of Neighborhoods), an organization that works with law enforcement to tackle substance abuse, crime, and quality-of-life issues through the implementation of evidence-based strategies, and

Whereas, Project VISION's chair, Joseph Kraus, explained that the concept of this civic partnership is to inform the public that Rutland "is our community and we're taking it back," and

Whereas, the Rutland City Police Department has identified a 10-block zone in the northwest area that is responsible for nearly three-fourths of all the city's police calls, and

Whereas, Project VISION will implement integrated approaches to prevent and reduce crime within the targeted neighborhood through a 25 percent reduction of blighted homes, and a three-year, 50 percent decrease in the number of multiunit apartments through a combined purchase, rehabilitation, and resale program, resulting in the owners residing in the units, and

Whereas, Project VISION has inspired other city initiatives to improve life in this northwest Rutland City neighborhood, and

Whereas, it will take much time and effort to address successfully the opiate problems in Rutland City, but Project VISION represents an important start in the right direction, now therefore be it

That the General Assembly recognizes Project VISION for its role in addressing opiate addiction in Rutland City, and be it further

Whereas, cancer not only affects survivors, but also their caregivers, family members, and close friends, and

Whereas, every year since 1938, the President of the United States has proclaimed April as Cancer Control Month to highlight advances against cancer and rededicate the nation to fighting this disease, and

Whereas, in his 2013 Presidential Proclamation designating April as Cancer Control Month, President Obama stated "Together, our Nation is moving forward in the fight against cancer. As we recommit to improving prevention, detection, and treatment, let us honor the memory of the courageous men and women we have lost to the disease," and

Whereas, the Vermont Department of Health's most recent statistics indicate that approximately 32,000 Vermonters, at some point in their lives, have been diagnosed with cancer, and

Whereas, the American Cancer Society works tirelessly to save lives from cancer by helping people stay well and get well, and

Whereas, recent medical breakthroughs, in combination with an increased public awareness of steps that can be taken to reduce an individual's risk of developing cancer and the importance of early detection, have made cancer more likely to be controllable and curable, and

Whereas, according to the American Cancer Society, research shows that behavior and lifestyle changes, such as quitting tobacco, eating healthier, drinking less alcohol, exercising regularly, using sun protection, and completing necessary cancer screenings, can significantly reduce the risk of being diagnosed with cancer, and

Whereas, despite Vermont's high cancer screening rates, cancer remains the State's leading cause of death, and

Whereas, for survivors and caregivers, a cancer diagnosis is life changing, and their experiences can serve as inspiration for all Vermonters, and

Whereas, April 2014 is recognized nationally as Cancer Control Month and serves as an excellent opportunity to honor cancer survivors and their caregivers and their role in educating the public about this dreaded but increasingly controllable disease, now therefore be it

Whereas, MS causes unpredictable effects in which the progression, severity, and specific symptoms cannot be foreseen, and the cause and cure for this chronic and often debilitating disease remain unknown, and

Whereas, the National Multiple Sclerosis Society, Greater New England Chapter has been committed for more than 58 years to a world free of MS, heightening public knowledge about and insight into the disease, and

Whereas, since 1946, the National Multiple Sclerosis Society has been a driving force of MS research, relentlessly pursuing prevention, treatment, and a cure and has invested more than \$771 million in groundbreaking research, and

Whereas, funds raised through the National Multiple Sclerosis Society fuel the efforts of nearly 325 research projects, globally totaling \$40 million annually, at the best medical centers, universities, and other institutions, and because of this, MS researchers have never been more hopeful, and

Whereas, discovering the cause, finding a cure, and preventing future generations from getting MS is an important task that all Americans and Vermonters should support, and

Whereas, the State of Vermont recognizes the importance of finding the cause of and cure for MS, and expresses its appreciation and admiration for the dedication that the National Multiple Sclerosis Society, Greater New England Chapter has shown toward a future free of MS, now therefore be it

House concurrent resolution congratulating Lida Croteau Surridge on her 100th birthday

Whereas, on November 11, 1913, Lida Croteau was born on her family's Sugar Hill Farm in Kirby, the first of six children of Theodore and Alphosine Croteau, and

Whereas, her household was religiously observant, and the family traveled by buggy or sleigh to Roman Catholic mass each Sunday, and

Whereas, when she was a small child, her father insisted that English was for school and that at home only the French language of his heritage was to be spoken, and

Whereas, in 1921, Theodore Croteau offered the use of a vacant one-room schoolhouse on his property, known today as the Little Red Schoolhouse, if the town of Kirby provided a teacher, and in that structure Lida Croteau completed her education through the eighth grade, and

Whereas, in 1923, Theodore Croteau died when Lida was nine years old, and

Whereas, Lida Croteau met George Surridge while he was logging near her family's farm, and their marriage began on January 31, 1931 at St. Elizabeth's Roman Catholic Church in Lyndonville, and

Whereas, they became the parents of eight children Isabelle, Ethel, Raymond, George Jr., Betty, Helen Ruth, Paul, and Diane Marie, and the family has now grown to include 19 grandchildren, 29 great-grandchildren, and 16 great-great-grandchildren, and

Whereas, in 1940, the family moved for a period of time to a home in Kirby created by moving, and then joining, two camps together, and Lida Surridge returned to an improved version of the house in 1973, remaining until 2013, and

Whereas, Lida Surridge was employed at the St. Johnsbury (later the Northeast Vermont Regional) Hospital, and served as the long-time president of the Morse's Mills Home Demonstration Club, and
