Whereas, Edwin Lawrence is an extraordinary musician, and

Whereas, he holds a bachelor's degree in music from the State University of New York at Fredonia, and

Whereas, at Williams College, he is an artist associate teaching courses in piano, harpsichord, and organ, and

Whereas, Edwin Lawrence serves as Minister of Music for the First Congregational Church of Williamstown and Music Director of the Oldcastle Theater in Bennington, and

Whereas, for 38 years, Edwin Lawrence has served as the outstanding director of the Bennington County Choral Society (BCCS), a community chorus drawing enthusiastic singers from Bennington County and nearby New York State and Massachusetts communities, and

Whereas, Edwin Lawrence has arranged and composed music for the BCCS, and under his leadership the BCCS has commissioned musical works of other Vermont composers, including Erik Nielsen and Allen Shaw, and

Whereas, for the 250th anniversary of the Town of Bennington, he arranged musical settings for the poetry of Bennington poets Mary Ruefle, Ben Belitt, Lyle Glazier, Barbara Howes, Julia Randall, and Stephen Sandy, and

Whereas, Edwin Lawrence has conducted the combined forces of the BCCS and the Vermont Symphony on two occasions, and

Whereas, in 1976, he was one of the Vermont composers to represent the State at the Kennedy Center's Bicentennial Parade of American Music, and

Whereas, he is a founding member of the Consortium of Vermont Composers, and

Whereas, Edwin Lawrence is a recipient of the Vermont Arts Council Citation of Merit and a Paul Harris Fellowship from the Bennington Rotary Club, and

Whereas, after nearly four decades of delighting his singers and audiences with inspiring choral music performances, on April 26 and 27, 2014, Edwin Lawrence will conduct his final BCCS concerts: Folk Mass from Two Worlds, featuring the Misa Criolla by Ariel Ramirez and Schubert's Mass in G, now therefore be it

Whereas, the public will still be able to rely on Grace Simonds for important emergency and public safety information, as she will continue her tenure as the Whiting Town Service Officer, and

fields of science, technology, mathematics, or engineering to work for 11 months with a federal agency or Congress on a national education policy or program, and

Whereas, the U.S. Department of Energy's Office of Science's Office of Workforce Development for Teachers and Scientists manages the AEF Program, and

Whereas, only 14 educators are awarded this honor each year, and the extremely competitive selection process, including four days of interviews in Washington, D.C., started in September and culminated with the announcement of fellowship recipients in March, and

Whereas, one of the 2014 Albert Einstein Distinguished Educator Fellowship winners is Erica Wallstrom, a 9th-grade science teacher at Rutland Senior High School, and

Whereas, Erica Wallstrom and her husband, David, who has been an enthusiastic supporter of her successful quest for an AEF, will be relocating temporarily to Washington, D.C., and

Whereas, in the nation's capital, Erica Wallstrom will be working at federal agencies on National Science Foundation-supported research examining climatological effects on the permafrost in Greenland and possibly in Antarctica, and

Whereas, Erica Wallstrom is anticipating this unusual and exciting research adventure to encourage more persons, especially her students, to recognize the importance of the polar icecap on the world's environment, and

Whereas, she is an educator who cares passionately about her students and views her teaching role as one of great importance, and

Whereas, the awarding of an Albert Einstein Distinguished Educator Fellowship to Erica Wallstrom is both a singular personal achievement and a great honor for Rutland Senior High School, now therefore be it

Whereas, his reputation and credentials were such an ideal match that the district did not conduct any external advertising for the job, and

Whereas, Rutland City Superintendent Mary Moran has described William Olsen as "the teacher every parent wanted for their children, the middle school assistant principal whom countless students sought out for advice," and

Whereas, she has stated that his RSHS principalship has been transformative, making the school "more student-centered, rigorous, and relevant," and

Whereas, under his leadership, RSHS has adopted new approaches to instruction and assessment as well as new forms of intervention to keep struggling students from failing, and

Whereas, at a recent Global Issues Network conference, RSHS students gave presentations on a variety of topics, ranging from health to cyberbullying, alongside experts in these respective fields, and

Whereas, William Olsen described his work at RSHS as an effort to redesign the school, and

Whereas, through all of these developments, William Olsen has minimized his role, emphasizing the participation of the entire RSHS community, and

Whereas, despite this modesty, the Vermont Principals Association (VPA) recognized that William Olsen is an outstanding educational leader and has named him its 2014 Principal of the Year, and

Whereas, this well-deserved honor will be presented to William Olsen at the VPA's luncheon on April 30, now therefore be it

Whereas, during World War II, Larry Powers served initially in the Belgian Congo, then graduated as a second lieutenant from the Aviation Cadet Center in San Antonio, Texas before flying combat missions in Europe, and many years later, in 1964, he retired as a U.S. Air Force Reserve major, and

Whereas, he married his wife, Bernice, in 1945, and was associated with his family's business M.F. Powers's & Sons, and

Whereas, Larry Powers's public service included every aspect of village governance including the North Bennington Village Board of Trustees, School Board, and Water Board, and

Whereas, although he served on the Town of Bennington Board of Listers and Board of Civil Authority, Larry Powers always remained a strong advocate for the continued political independence of the Village of North Bennington, and

Whereas, Larry Powers's nonprofit leadership included the boards of the Park-McCullough House, the John C. McCullough Library, the Bennington Museum, Southern Vermont College, serving as president of Parans Recreation, the NorShaft Lions Club, and the Vermont Veterans Home, and being a charter member of the NorShaft Little League, and

Whereas, starting in 1974, the local electorate chose Larry Powers to serve three consecutive terms in the House of Representatives, and for two of those three terms, he chaired the House Committee on Commerce, and

Whereas, Larry Powers wrote two books of stories about North Bennington, and

Whereas, on February 7, 2014, at 93 years of age, Larry Powers died, and his survivors include his children, Timothy and Christine, and a granddaughter, Margaret, now therefore be it

Whereas, between his two Afghan assignments, Command Sergeant Major Forest Glodgett served in leadership posts with the 124th Regiment and the 86th Infantry Brigade Combat Team (Mountain), and

Whereas, the culmination of Forest Glodgett's military career occurred on February 7, 2011 when he was appointed the Vermont National Guard's top noncommissioned officer, State Command Sergeant Major, and

Whereas, in this senior role, he advises the Vermont Adjutant and Inspector General on all matters related to Vermont Army and Air National Guard enlisted personnel and is responsible for their participation in the Vermont National Guard's partnerships with Macedonia and Senegal, and

Whereas, Command Sergeant Major Forest Glodgett is the recipient of numerous military honors, including the Legion of Merit, the Bronze Star Medal (with one oak leaf cluster), and the Meritorious Service Medal, and

Whereas, the Brownington native and Jericho resident is married to Kara Glodgett, and they are the parents of Travis, Shannon, Wyatt, and Kade, and the grandparents of Jaylynne, and

Whereas, Command Sergeant Major Forest Glodgett will conclude his 37 years of extraordinary military service on September 30, 2014, now therefore be it

Whereas, the Northfield Post Office has a special role each business day, gathering the large amount of mail addressed to recipients at Norwich University, and

Whereas, in recent years, automation has altered the process of sorting incoming mail, and

Whereas, the local cancellation stamp is gone, as all mail, even mail sent between two Northfield postal patrons, is sent first to the regional processing center in Essex, and

Whereas, the prevalence of First-Class Mail declined sharply as e-mail assumed a predominant role in personal correspondence, and

Whereas, the sale of Forever stamps has grown, as they can be used for their original purpose notwithstanding changing postal rates, and

Whereas, despite these changes in postal practices, Wayne Hunter remained a steady presence at the Northfield Post Office for over three decades, and

Whereas, on April 2, 2014, Wayne Hunter concluded his exemplary public service as a U.S. Postal Service employee and now looks forward to spending more time gardening at home in Riverton, on the golf course, and with his wife, Jeanette, their two daughters, and three grandchildren, now therefore be it
