Whereas, Marc Chabot also earned a master's degree in computer science and shifted his career back and forth between teaching and the technology industry until arriving at Thetford Academy, at the suggestion of head of school Martha Rich, to accept a joint chemistry-physics position, and

Whereas, Thetford Academy proved his ideal employer, and Marc Chabot developed a true passion for teaching, and

<u>Whereas</u>, technology remains a focus of Marc Chabot's professional duties, and he serves as his school's STEM coordinator and robotics advisor, and

Whereas, Marc Chabot has become a teacher held in the highest regard at both Thetford Academy and among his colleagues near and far, and

Whereas, here in Vermont, Marc Chabot was presented the 2014 Angelo J. Dorta Award for Teaching Excellence, the premier recognition that the Vermont-NEA bestows on a teacher, and

Whereas, Marc Chabot will represent Vermont at the national competition for the NEA Foundation Award for Teaching Excellence, and

Whereas, winning the Vermont-NEA Award was not Marc Chabot's only special honor this school year, and

Whereas, he was also selected as a Siemens Teachers As Researchers (STARs) Fellow, a program of the Siemens Foundation conducted in association with Discovery Education and Oak Ridge Associated Universities, and

Whereas, Marc Chabot will travel to the Oak Ridge National Laboratory in Tennessee to attend the two-week STARs program, featuring workshops and research opportunities with Oak Ridge scientists and other educators, and

Whereas, truly Marc Chabot is a teacher of extraordinary dedication and talent who is a model for his peers to emulate, now therefore be it

Whereas, in 2014, HFCU has expanded to nine branches, with three locations in its hometown of Rutland, as well as Bennington, Brandon, Fair Haven, Londonderry, Ludlow, and across the Connecticut River in Hooksett, New Hampshire, and

Whereas, the financial assets at HFCU have grown to more than \$361 million and there are 145 employees on its staff, and

Whereas, HFCU manages two student credit unions and is proud of its Ron Hance Operations Center, and

Whereas, Ron Hance is a State, national, and international leader in the credit union movement, and

Whereas, in 2011, his professional colleagues demonstrated their respect for his accomplishments when they inducted Ron Hance into the Credit Union Executive Society Hall of Fame, and

Whereas, locally, Ron Hance was honored as the 2012 Rutland Region Chamber of Commerce Business Person of the Year, and

Whereas, he is active in the Rutland community through his association with the College of St. Joseph and the Rutland Regional Medical Center, and

Whereas, after 36 years as the HFCU's dynamic and respected CEO, Ron Hance has announced his retirement, and the HFCU employees will miss his presence in their professional lives, now therefore be it

Whereas, after extensive planning, in 1992 the Springfield Area Parent Child Center (SAPCC) opened, and after a brief residency in the former Park Street School, purchased a building on Myrtle Street, and

Whereas, Betty Kinsman was hired as the first SAPCC director, and

Whereas, in 1997, in need of more space, the SAPCC relocated much of its activity to the former Springfield Decorating Center in North Springfield, and

Whereas, in the ensuing years, the SAPCC added additional programs and services, including, in 2002, Myrtle's Closet - A Thrift Store, used as a job training site, and the Learning Partners Child Center located at the Howard Dean Education Center, and

Whereas, in 2004, the SAPCC purchased its North Springfield building and the adjacent property, and

Whereas, after planning and experimental online fundraising, in 2009, a formal capital campaign for a new headquarters was launched, and

Whereas, privately raised funds and \$2.7 million in federal grants and loans led to the opening in June 2011 of a beautiful new \$3.5 million, 12,469-square-foot headquarters, and the old building was rehabilitated for rental apartments and the SAPCC's child advocacy center, and

Whereas, the SAPCC now serves 15 communities in Windsor and Windham counties and offers approximately 50 different services to children, young families, new mothers, and families in crisis, and

Whereas, these accomplishments would not have occurred without the dedicated leadership of Betty Kinsman who oversaw the SAPCC as it evolved, and

Whereas, after over two decades of exemplary work for the children and families of the greater Springfield area, Betty Kinsman retired in February 2014, leaving outstanding programs and an impressive headquarters as her professional legacy, now therefore be it

Whereas, the Town of Albany has been most fortunate to avail itself of Francis Whitcomb's faithful and wise civic leadership as a lister, justice of the peace, and planning commissioner for 36 years, a grand juror for 29 years, and as a patient and effective town moderator for 15 years, and

<u>Whereas</u>, her compositional aspirations are nurtured through her participation in the Music Composition Online Mentoring Program, a nonprofit organization supporting Vermont student composers and musical organizations, and

Whereas, Susie Francy enjoys composing music "because it lets me express ideas that cannot be expressed as thoroughly through words," and that "speaking through music (arrangement especially) allows my unique perspective of the world to be heard," and

Whereas, at the January 22, 2014 Farmers Night State House concert, the Vermont Symphony Orchestra performed her composition, *Beowulf's Last Battle*, and the audience took pleasure in its premier performance, and

Whereas, Beowulf refers to a legendary Geatish (early Swedish) hero and king, and the composition is intended as a synopsis of this hero's final battle, but the composer explained that her musical work could be "applied to any battle, whether it be physical, social, or emotional," and

Whereas, when not musically engaged, Susie Francy has acted in school plays and volunteered with the Boys and Girls Club Summer Program and the Summer Explorer's Camp in Newfane and Townshend, and

Whereas, she is enrolled in Leland and Gray's Journey East program, an Asian immersion study program that is traveling to China to collaborate with Chinese students in cultural and theatrical activities, now therefore be it

House concurrent resolution designating April 29, 2014 as Alzheimer's Awareness Day in Vermont

Whereas, dementia is a "deterioration of intellectual facilities such as memory, concentration and judgment," and

Whereas, Alzheimer's is the most common form of dementia in the United States, and

Whereas, the symptoms of Alzheimer's develop slowly and worsen over time, and

Whereas, although the greatest known risk factor for Alzheimer's is increasing age, it is not a normal part of aging, and

Whereas, according to the Alzheimer's Association, an estimated 5.2 million Americans have the disease, and the comparable Vermont figure is 11,000, and

Whereas, Alzheimer's is the sixth leading cause of death in the United States, and annually approximately 500,000 deaths are attributable to Alzheimer's disease, and

Whereas, according to 2013 data, there are 15.5 million Americans serving as Alzheimer's caregivers who devote an estimated 17.7 billion unpaid hours valued at \$220 billion, and

Whereas, Alzheimer's has no current cure, but treatment for symptoms is available and research continues, and

Whereas, the General Assembly has recognized the societal impact of Alzheimer's and established the Commission on Alzheimer's Disease and Related Disorders (Commission), and

Whereas, the Commission is directed in statute to "advise State agencies on matters of State policy relating to Alzheimer's disease and other dementia-related disorders," and

Whereas, in this capacity, a Commission subcommittee provided guidance and oversight to the Department of Disabilities, Aging, and Independent Living in the development of the State Plan on Dementia, and

Whereas, today, April 29, 2014, Vermonters concerned about Alzheimer's are visiting the State House, now therefore be it
