House resolution supporting a woman's right to decide her own reproductive choices and commemorating the 40th anniversary of the U.S. Supreme court decision in *Roe v. Wade*

Whereas, on January 22, 1973, the U.S. Supreme Court decision in *Roe v. Wade*, 410 U.S. 113 (1973), established that the U.S. Constitution protects a woman's right to privacy and limits government interference with medical decisions, and

Whereas, the House of Representatives believes that the decision in *Roe v. Wade* ensures that abortion remains a safe and legal procedure for a woman to consider, if and when she needs it, and

Whereas, as the State of Vermont pursues major health care reform, it should be a public policy goal to enhance the health of all citizens, including women of all ages, and to strengthen individuals and families by encouraging and promoting access to comprehensive family planning services and to prenatal support services that help ensure that planned pregnancies remain healthy throughout their entire term, and

Whereas, the General Assembly's repeal of the dated and restrictive 13 V.S.A. Chapter 3 would remove the statutory prohibition on abortion procedures in Vermont and serve as an important legislative action in support of a woman's reproductive rights as well as help a health care provider to perform an abortion procedure without fear of criminal liability, and

Whereas, this legislative body believes that abortion is a deeply personal and often complex decision for a woman, and therefore decisions about whether to choose adoption, end a pregnancy, or raise a child must be left to woman, her family, and her faith, with the counsel of her doctor or health care provider, and

Whereas, a majority of Americans support access to safe and legal abortion and oppose efforts to overturn *Roe v. Wade*, and

Whereas, the 2012 elections sent a powerful and unmistakable message to members of Congress and state legislatures that people do not want politicians to interfere with their personal medical decisions, and

<u>Whereas</u>, violence against providers of family planning services and restrictions on access to abortion endanger the lives of women, now therefore be it

## Resolved by the House of Representatives:

That on the 40th anniversary of *Roe v. Wade*, this legislative body urges Congress and other state legislatures to preserve the rights protected in *Roe v. Wade*, and be it further

Resolved: That this legislative body recognizes the critical importance of continued access to safe and legal abortion, and be it further

<u>Resolved</u>: That this legislative body reaffirms the right of every Vermont woman to privacy, autonomy, and safety in making personal decisions regarding reproduction and family planning, and be it further

<u>Resolved</u>: That the Clerk of the House be directed to send a copy of this resolution to the Vermont Congressional Delegation.

Was read and pending the question, Shall the resolution be adopted? **Rep. Donahue of Northfield** moved to amend the resolution as follows:

<u>First</u>: By amending the eighth <u>Whereas</u> clause and adding a ninth <u>Whereas</u> clause to read as follows:

Whereas, violence against providers of family planning services and restrictions on access to abortion endanger the lives of women, now therefore be it and

Whereas, choice for women is not an option in other nations, especially in China, where women are subjected to forced sterilizations and where pregnant women, often in the late stages of pregnancy, are subjected to forced abortions, now therefore be it

<u>Second</u>: By adding a new third <u>Resolved</u> clause to read as follows:

<u>Resolved</u>: That the Vermont Congressional Delegation be encouraged to speak out strongly against the current practice of forced abortions and forced sterilizations in countries where this is practiced and to take steps to ensure that federal tax dollars are not funding these atrocities, and be it further

**Rep. Pugh of South Burlington** raised a Point of Order that the amendment was not germane to the resolution.

Thereupon, the Speaker referred the resolution to the committee on Human Services.
