Message from the Senate No. 44

A message was received from the Senate by Mr. Marshall, its Assistant Secretary, as follows:

Mr. Speaker:

I am directed to inform the House that:

The Senate has on its part passed Senate bill of the following title:

S. 23. An act relating to access to records in adult protective services investigations.

In the passage of which the concurrence of the House is requested.

The Senate has considered bills originating in the House of the following titles:

H. 584. An act relating to municipal regulation of parking lots and meters.

H. 631. An act relating to lottery commissions.

H. 872. An act relating to the State's Transportation Program and miscellaneous changes to the State's transportation laws.

And has passed the same in concurrence with proposals of amendment in the adoption of which the concurrence of the House is requested.

House Bill Introduced
