SESCF Building Renovation Timeline

January 2014 (funds are secured)

Buildings & General Services hires architect to create construction designs

February – March 2014

Buildings & General Services, Corrections & Salvation Farms work together to draft bid documents

April - May 2014

Project "goes out to bid", General Contractors bid on the project

May - June 2014 (\$100,000 needed to move forward)

Contract is awarded

June 2014

Construction begins

September – October 2014

Construction nears completion

Salvation Farms, Vermont Commodity activities at SESCF Successes

- From Nov. 2012 Jan. 2014, 38 inmates have participated in Vermont Commodity raw packing activities at SESCF; this includes cleaning, grading, and packing raw surplus crops
- Inmate crews have worked a total of 51 days with Salvation Farms' Vermont Commodity Program
- More than 121,430 pounds of donated Vermont surplus produce
- Produce donations have come from only 10 farms this is clear indication that the potential is significant to support scaling up operations.
- Crops cleaned and packed include potatoes, apples, winter squash, onions, carrots, and rutabaga.
- 11 food access sites/agency/institutions have received Vermont Commodity Products:
 - 5 Upper Valley food access sites
 - 2 Vermont Foodbank locations (reaching as many as 280 food access sites in Vermont)
 - o 1 northern Vermont site
 - o 2 out of state sites
 - o the SESCF Meal Program
- Black River Produce (paid by Salvation Farms) has shipped more than 120,000 pounds from farms to SESCF and more than 104,150 pounds from SESCF food to four different food access sites.
- Salvation Farms has transported roughly 1,000 pounds from farms to SESCF and 11,200 pounds from SESCF to nine food access sites.
- Roughly 6,000 pounds between receiving and shipping represents culls from the pack line destined either for the SESCF meal program or the compost.
- Since September of 2013, 6 Vermont Commodity Program crew members have completed ServSafe, one inmate did not received ServSafe certification.

• 10 inmate crew members have participated in a Good Agricultural Practices (GAP) and Good Handling Practices (GHP) short-course specifically designed for them. All received certifications of GAP/GHP training completion.
