2 Representative Kupersmith of South Burlington moves that the bill be
3 amended as follows:

4 First: In Sec. 8, 16 V.S.A. § 176, in subsection (d), by striking out
5 subdivision (1) in its entirety and inserting in lieu thereof a new subdivision (1)
6 to read:

7 (1) Programs of education sponsored by a trade, labor, business, or
8 professional organization that are conducted solely for that organization's
9 membership or for members of the particular industries or professions served
10 by that organization.

11 Second: In Sec. 9, 16 V.S.A. § 176a(e), by striking out subdivision (1) in
12 its entirety and inserting in lieu thereof a new subdivision (1) to read:

13 (1) Programs of education sponsored by a trade, labor, business, or
14 professional organization that are conducted solely for that organization's
15 membership or for members of the particular industries or professions served
16 by that organization.

17 Third: By striking out Sec. 12, 16 V.S.A. § 1521(a), in its entirety and
18 inserting in lieu thereof a new Sec. 12 to read:

19 Sec. 12. 16 V.S.A. § 1521(a) is amended to read:

20 (a) It is the policy of the ~~state~~ State of Vermont that all Vermonters should
21 ~~receive~~ have access to educational services that ~~enable them to master the~~

1 ~~skills essential for further education and training or~~ provide them with the
2 knowledge, skills, and work habits needed for further education and training,
3 increase their employment options, and prepare them for successful entry into
4 or advancement in the workplace.

5 Fourth: In Sec. 13, 16 V.S.A. § 1522, in subdivision (15), in the second
6 sentence, after the final semicolon and before the words “and leads to” by
7 inserting the following: “prepares students for successful entry into or
8 advancement in the workplace;”

9 Fifth: In Sec. 16, 16 V.S.A. § 1533, in subsection (b), by striking out
10 subdivisions (7) and (8) in their entirety and inserting in lieu thereof four new
11 subdivisions to be subdivisions (7) through (10) to read:

12 (7) the adequacy and effectiveness of the center in meeting the
13 educational and employment needs of all its eligible students, including its
14 success in taking steps to encourage each student to consider enrolling in
15 courses not traditional for that student’s ~~sex~~ gender;

16 (8) faculty development policies and instruction;

17 (9) the center’s alignment with and responsiveness to State and regional
18 workforce needs as identified by the Department of Labor in its then-current
19 long-term and short-term occupational projections; and

20 (10) the center’s alignment with the State’s economic development
21 policies and initiatives.

1 Sixth: In Sec. 17, 16 V.S.A. § 1534, in subsection (b), by striking out
2 subdivisions (8) and (9) in their entirety and inserting in lieu thereof four new
3 subdivisions to be subdivisions (8) through (11) to read:

4 (8) participation and completion rates in the program;

5 (9) compliance with State Board rules;

6 (10) the program’s alignment with and responsiveness to State and
7 regional workforce needs as identified by the Department of Labor in its
8 then-current long-term and short-term occupational projections; and

9 (11) the program’s alignment with the State’s economic development
10 policies and initiatives.
