

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Fish, Wildlife and Water Resources to which was
3 referred House Bill No. 685 entitled “An act relating to identification and
4 registration of moorings” respectfully reports that it has considered the same
5 and recommends that the bill be amended by striking out all after the enacting
6 clause and inserting in lieu thereof the following:

7 Sec. 1. 29 V.S.A. § 401 is amended to read:

8 § 401. POLICY

9 (a) Lakes and ponds which are public waters of Vermont and the lands
10 lying thereunder are a public trust, and it is the policy of the State that these
11 waters and lands shall be managed to serve the public good, as defined by
12 section 405 of this title, to the extent authorized by statute. For the purposes of
13 this chapter, the exercise of this management shall be limited to encroachments
14 subject to ~~section 403 of this title~~ subchapter 2 and moorings subject to
15 subchapter 3 of this chapter. The management of these waters and lands shall
16 be exercised by the Department of Environmental Conservation in accordance
17 with this chapter and the rules of the Department.

18 (b) For the purposes of regulation of encroachments under subchapter 2 of
19 this chapter, jurisdiction of the Department shall be construed as extending to
20 all lakes and ponds which are public waters and the lands lying thereunder,
21 which lie beyond the shoreline or shorelines delineated by the mean water

1 level of any lake or pond which is a public water of the State, as such mean
2 water level is determined by the Department. For the purposes of regulation of
3 encroachments under subchapter 2 of this chapter, jurisdiction shall include
4 encroachments of docks and piers on the boatable tributaries of Lake
5 Champlain and Lake Memphremagog upstream to the first barrier to
6 navigation, and encroachments of docks and piers on the Connecticut River
7 impoundments and boatable tributaries of such impounds upstream to the first
8 barrier to navigation. No provision of this chapter shall be construed to permit
9 trespass on private lands without the permission of the owner.

10 (c) For purposes of regulation of moorings regulated under subchapter 3 of
11 this chapter, jurisdiction of the Department shall be construed as extending to
12 all public waters of the State.

13 Sec. 2. 29 V.S.A. § 402(8) is added to read:

14 (8) “Mooring” means a buoy, piling, stake, or other apparatus used to
15 secure, berth, or moor vessels in public water. It does not include fixed piers
16 connected to the shore or accessory structures directly related thereto that are
17 encroachments subject to the permitting requirements of section 403 of this
18 title.

19 Sec. 3. 29 V.S.A. § 403(b) is amended to read:

20 (b) A permit shall not be required for the following uses provided that
21 navigation or boating is not unreasonably impeded:

§ 406. APPEALS

Appeals of any act or decision of the ~~department~~ Department under this ~~chapter~~ subchapter shall be made in accordance with 10 V.S.A. chapter 220 of Title 10.

Sec. 5. 29 V.S.A. § 409 is amended to read:

§ 409. INJUNCTION

Any person aggrieved by any violation of this ~~chapter~~ subchapter, or the ~~attorney general~~ Attorney General at the request of the ~~department~~ Department, may institute any appropriate action in the ~~superior court~~ Superior Court of the county in which a proposed or existing encroachment is located to prevent, restrain, correct, or abate any violation of this ~~chapter~~ subchapter or of the conditions of any permit issued under this ~~chapter~~ subchapter.

Sec. 6. 29 V.S.A. chapter 11, subchapter 3 is added to read:

Subchapter 3. Moorings

§ 416. IDENTIFICATION OF MOORINGS

(a) A person who places a mooring on or in the waters of the State shall paint on or attach to the mooring the owner's name and address.

1 **(b) Any person may use a mooring not bearing the owner's name and**
2 **address to secure his or her vessel.**

3 **§ 417. UNAUTHORIZED USE OF MOORINGS**

4 **A person who ties or otherwise attaches a vessel to an identified mooring of**
5 **another without express permission of the mooring's owner is subject to an**
6 **administrative penalty of not more than \$75.00.**

7 **§ 418. APPEALS**

8 **Appeals of any act or decision of the Department under this subchapter**
9 **shall be made in accordance with 10 V.S.A. chapter 220.**

10 **§ 419. APPLICATION OF MUNICIPAL ORDINANCES**

11 **This subchapter shall not apply to a mooring subject to a validly issued**
12 **municipal ordinance.**

13 **Sec. 7. RECODIFICATION**

14 29 V.S.A. §§ 401–402 are recodified within chapter 11 to be subchapter 1,
15 which is added to read:

16 **Subchapter 1. General Provisions**

17 **Sec. 8. RECODIFICATION**

18 29 V.S.A. §§ 403–410 are recodified within chapter 11 to be subchapter 2,
19 which is added to read:

20 **Subchapter 2. Encroachments**

1 Sec. 9. EFFECTIVE DATE

2 This act shall take effect on July 1, 2014.
