2	The Committee on Government Operations to which was referred House
3	Bill No. 595 entitled "An act relating to establishing the Agency of Controlled
4	Substances" respectfully reports that it has considered the same and
5	recommends that the bill be amended by striking out all after the enacting
6	clause and inserting in lieu thereof the following:
7	Sec. 1. LEGISLATIVE STUDY; AGENCY OF CONTROLLED
8	SUBSTANCES
9	(a) Creation. There is created a Legislative Agency of Controlled
10	Substances Study Committee to review whether an Agency of Controlled
11	Substances should be created in the State.
12	(b) Membership. The Committee shall be composed of the following eight
13	members:
14	(1) four current members of the House of Representatives, not all from
15	the same political party, who shall be appointed by the Speaker of the House.
16	Two of these members shall be from the Committee on Government
17	Operations and two of whom shall be from the Committee on General,
18	Housing and Military Affairs; and
19	(2) four current members of the Senate, not all from the same political
20	party, who shall be appointed by the Committee on Committees. Two of these
21	members shall be from the Committee on Government Operations and two of

whom shall be from the Committee on Economic Development, Housing and

3	(c) Powers and duties. The Committee shall study whether an Agency of
4	Controlled Substances should be created in the State, including the following
5	issues:
6	(1) the duties of the Agency and its personnel; and
7	(2) the structure of the Agency, including which departments would be
8	under the jurisdiction of the Agency.
9	(d) Assistance. The Committee shall have the administrative, technical,
10	and legal assistance of the Office of Legislative Council and the Joint Fiscal
11	Office.
12	(e) Report. On or before December 31, 2014, the Committee shall submit a
13	written report to the General Assembly with its findings and any
14	recommendations for legislative action.
15	(f) Meetings.
16	(1) The Speaker of the House and the President Pro Tempore of the
17	Senate shall call the first meeting of the Committee to occur on or before
18	July 30, 2014.
19	(2) The Committee shall select two co-chairs from among its members
20	at the first meeting, one of whom shall be a member of the House and one of
21	whom shall be a member of the Senate.

1	(3)(A) A majority of the members of the Committee shall be physically
2	present at the same location to constitute a quorum.
3	(B) A member may vote only if physically present at the meeting
4	location.
5	(C) Action shall be taken only if there is both a quorum and a
6	majority vote of the members physically present and voting.
7	(4) The Committee shall cease to exist on December 31, 2014.
8	(g) Reimbursement. For attendance at meetings during adjournment of the
9	General Assembly, legislative members of the Committee shall be entitled to
10	per diem compensation and reimbursement of expenses pursuant to
11	2 V.S.A. § 406.
12	Sec. 2. EFFECTIVE DATE
13	This act shall take effect on passage.
