20	(a) Notwithstanding the provisions of 32 V.S.A. § 1051(a) that provide that
21	the Speaker of the House and the President Pro Tempore of the Senate shall

1	receive annual compensation that is adjusted annually by the cost of living
2	adjustment negotiated for State employees under the most recent collective
3	bargaining agreement, in fiscal years 2015 and 2016, the Speaker and the
4	President Pro Tempore shall not receive a cost of living increase.

14	Sec. 5. PAY ACT APPROPRIATIONS
15	(a) Executive Branch. The two-year agreements between the State of
16	Vermont and the Vermont State Employees' Association for the Defender
17	General, nonmanagement, supervisory, and corrections bargaining units for the
18	period July 1, 2014 through June 30, 2016 and for the collective bargaining
19	agreement with the Vermont Troopers' Association for the period of July 1,
20	2015 through June 30, 2016 shall be funded as follows:

1	(1) Fiscal Year 2015.
2	(A) General Fund. The amount of \$6,571,373.00 is appropriated
3	from the General Fund to the Secretary of Administration for distribution to
4	departments to fund the fiscal year 2015 collective bargaining agreements and
5	the requirements of this act.
6	(B) Transportation Fund. The amount of \$2,000,000.00 is
7	appropriated from the Transportation Fund to the Secretary of Administration
8	for distribution to the Agency of Transportation and the Department of Public
9	Safety to fund the fiscal year 2015 collective bargaining agreements and the
10	requirements of this act.
11	(C) Other funds. The administration shall provide additional
12	spending authority to departments through the existing process of excess
13	receipts to fund the fiscal year 2015 collective bargaining agreements and the
14	requirements of this act. The estimated amounts are \$11,591,844.00 from
15	special fund, federal, and other sources.
16	(D) With due regard to the possible availability of other funds, for
17	fiscal year 2015, the Secretary of Administration may transfer from the various
18	appropriations and various funds and from the receipts of the Liquor Control
19	Board such sums as the Secretary may determine to be necessary to carry out
20	the purposes of this act to the various agencies supported by State funds.

1	(2) Fiscal Year 2016.
2	(A) General Fund. The amount of \$7,900,794.00 is appropriated
3	from the General Fund to the Secretary of Administration for distribution to
4	departments to fund the fiscal year 2016 collective bargaining agreements and
5	the requirements of this act.
6	(B) Transportation Fund. The amount of \$2,000,000.00 is
7	appropriated from the Transportation Fund to the Secretary of Administration
8	for distribution to the Agency of Transportation and the Department of Public
9	Safety to fund the fiscal year 2016 collective bargaining agreements and the
10	requirements of this act.
11	(C) Other funds. The administration shall provide additional
12	spending authority to departments through the existing process of excess
13	receipts to fund the fiscal year 2016 collective bargaining agreements and the
14	requirements of this act. The estimated amounts are \$13,594,459.00 from
15	special fund, federal, and other sources.
16	(D) With due regard to the possible availability of other funds, for

1	(b) Judicial Branch. The two-year agreements between the State of
2	Vermont and the Vermont State Employees' Association for the judicial
