15	according to the provisions of this subchapter, except as exempted by section	
16	3587 of this title, and to enter a complaint against the owners or keepers	
17	thereof.	
18	Third: In Sec. 6, 17 V.S.A. § 2651d, in subsection (a), in the first sentence,	
19	by striking out the words "by Australian ballot"	
20	Fourth: By striking out Sec. 10 in its entirety and inserting in lieu thereof a	
21	new Sec. 10 to read Sec. 10. [Deleted.]	

1	<u>Fifth</u> : In Sec. 11, 24 V.S.A. § 2291, by striking out subdivision (26) in its	
2	entirety and inserting in lieu thereof a new subdivision (26) to read:	
3	(26) When a disaster or emergency has been declared by the Governor, a	
4	municipal building inspector, health officer, fire marshal, or zoning	
5	administrator may declare condemned to be destroyed a property that has been	
6	damaged in the disaster or emergency and is dangerous to life, health, or safety	
7	due to the disaster-related damage. The local legislative body may require that	
8	an official receive training on disaster-related condemnation before he or she	
9	may condemn property under this subdivision. The owner of property	
10	condemned under this subdivision may appeal the condemnation according to	
11	the condemnation appeals procedure of chapter 83 of this title, provided that	
12	any appeal to the Superior Court shall be to the Civil Division.	
13	Sixth: By adding a Sec. 11a to read:	
14	Sec. 11a. DISASTER CONDEMNATION TRAINING	
15	On or before July 1, 2015, the Department of Health, in consultation with	
16	the Department of Housing and Community Development and the Department	
17	of Public Safety, shall develop condemnation guidance for inclusion in disaster	
18	training and education for local officials. The guidance shall include:	
19	(1) methods of inspection of buildings and structures damaged by	
20	natural disaster; and
