

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Government Operations to which was referred Senate
3 Bill No. 27 entitled “An act relating to respectful language in the Vermont
4 Statutes Annotated” respectfully reports that it has considered the same and
5 recommends that the House propose to the Senate that the bill be amended as
6 follows:

7 First: In Sec. 1, subsection (b), by deleting “and 223,” and by inserting
8 “and” before “222” and by deleting Sec. 2a in its entirety

9 Second: In Sec. 2b, 1 V.S.A. § 146, in the first sentence, by striking out
10 “general”

11 Third: By inserting a Sec. 2d after Sec. 2c to read as follows:

12 Sec. 2d. 1 V.S.A. § 148 is added to read:

13 § 148. DEVELOPMENTAL DISABILITY

14 “Developmental disability” or “person with developmental disabilities”
15 shall have the same meaning as in 18 V.S.A. § 9302.

16 Fourth: By deleting Sec. 9 in its entirety

17 Fifth: By deleting Sec. 10 in its entirety

18 Sixth: In Sec. 11, 4 V.S.A. § 33, subdivision (13), by striking out
19 “developmental” and inserting in lieu thereof “intellectual”

20 Seventh: In Sec. 12, 4 V.S.A. § 36(a), subdivision (2)(B)(v), by striking out
21 “developmental” and inserting in lieu thereof “intellectual”

1 Eighth: In Sec. 15, 6 V.S.A. § 2777(d), in subdivisions (2)(E) and (4)(B),
2 by striking out “persons who are elderly” and inserting in lieu thereof “elders”

3 Ninth: By deleting Sec. 17 in its entirety

4 Tenth: In Sec. 19, 8 V.S.A. § 4089b, by deleting subdivision (c)(1) and
5 inserting in lieu thereof the following:

6 (c) A health insurance plan shall provide coverage for treatment of a mental
7 ~~health~~ condition and shall:

8 (1) not establish any rate, term, or condition that places a greater burden
9 on an insured for access to treatment for a mental ~~health~~ condition than for
10 access to treatment for other health conditions, including no greater
11 co-payment for primary mental health care or services than the co-payment
12 applicable to care or services provided by a primary care provider under an
13 insured’s policy and no greater co-payment for specialty mental health care or
14 services than the co-payment applicable to care or services provided by a
15 specialist provider under an insured’s policy;

16 Eleventh: In Sec. 19, 8 V.S.A. § 4089b, by deleting subdivision (d)(1)(A)
17 and inserting in lieu thereof the following:

18 (d)(1)(A) A health insurance plan that does not otherwise provide for
19 management of care under the plan, or that does not provide for the same
20 degree of management of care for all health conditions, may provide coverage
21 for treatment of mental ~~health~~ conditions through a managed care organization,

1 provided that the managed care organization is in compliance with the rules
2 adopted by the Commissioner that assure that the system for delivery of
3 treatment for mental health conditions does not diminish or negate the purpose
4 of this section. In reviewing rates and forms pursuant to section 4062 of this
5 title, the Commissioner or the Green Mountain Care Board established in
6 18 V.S.A. chapter 220, as appropriate, shall consider the compliance of the
7 policy with the provisions of this section.

2 and inserting in lieu thereof “developmental”

3 Eighteenth: In Sec. 80, 16 V.S.A. § 3851(c), by deleting subdivision (5)(D)
4 and inserting in lieu thereof the following:

5 (D) nonprofit assisted living facility, nonprofit continuing care
6 retirement facility, nonprofit residential care facility or similar nonprofit
7 facility for the continuing care of ~~the elderly~~ elders or the infirm, provided that
8 such facility is owned by or under common ownership with an otherwise
9 eligible institution, and in the case of facilities to be financed for an eligible
10 institution provided by this subdivision (5) of this subsection, for which the
11 Green Mountain Care Board, if required, has issued a certificate of need.

3 by inserting “mental condition or” before “psychiatric disability”

4 Twenty-third: In Sec. 111, in 18 V.S.A. § 8706, in subdivision (1), by
5 striking out “and” after the semicolon and in subdivision (3) by inserting “and”
6 after the semicolon

8 who are elderly” and by inserting in lieu thereof “elders” and by inserting
9 “adults who” after “~~disabled adults or~~”

11 inserting before the semicolon “, which means significantly subaverage
12 intellectual functioning existing concurrently with deficits in adaptive behavior
13 that were manifest before 18 years of age”

15 who are elderly” and inserting in lieu thereof “elders”

18 “persons who” and by striking out the comma after “infirmity”

20 striking out the second section symbol

1 adopted by him or her after proper application has been made to the
2 Commissioner by any person residing within the State of Vermont.
3 Application forms shall be available on request at the Department of Motor
4 Vehicles.

6 (4) An applicant for a ~~special handicapped~~ registration plate or placard
7 for persons with disabilities may request the Civil Division of the Superior
8 Court in the county in which he or she resides to review a decision by the
9 Commissioner to deny his or her application for a special registration plate or
10 placard.

12 (d) A person who has an ambulatory disability or an individual transporting
13 a person who is blind shall be permitted to park and to park without fee for at
14 least 10 continuous days in a parking space or area which is restricted as to the
15 length of time parking is permitted or where parking fees are assessed, except
16 that this minimum period shall be 24 continuous hours for parking in a State-
17 or municipally operated parking garage. This section shall not apply to spaces
18 or areas in which parking, standing, or stopping of all vehicles is prohibited by
19 law or by any parking ban, or which are reserved for special vehicles. As a
20 condition to this privilege, the vehicle shall display the ~~special handicapped~~

1 registration plate or placard issued by the Commissioner or a special
2 registration license plate or placard issued by any other jurisdiction.

3 * * *

4 (f) Persons who ~~are temporarily disabled with an~~ have a temporary
5 ambulatory disability may apply for a temporary removable windshield placard
6 to the Commissioner on a form prescribed by him or her. The placard shall be
7 valid for a period of up to six months and displayed as required under the
8 provisions of subsection (c) of this section. The application shall be signed by
9 a licensed physician, certified physician assistant, or licensed advanced
10 practice registered nurse. The validation period of the temporary placard shall
11 be established on the basis of the written recommendation from a licensed
12 physician, certified physician assistant, or licensed advanced practice
13 registered nurse. The Commissioner shall promulgate rules to implement the
14 provisions of this subsection.
