14	prescriptions where the cost-sharing amount required by Medicare Part D is
15	less than \$30.00, and a co-payment of \$2.00 for prescriptions where the
16	cost-sharing amount required by Medicare Part D is \$30.00 or more. A
17	pharmacy may not refuse to dispense a prescription to an individual who does
18	not provide the co-payment.
19	(2) An individual shall contribute the following base cost sharing
20	amounts which shall be indexed to the increases established under 42 C.F.R.
