

## **Substance Abuse Prevention Program Overview**

## What is Substance Abuse Prevention?

Substance abuse prevention is the proactive promotion of healthy lifestyles and norms that reduce the risks associated with the use of alcohol, tobacco and other drugs.

The best prevention is evidence-based and comprehensive – with interventions at the state, community, school, family and individual levels.

## What are ADAP's Prevention Priorities?

Through an ongoing, thorough review of key substance abuse indicators and a strategic planning process involving multiple partners and stakeholders, ADAP has identified the following priority prevention goals<sup>1</sup>:

- Reduce underage drinking
- Reduce high-risk drinking
- Reduce adolescent marijuana use
- Reduce prescription drug misuse and abuse

### What is ADAP Prevention Doing?

ADAP's approach to prevention includes interventions and services at the state, community, school, family and individual levels to support a comprehensive approach to preventing and reducing alcohol and other drug use.

## Capacity Building at State and Community Levels

ADAP's structure includes ten regional Prevention Consultants who serve the agencies, organizations and individuals within the twelve Health Districts. The goal of the Prevention Consultant System is to increase the local community's capacity to lead and carry out effective substance abuse prevention efforts. Prevention Consultants offer five essential services:

- Community Organizing
- Program Planning & Consultation
- Presentations and Training
- Community Grants Information & Guidance
- Information & Referral

ADAP supports a network of community partners through grants, training, and technical assistance to provide the services and interventions described below.

### **Community-wide Interventions**

**Community-Based Prevention Grants** are a joint initiative, supported by funding from Alcohol and Drug Abuse Prevention, Nutrition and Physical Activity, and Tobacco Control. The aim of the program is to reduce health care costs through the creation of healthy communities where Vermonters can lead healthy lives.

Funded strategies include:

- Education on Policy Approaches;
- Social Marketing;
- Sticker Shock;
- Law Enforcement Collaboration;
- Responsible Service Beverage Training;
- eCHECKUP to go;
- Parenting Programs

**Partnerships for Success** is a three-year Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA) Grant. This project builds on the significant outcomes achieved through the Strategic Prevention Framework (see back).

PFS supports regional prevention strategies in six public health districts. The community grants in the amount of \$130,000/year have been awarded to lead agencies representing the VDH district office or county catchment area. The grant also supports training and communications activities for all twelve districts of the state.

Funded strategies include:

- Education on Policy Development
- Enhanced Law Enforcement
- Supporting activities for Alcohol Compliance Checks
- Community Mobilization
- Media Advocacy
- Electronic Screening and Brief Intervention
- Parenting Programs

#### **Enforcing Underage Drinking Laws Program**

The Department of Justice's Office of Juvenile Justice and Delinquency Prevention (OJJDP) funds the Enforcing Underage Drinking Laws (EUDL) Program to reduce underage drinking and improve public safety by encouraging communities to enforce laws, policies and sanctions. In FY14, a EUDL Block Grant of \$59,639 supports:

- 1-866-ITS-FAKE line
- 3 regional Stop Teen Alcohol Risk Teams
- ParentUp Campaign

# Statewide Communications and Information Dissemination

ADAP supports the dissemination of information, tools and links to community resources for the prevention of substance abuse statewide through ADAP's website and materials distribution. Examples include:

## **School-based Services**

ADAP supports twenty-one supervisory unions and school districts with grants to deliver substance abuse prevention and early intervention services as part of a coordinated school health program. Evidence-based school prevention programs can save Vermont \$18 for every \$1 invested.<sup>2</sup>

Examples of ADAP supported school-based services include:

- Substance abuse screening and referral
- Coordinated school health initiatives
- Classroom health curricula
- Training for youth empowerment groups
- Parent education
- Teacher and support staff training
- Delivery of educational support groups

## **Family Support and Education Services**

ADAP supports programs that promote healthy family relationships and strengthen parenting skills and communication. Evidence-based programs that support strong family connections combined with school prevention save from \$3 to \$11 per \$1 invested.<sup>2</sup>

Examples of family support and education programs include:

- Project Rocking Horse
- Parenting Education Programs


## How Do We Know Prevention is Working?


#### **Strategic Prevention Framework Evaluation**

In 2007, Vermont received a Strategic Prevention Framework State Incentive Grant (SPF-SIG), a federally funded five-year initiative in which 24 community-based organizations received grants and training to address underage drinking, high-risk drinking among persons < age 25, and marijuana use among persons < age 25.

All 24 communities successfully completed a prevention plan for their community and implemented one or more environmental prevention strategies aimed at changing population-level indicators of targeted substance use priorities.

Grantees were generally successful in enhancing their organizational capacity for conducting and sustaining their community-based prevention efforts. These efforts appear to have led to significant reductions (relative to non-funded communities) in binge drinking, and marijuana use among high school students.
