8	(1) The Secretary of Natural Resources (Secretary), in consultation with the Secretary of
9	Transportation, the Commissioner of Public Service, the Commissioner of Motor Vehicles, the
10	Commissioner of Taxes, and any other person the Secretary considers appropriate, shall study
11	and formulate recommendations on how to promote an expansion in the use of electric vehicles
12	in Vermont consistent with achieving the State's greenhouse gas reduction goals set forth in 10

14	(A) the costs and benefits to the State of its offering incentives for the purchase or sale
