This report is submitted pursuant to 24 V.S.A. §4774(b), which requires the Agency of Natural Resources and Vermont Economic Development Authority (VEDA) to submit an annual report on the Drinking Water State Revolving Fund (DWSRF) to members of the Joint Fiscal Committee. The report includes information on the balance of the fund, loan awards made to date, and funds anticipated to be made available in the coming year. Additionally, in accordance with past practice, the report is submitted to the House and Senate Committees on Institutions, Senate Committee on Natural Resources and Energy, and House Committee on Fish, Wildlife & Water Resources. The report includes three tables that summarize funds received by the program and the loan commitments capitalized with those funds. The DWSRF was established in 1997 with federal funds appropriated in federal fiscal year 1997 and state matching funds appropriated in state fiscal year 1998. Funding received for the loan program through December 31, 2013 is summarized in Table 1 on the following page.

Priority lists developed in accordance with Environmental Protection Agency approved procedures are used to identify projects to be funded and are included in what are referred to as Intended Use Plans. Table 2 summarizes funding commitments as of December 31, 2013 for both municipally owned and privately owned public water systems. During calendar year 2013, two separate federal fiscal year priority lists were established. The FFY12 priority list, which was initially adopted September 21, 2012, was amended May 1, 2013 and the FFY13 list was adopted August 26, 2013. The initial FFY12 list was developed and submitted to EPA prior to receiving the necessary state match and was established as a tentative list, pending availability of the state appropriation. Filing of a tentative priority list was necessary to apply for and avoid potential loss of federal funds. The required state match was appropriated in the spring of 2013 and the priority list was subsequently amended.

The fundable projects in these two adopted lists are shown in the attached two tables, which are excerpts from Section 9.1 of the adopted FFY12 and FFY13 IUPs¹, respectively. While some of these projects have already commenced, most are anticipated to proceed to construction in the spring/summer of 2014. A funding gap continues to exist as shown in the two priority lists, and based on the number of projects and the funding shortfall in the FFY12 and FFY13 lists of \$27.3M and \$10.7M, respectively, it is anticipated that the demand for loans will continue to exceed the available funding well into the future.

At December 31, 2013 the balance of funds available for additional loans is \$29,742,221, all of which is reserved for fundable projects along with projected revenue from loan repayments and fund interest over the course of this fiscal year to meet the current projected pending project total of \$31,526,107.
