Statement of purpose of bill as introduced: This bill proposes to enable a  
municipality to elect and appoint members to a budget committee.

An act relating to municipal budget committees

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 17 V.S.A. § 2646 is amended to read:

§ 2646. TOWN OFFICERS; QUALIFICATION; ELECTION

At the annual meeting, a town shall choose from among its legally qualified  
voters the following town officers, who shall serve until the next annual  
meeting and until successors are chosen, unless otherwise provided by law:

(17) Three water commissioners unless the town votes to elect additional selectboard members, in which case the number of water commissioners shall, at the discretion of the selectboard, be the same as the number of members that comprise the selectboard. The commissioners shall be elected by ballot if the town has so ordered; otherwise they shall be appointed by the selectboard as provided in section 2651 of this chapter;

(18) If the town so orders, three members of an advisory budget committee to be elected by ballot. Two additional members shall be appointed to the committee by the municipality's legislative body as provided in 24 V.S.A. § 1147.

Sec. 2. 24 V.S.A. chapter 33, subchapter 14 is added to read:

Subchapter 14. Budget Committee

§ 1147. ADVISORY BUDGET COMMITTEE APPOINTMENT; DUTIES

(a) If a municipality elects to create an advisory budget committee as provided in 17 V.S.A. § 2646(18), the legislative body of the municipality shall appoint two members to the five-member committee who shall serve until the next annual meeting.

(b) The municipal budget committee shall evaluate the municipality's budget and make recommendations for the budget based on its findings.

1       Sec. 3. EFFECTIVE DATE

2       This act shall take effect on July 1, 2014.
