
ESIA Transition

The Vermonters included in the tracking below were covered by employer-sponsored insurance in December 2013. The expectation was that enrollment from this group would be low because of existing access to coverage. However, some of these individuals used Vermont Health Connect to find a health plan because their current coverage was considered “unaffordable” or they lost employer-sponsored insurance during the open enrollment period.



Average Time to Answer




