#### SUBSTANCE USE TREATMENT

#### Providing Rehabilitation Services in a Mental Health Setting

**DayOne**, a division of the Psychiatry Service at Fletcher Allen, is an outpatient rehabilitation program for substance use disorders that provides comprehensive treatment at several levels of intensity, ranging from office-based evaluation and treatment to intensive outpatient services.

**DayOne** services are offered to adult men and women who are experiencing symptoms related to addiction and co-occurring mental health disorders.

**DayOne** provided treatment services to **299** patients in **FY13**. Their primary substance use disorder is as follows:

Alcohol-49%Opioids-35%Cannabis-6%Cocaine, etc.-10%

DayOne measures a successful outcome by the following:

- Completion of Individualized Treatment Plan Goals
- Acquired and maintained abstinence
- Addressing co-occurring mental health disorders (if necessary)
- Social Connectedness (12-Step Meetings, Recovery Center visits, self-help groups, etc.)

#### SCREENING AND ASSESSMENT

- A comprehensive assessment to determine the appropriate level of care.
- Provide information regarding treatment options.
- Individualized treatment planning.

#### DAYONE PROVIDES THE FOLLOWING REHABILITATION SERVICES:

• Intensive Outpatient Program (IOP) and Outpatient services with a concentration on group therapy which utilizes emotion regulation, mindfulness, group psychotherapy, motivational enhancement, Cognitive Behavior Therapy, relapse prevention, coping & life skills training and other evidence based solution focused techniques.

- Each group meets for a minimum of 12 sessions.
- Medical mental health assessment with onsite psychiatric services.
- Psychopharmacological evaluation and monitoring.
- Random urine screens and breath alcohol testing to verify self-report.
- Consultation for integrating mental health services.
- Assessment for detoxification services.
- Referral services to residential services as needed.
- Collaboration with Seneca Center and/or Mood and Anxiety Disorders Clinic at Fletcher Allen.
- Educational services and assistance to other Fletcher Allen departments or agencies.

#### TREATMENT DELIVERY

Our range of outpatient treatment services include:

**LEVEL III** – This level of service is our Intensive Outpatient Program (IOP) which meets three times a week for three hour sessions. We offer a morning and an afternoon IOP. The morning IOP meets Monday/Wednesday/Friday from 8:45 - 11:45am with a concentration on co-occurring mental health disorders. The afternoon IOP meets Monday/Tuesday/Thursday from 2:00 - 5:00pm.

LEVEL II – This group meets twice a week on Tuesday and Thursday from 9:00 – 11:00am.

**LEVEL I** – This level of service might include group or individual counseling. The Level I groups meet once a week for ninety minutes. The Level I focus groups include: Women's Recovery Group, Men's Group, Cognitive Behavior Therapy\* Skills Group, Relapse Prevention, Gambling, etc.

\**Cognitive Behavioral Therapy* emphasizes problem-solving, identifying thought distortions and teaching people to think/act more constructively.
