8	(a) There is created a Vermont Physical Education and Nutrition Task
9	Force to examine and recommend ways for schools to improve wellness,
10	physical education, activity, and nutrition in Vermont schools.
11	(b) The Task Force shall be composed of the following members:
12	(1) an individual employed as a teacher in a Vermont public school
13	appointed by the Vermont National Education Association;
14	(2) an individual employed as a physical education teacher in a Vermont
15	public school appointed by the Vermont Association for Health, Physical
16	Education, Recreation and Dance;
17	(3) an individual employed as a food service director in a Vermont
18	public school appointed by the School Nutrition Association of Vermont;
19	(4) an individual employed as a principal in a Vermont public school

6	(8) a representative of the American Cancer Society;
7	(9) a representative of a statewide obesity coalition selected by the

11	(c) The Task Force shall:
12	(1) examine barriers to good nutrition and to adequate time for physical

17	(C) the availability of snacks and beverages;
18	(D) the provision of physical education, including minimum

2	(d) The Task Force shall have the administrative, technical, and legal
3	assistance of the Agency of Education. For purposes of preparing

7	Agency of Education's website and submit to the Governor and the House and
