2	The Committee on Government Operations to which was referred Senate
3	Bill No. 293 entitled "An act relating to reporting on population-level
4	outcomes and indicators and on program-level performance measures"
5	respectfully reports that it has considered the same and recommends that the
6	bill be amended by striking out all after the enacting clause and inserting in
7	lieu thereof the following:
8	Sec. 1. PURPOSE
9	(a) This act is necessary for the General Assembly to obtain data-based
10	information to know how well State government is working to achieve the
11	population-level outcomes the General Assembly sets for Vermont's quality of
12	life, and will assist the General Assembly in determining how best to invest
13	taxpayer dollars.
14	(b) Evaluating the results of spending taxpayer dollars will allow the
15	General Assembly to be more forward-thinking, strategic, and responsive to
16	the long-term needs of Vermonters and allow the Executive Branch to consider
17	how the programs it administers could be further refined in order to produce
18	better results.
19	(c) Using the data-based information provided under this act will encourage
20	State government to continue to move steadily toward results-based
21	accountability and will help educate the General Assembly and Executive

1	Branch on how to be more effective and accountable to Vermonters and will
2	encourage a better partnership with Vermont communities.

5	§ 2311. CHIEF PERFORMANCE OFFICER; ANNUAL REPORT ON
6	POPULATION-LEVEL OUTCOMES USING INDICATORS
7	(a) Report. Annually, on or before July 30, the Chief Performance Officer
8	within the Agency of Administration shall report to the General Assembly on
9	the State's progress in reaching the population-level outcomes for each area of
10	Vermont's quality of life set forth in subsection (b) of this section by providing
11	data for the population-level indicators that are requested pursuant to the
12	process set forth in subsection (c) of this section.
13	(b) Vermont population-level quality of life outcomes.
14	(1) Vermont has a prosperous economy.
15	(2) Vermonters are healthy.
16	(3) Vermont's environment is clean and sustainable.
17	(4) Vermont's communities are safe and supportive.
18	(5) Vermont's families are safe, nurturing, stable, and supported.
19	(6) Vermont's children and young people achieve their potential,
20	including:
21	(A) Pregnant women and young people thrive.

1	(B) Children are ready for school.
2	(C) Children succeed in school.
3	(D) Youths choose healthy behaviors.
4	(E) Youths successfully transition to adulthood.
5	(7) Vermont's elders and people with disabilities and people with
6	mental conditions live with dignity and independence in settings they prefer.
7	(8) Vermont has open, effective, and inclusive government at the State
8	and local levels.
9	(c) Requesting population-level indicators.
10	(1) Annually, on or before March 1, a standing committee of the
11	General Assembly having jurisdiction over a population-level quality of life
12	outcome set forth in subsection (b) of this section may submit to the
13	Government Accountability Committee a request that any population-level
14	indicator related to that outcome be revised.
15	(2) If that request is approved by the Government Accountability
16	Committee, the President Pro Tempore of the Senate, and the Speaker of the
17	House, the Chief Performance Officer shall revise and report on the
18	population-level indicator in accordance with the request and this section.
19	(d) The report set forth in this section shall not be subject to the limitation
20	on the duration of agency reports set forth in 2 V.S.A. § 20(d).

1	§ 2312. PERFORMANCE ACCOUNTABILITY LIAISONS TO THE
2	GENERAL ASSEMBLY
3	(a) The Chief Performance Officer shall designate an employee in each
4	agency of State government to be a performance accountability liaison to the
5	General Assembly. A liaison designated under this section shall be responsible
6	for reviewing with the General Assembly any of the population-level outcomes
7	and indicators set forth in section 2311 of this subchapter to which that agency
8	contributes and for responding to any other requests for results-based
9	accountability information requested by the General Assembly.
10	(b) The performance accountability liaisons shall report to the Chief
11	Performance Officer on any action taken under subsection (a) of this section.
12	(c) Annually, on or before July 30 and as part of any other report
13	requirement to the General Assembly set forth in this subchapter, the Chief
14	Performance Officer shall report to the General Assembly on his or her
15	analysis of the actions taken by the performance accountability liaisons under
16	this section.
17	§ 2313. PERFORMANCE CONTRACTS AND GRANTS
18	(a) The Chief Performance Officer shall have oversight over the State's
19	performance contracts and grant-making in order to:
20	(1) assist contractors and grantees in developing performance measures
21	for those contracts and grants; and

1	(2) ensure contractors and grantees subject to those contracts and grants
2	meet the performance requirement specified therein.
3	(b) Annually, on or before July 30 and as part of any other report
4	requirement to the General Assembly set forth in this subchapter, the Chief
5	Performance Officer shall report to the General Assembly on the progress by
6	rate or percent of how many State contracts and grants have performance
7	accountability requirements.
8	Sec. 3. INITIAL POPULATION-LEVEL INDICATORS
9	Until any population-level indicators are requested pursuant to the
10	provisions of Sec. 2 of this act, 3 V.S.A. § 2311(c) (requesting population-level
11	indicators), each population-level quality of life outcome set forth in Sec. 2 of
12	this act, 3 V.S.A. § 2311(b) (Vermont population-level quality of life
13	outcomes), and listed in this section shall have the following population-level
14	indicators:
15	(1) Vermont has a prosperous economy.
16	(A) Percent or rate per 1,000 jobs of nonpublic sector employment.
17	(B) Median household income.
18	(C) Percent of Vermont covered by state-of-the-art
19	telecommunications infrastructure.
20	(D) Median house price.
21	(E) Rate per 1,000 residents of resident unemployment.

1	(F) Percent of structurally-deficient bridges, as defined by the
2	Vermont Agency of Transportation.
3	(G) Percent of local farm sales.
4	(2) Vermonters are healthy.
5	(A) Percent of adults who exceed healthy weight.
6	(B) Percent of adults who smoke cigarettes.
7	(C) Rate per 1,000 adults of adults who are homeless.
8	(D) Percent of individuals and families living at different poverty
9	<u>levels.</u>
10	(E) Percent of adults at or below 200 percent of federal poverty level.
11	(F) Percent of adults who are insured.
12	(3) Vermont's environment is clean and sustainable.
13	(A) Percent of waters that need remediation under the Clean
14	Water Act.
15	(B) Percent of water, sewer, and stormwater systems that meet
16	federal and State standards.
17	(C) Carbon dioxide per capita.
18	(D) Electricity by fuel or power type.
19	(4) Vermont's communities are safe and supportive.
20	(A) Rate per 1,000 adults 25 years of age or older of out-of home
21	placements for such adults.

1	(B) Rate per 1,000 residents of petitions filed for relief from domestic
2	abuse.
3	(C) Rate per 1,000 crimes of violent crime.
4	(D) Rate per 1,000 residents of sexual assault committed against
5	residents.
6	(E) Percent of residents living in affordable housing.
7	(F) Percent or rate per 1,000 formerly incarcerated residents of
8	residents returned to prison for technical violations of probation or parole.
9	(G) Percent or rate per 1,000 nonviolent offenders of nonviolent
10	offenders diverted from prison into the community.
11	(H) Percent or rate per 1,000 people convicted of crimes of
12	recidivism.
13	(I) Rate per 1,000 crimes of violent crime.
14	(J) Rate per 1,000 residents of residents incarcerated.
15	(K) Percent or rate per 1,000 residents of residents entering the

7	pregnancy in such teenagers.
8	(ii) Percent of students who report using alcohol, tobacco, or drugs
9	within the last 30 days.
10	(iii) Number and rate per 1,000 minors of minors who are under
11	the supervision of the Department of Corrections.
12	(E) Youths successfully transition to adulthood.
13	(i) Percent of high school seniors with plans for education,
14	vocational training, or employment.
15	(ii) Percent of graduating high school seniors who continue their

1	Sec. 4. CHIEF PERFORMANCE OFFICER; REPORT ON
2	PERFORMANCE MEASURE PILOT PROGRAM
3	(a) Annually, on or before July 30 and as part of any other report
4	requirement to the General Assembly set forth in Sec. 2 of this act, 3 V.S.A.
5	chapter 45, subchapter 5 (Chief Performance Officer), the Chief Performance
6	Officer shall submit to the General Assembly a report on the Department of
7	Finance and Management's Performance Measure Pilot Program. The report
8	shall include:
9	(1) the performance measure data collected by the pilot participants; and
10	(2) the progress of all programs in the Executive Branch and how many
11	of those programs have and are using performance measures.
12	(b) The Chief Performance Officer shall collaborate with the Joint Fiscal
13	Office in developing new performance measures for programs.
14	Sec. 5. APPROPRIATION; GOVERNMENT ACCOUNTABILITY
15	COMMITTEE; RESULTS-BASED ACCOUNTABILITY
16	TRAINING
17	(a) There is appropriated from the General Fund to the General Assembly
18	in Fiscal Year 2015 the amount of \$20,000.00 for training on results-based
19	accountability, as determined by the Government Accountability Committee
20	(the GAC).

1	(b) The GAC may use any portion of this appropriation for training		
2	legislators, Executive Branch program managers, community partners, and any		
3	other persons it determines necessary on results-based accountability in order		
4	to share knowledge, understand current trends in program results, and expand		
5	the use of results-based accountability in State government and among		
6	community partners.		
7	Sec. 6. CHIEF PERFORMANCE OFFICER; INITIAL PERFORMANCE		
8	ACCOUNTABILITY LIAISON APPOINTMENTS		
9	The Chief Performance Officer within the Agency of Administration shall		
10	make his or her initial designations of the performance accountability liaisons		
11	described in Sec. 2 of this act, 3 V.S.A. § 2312, by November 15, 2014.		
12	Sec. 7. QUARTERLY PROGRESS REPORTS; TEMPORARY SUSPENSION		
13	The report requirement set forth in 2010 Acts and Resolves No. 146,		
14	Sec. H4 (Challenges for Change; quarterly reporting and implementation) is		
15	temporarily suspended. The report requirement shall resume in 2017		
16	beginning with the first quarterly report due for that year.		
17	Sec. 8. REPEAL; ANNUAL REPORT ON POPULATION-LEVEL		
18	OUTCOMES AND INDICATORS		
19	Sec. 2 of this act, 3 V.S.A. § 2311 (Chief Performance Officer; annual		
20	report on population-level outcomes using indicators), is repealed on		
21	<u>January 1, 2017.</u>
