

1 TO THE HONORABLE SENATE:

2 The Committee on Health and Welfare to which was referred House Bill
3 No. 123 entitled “An act relating to Lyme disease and other tick-borne
4 illnesses” respectfully reports that it has considered the same and recommends
5 that the Senate propose to the House that the bill be amended as follows:

6 First: By striking out Sec. 3 in its entirety and inserting in lieu thereof a
7 new Sec. 3 to read as follows:

8 Sec. 3. POLICY STATEMENT

9 A policy statement clearly communicating the following shall be issued by
10 the Vermont State Board of Medical Practice to physicians licensed pursuant
11 to 26 V.S.A. chapter 23 and to physician assistants licensed pursuant to
12 26 V.S.A. chapter 31; the Vermont Board of Osteopathic Physicians to
13 physicians licensed pursuant to 26 V.S.A. chapter 33; the Office of
14 Professional Regulation to physicians licensed pursuant to 26 V.S.A.
15 chapter 81; and the Vermont Board of Nursing to advanced practice registered
16 nurses licensed pursuant to 26 V.S.A. chapter 28:

17 (1) a physician, physician assistant, or nurse practitioner, as appropriate,
18 shall document the basis for diagnosis of and treatment for Lyme disease, other
19 tick-borne illness, or coinfection in a patient’s medical record;

20 (2) a physician, physician assistant, or nurse practitioner, as appropriate,
21 shall obtain a patient’s informed consent in writing prior to administering a

1 diagnostic Lyme disease test and any proposed long-term treatment for Lyme
2 disease, other tick-borne illness, or coinfection; and

3 (3) the Board or Office of Professional Regulation shall not pursue
4 disciplinary action against a physician, physician assistant, or nurse
5 practitioner, as appropriate, solely for the use of medical care recognized by
6 the guidelines of the Centers for Disease Control and Prevention, Infectious
7 Diseases Society of America, or International Lyme and Associated Diseases
8 Society for the treatment of a patient's symptoms when the patient is clinically
9 diagnosed with Lyme disease or other tick-borne illness; however, this does
10 not preclude discipline for errors, omissions, or other unprofessional conduct
11 when practicing within such guidelines.

12 Second: By inserting a new Sec. 4 after Sec. 3 to read as follows:

13 Sec. 4. REPORT

14 On or before January 15, 2016, the Commissioner of Health shall report to
15 the House Committee on Health Care and to the Senate Committee on Health
16 and Welfare on the following:

17 (1) the trends in the spread of Lyme disease and other tick-borne
18 illnesses throughout Vermont, including a description of the surveillance
19 criteria used in evaluating the spread of these diseases; and

1 (2) the Department of Health’s public education initiatives to date
2 regarding the prevention and treatment of Lyme disease and other tick-borne
3 illnesses, including an assessment of each initiative’s effectiveness.
4 and by renumbering the remaining section to be Sec. 5.
