15	Second: By striking out Sec. 15 in its entirety and inserting in lieu thereof

18	Sec. 15. 10 V.S.A. § 5001 is amended to read;
19	§ 5001. HUNTING DOGS; FIELD TRAINING
20	(a) While accompanying the dog, a person may train a hunting dog to hunt
21	and pursue:

1	(1) Bear bear during the period from June 1 to September 15 and then
2	only from sunrise to sunset;
3	(2) Rabbits rabbits and game birds during the period from June 1 to the
4	last Saturday in September and then only from sunrise to sunset;
5	(3) Raccoon raccoon during the period from June 1 to the last Saturday
6	in September at any time of the day or night through any time of day or night
7	on the day before the opening day of raccoon hunting season; and
8	(4) Bobcat bobcat and fox during the period June 1 to March 15, except
9	during regular deer season as prescribed in section 4741 of this title.

11	Sec. 16. EFFECTIVE DATE
12	(a) This section and Secs. 1-2 (landowner exception; captive hunt;
13	definitions), 3 (license for disabled veteran), 3a (Joint Fiscal Office report on
14	fiscal impact of issuing hunting licenses to disabled veterans), 8 (shooting from
15	or across highway), and 15 (training hunting dogs; raccoon season) shall take
16	effect on passage.
17	(b) Secs. 4 (migrating game bird harvest numbers), 10 (conservation
18	registration plates report), 11-13(cultural and ceremonial use of bird feathers),
19	and 14 (State Fly-Fishing Fly) shall take effect on July 1, 2014.
20	(c) Secs. 5-7 (deer season rules) and 9 (conservation plates; proceeds) shall
21	take effect on January 1, 2015.
