**Re:** Report on Econometric Modeling Recommendations

Required by Section 2 of Act 112 of 2012

This report reviews the current status of findings and recommendations toward satisfying Section 2 of Act 112 of 2012. Section 1 of Act 112 of 2012 requires the Secretary of Administration and the legislative economist to design and implement a one-year pilot project to conduct an econometric analysis when evaluating government contracts for goods and services by the Department of Buildings and General Services, the Agency of Natural Resources, and the Department of Corrections. Section 2 requires the Secretary of Administration, working with the legislative economist, to submit a report to the House and Senate Committees on Government Operations and on Natural Resources and Energy, the House Committee on Corrections and Institutions, and the Senate Committee on Institutions on the results of the econometric analysis pilot project and any further legislative or policy recommendations for expansion, adaptation, or elimination of econometric analysis in government contracting.

I am proposing to shift the deadline for the Section 2 report for an additional month and a half, to February 28, 2014, to accommodate the current project schedule. A summary of the current project work plan follows:

It is anticipated that the February 28, 2014 report and recommendations will include:

- results of hypothetical model runs
- recommendations for contract areas that appear to have potential for in-state contracting
- information requirements needed in Requests For Proposal (RFP) to enable modeling for bid evaluation
- actionable information and recommendations for State contracting personnel
- a concise review of known issues (Federal funding, security of the bidding process, etc.).

In addition, the pilot project will continue its data collection from ongoing RFPs, emphasizing the importance of certain data regarding proportions of Vermont labor and purchased goods/services used to fulfill State contracts, and will introduce an educational outreach effort to all departments with significant activity in promising contracting areas.

<sup>&</sup>lt;sup>1</sup> A "hypothetical <u>model</u>" runs selected contract subject areas, where the data indicates large contracts that could be bid on by an instate entity, to estimate the net cost to taxpayers of a hypothetical contract awarded to a 100% in-state entity compared to a 100% out-of-state entity. For cases where linearity is affected by disparities in the multiplier for elements within a contract, values between 100% in and out of state may be included.
