13	It is hereby enacted by the General Assembly of the State of Vermont:
14	Sec. 1. 16 V.S.A. § 822a(g) is amended to read:
15	(g) Tuition and other costs.
16	(1) Unless the sending and receiving schools agree to a different
17	arrangement, no tuition or other cost shall be charged by the receiving district
18	or paid by the sending district for a sending district shall pay tuition for each
19	student transferring to a different high school under this section; provided,
20	however, a pursuant to subsection 824(b) of this title. In addition, the sending

1	high school district shall pay special education and career technical education
2	costs for resident students pursuant to the provisions of this title.
3	(2) A student transferring to a different high school under this section
4	shall pay no tuition, fee, or other cost that is not also paid by students residing
5	in the receiving district.
6	(3) A district of residence shall include within its average daily
7	membership any student who transfers to another high school under this
8	section; a receiving school district shall not include any student who transfers
9	to it under this section.
