17	(c) In carrying out the responsibility to investigate compliance with
18	sections 687, 688, 690, 692, and 708 of this chapter, the Commissioner, the
19	Director, or their agents, may enter upon an employer's premises, upon

presenting appropriate credentials to the occupant, for the purposes of

1	determining whether workers on the premises are properly classified as
2	employees or independent contractors, whether the workers are covered by a
3	workers' compensation insurance policy, whether wages or other payments are
4	properly reported for workers' compensation purposes, and whether the
5	workers are properly coded for insurance premium calculation purposes. The
6	Department shall enter at reasonable times, within reasonable limits, and in a
7	reasonable manner. If entry is refused, the Commissioner or Director may
8	apply to the Civil Division of the Superior Court for an order to enforce the
9	rights given to the Commissioner, the Director, and their agents under this
10	section.
11	Sec. 2. STUDY; REPORT
12	The Commissioner of Labor, in consultation with the Commissioner of
13	Disabilities, Aging, and Independent Living, shall study the effectiveness and
14	costs of the screening process required pursuant to 21 V.S.A. § 641 that is used
15	to determine the eligibility of injured workers for vocational rehabilitation
16	benefits. The Commissioner of Labor shall report to the House Committee on
17	Commerce and Economic Development and the Senate Committee on
18	Economic Development, Housing and General Affairs on the results of the
19	study on or before November 15, 2015. The report shall include
20	recommendations for statutory, regulatory, and administrative changes to
