16	It is hereby enacted by the General Assembly of the State of Vermont:
17	Sec. 1. PURPOSE
18	The General Assembly deems it prudent to direct the Department for
19	Children and Families to develop an education and outreach program related to
20	the Department's general and emergency rental assistance programs in order to

1	improve landlords' understanding of the programs and to ensure that the
2	Department's rental assistance programs function more efficiently and
3	accountably for Vermont taxpayers.
4	Sec. 2. 33 V.S.A. § 2115 is added to read:
5	§ 2115. RENTAL ASSISTANCE OUTREACH
6	(a) On or before December 1, 2015, the Department for Children and
7	Families shall develop and implement an ongoing education and outreach
8	program to inform Vermont landlords about the rental assistance provided
9	through the General Assistance Program and the Rental Arrearage Program
10	pursuant to this chapter.
11	(b) The education and outreach program shall, at a minimum, provide
12	Vermont landlords with information regarding:
13	(1) the rental assistance provided under the General Assistance Program
14	and the Rental Arrearage Program;
15	(2) the procedures and rules for the rental assistance under each
16	program;
17	(3) the relationship between the rental assistance provided under the
18	General Assistance Program and the Rental Arrearage Program and assistance
19	provided through other programs operated by the Department; and
20	(4) the eligibility requirements that tenants must meet to receive rental
21	assistance under each program.

1	Sec. 3. REPORT
2	The Commissioner for Children and Families shall report to the House
3	Committees on General, Housing, and Military Affairs and on Human Services
4	and the Senate Committees on Economic Development, Housing, and General
5	Affairs and on Health and Welfare on or before January 1, 2017, regarding the
6	effectiveness of the outreach program and any legislative action that may be
7	necessary to improve the efficiency and effectiveness of the rental assistance
8	provided under the General Assistance Program and the Rental Arrearage
9	Program pursuant to 33 V.S.A. chapter 21.
10	Sec. 4. EFFECTIVE DATE
11	This act shall take effect on July 1, 2015.
