Statement of purpose of bill as introduced: This bill proposes to approve the  
amendments to the charter of the Town of Middlebury.

An act relating to approval of amendments to the charter of the Town of  
Middlebury

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. CHARTER AMENDMENT APPROVAL

The General Assembly approves the amendment to the charter of the Town  
of Middlebury as set forth in this act. The voters approved the proposals of  
amendments on April 28, 2015.

Sec. 2. 24 App. V.S.A. chapter 127 is amended to read:

CHAPTER 127. TOWN OF MIDDLEBURY

Subchapter 3. Officers

2 § 302. ELECTIVE OFFICERS

3 (a) The officers elected by the Town at its annual meeting shall be:

5 (5) Three auditors, unless the Town has voted to eliminate the office of  
6 auditor pursuant to 17 V.S.A. § 2651b.

8 § 304. OTHER ELECTIVE OFFICERS

10 (b) The three auditors shall be elected in the same manner as described for  
11 the Board of Listers, in subdivision (a)(1) of this section, unless the Town has  
12 voted to eliminate the Office of Auditor pursuant to 17 V.S.A. § 2651b.

13 (1) The elected auditors shall be responsible for establishing and  
14 approving an independent municipal audit by a registered or certified public  
15 accountant. Such independent audit shall be required at least once a year.

16 (2) The auditors' duties shall otherwise be as established in  
17 24 V.S.A. §§ 1681-1691.

18 (3) Notwithstanding anything to the contrary in 17 V.S.A. § 2651b(c),  
19 the Town may vote by ballot at an annual meeting, pursuant to  
20 17 V.S.A. § 2651b(a), to eliminate the Office of Town Auditor. If the Town  
21 votes to eliminate the Office of Auditor, the duties formerly carried out by the

1 auditors shall be carried out in accordance with 17 V.S.A. § 2651b(a) and any  
2 other applicable statutes.

6 § 506. COMPENSATION

7 (a) The auditors shall fix the compensation of the ~~selectmen~~ members of  
8 the Selectboard, unless the Town has voted to eliminate the Office of Auditor  
9 pursuant to 17 V.S.A. § 2651b, in which case the Town may fix the  
10 compensation of the members of the Selectboard at an annual meeting. If the  
11 Town has voted to eliminate the Office of Auditor and the voters fail to fix the  
12 Selectboard's compensation, the members of the Selectboard shall be  
13 compensated at the rate at which they were compensated during the  
14 immediately preceding year.

15 (b) Except as provided in sections 506(a) and 704(1) of this ~~charter~~ chapter,  
16 the ~~selectmen~~ Selectboard shall fix the compensation of all elected officers and  
17 all officers appointed by them. An elected official may notify the ~~selectmen~~  
18 Selectboard in writing, at least 50 days before the annual meeting, that ~~he/she~~  
19 he or she wishes ~~his/her~~ his or her compensation fixed by the Town, and the  
20 ~~selectmen~~ Selectboard shall insert an article in the warning to that effect. If so  
21 warned, the Town may fix the compensation of that elected official for the

1 balance of ~~his/her~~ his or her term of office or for such shorter period as the  
2 Town may vote.
