8 Subject: Health; professions and occupations; physicians; athletic teams;
9 licensure

10 Statement of purpose of bill as introduced: This bill proposes to allow visiting
11 team physicians licensed to practice medicine in another state to serve their
12 teams while in Vermont without being licensed by the Vermont Board of
13 Medical Practice or the Vermont Board of Osteopathic Physicians and
14 Surgeons.

15 An act relating to an exemption from licensure for visiting team physicians

1 It is hereby enacted by the General Assembly of the State of Vermont:

2 Sec. 1. 26 V.S.A. § 1313(a) is amended to read:

3 (a) The provisions of this chapter shall not apply to the following:

4 (1) a health care professional licensed or certified by the office of
5 professional regulation when that person is practicing within the scope of his
6 or her profession;

7 (2) a member of the ~~United States~~ U.S. military or national guard,
8 including a national guard member in state status, or to any person giving aid,
9 assistance, or relief in emergency or accident cases pending the arrival of a
10 regularly licensed physician;

11 (3) a nonresident physician coming into this state to consult or using
12 telecommunications to consult with a duly licensed practitioner herein; ~~or~~

13 (4) a duly licensed physician in another state, in Canada, or in another
14 nation as approved by the board who is visiting a medical school or a teaching
15 hospital in this state to receive or conduct medical instruction for a period not
16 to exceed three months, provided the practice is limited to that instruction and
17 is under the supervision of a physician licensed by the board; or

18 (5) a physician licensed in another state, territory, or jurisdiction of the
19 United States if the physician is employed as or formally designated as the
20 team physician by an athletic team visiting Vermont for a specific sporting
21 event and the physician limits the practice of medicine in this State to medical

1 treatment of the members, coaches, and staff of the sports team employing or
2 designating the physician.

3 Sec. 2. 26 V.S.A. § 1753(c) is amended to read:

4 (c) The provisions of this chapter shall not apply to:

5 (1) A a commissioned officer of the U.S. Armed Forces or Public Health
6 Service when acting within the scope of his or her official duties;;

7 (2) A a nonresident licensed osteopathic physician or surgeon who is
8 called to treat or to consult on a particular case in this State provided he or she
9 does not otherwise practice in this State; or

10 (3) an osteopathic physician licensed in another state, territory, or
11 jurisdiction of the United States if the physician is employed as or formally
12 designated as the team physician by an athletic team visiting Vermont for a
13 specific sporting event and the physician limits the practice of medicine in this
14 State to medical treatment of the members, coaches, and staff of the sports
15 team employing or designating the physician.

16 Sec. 3. EFFECTIVE DATE

17 This act shall take effect on July 1, 2016.
