7	Statement of purpose of bill as introduced: This bill proposes to prohibit a
8	person from flying an unmanned aircraft for hobby or recreational purposes at

11	engaged in the business of selling unmanned aircraft to notify purchasers about
12	the 100-foot minimum altitude requirement.

16	It is hereby enacted by the General Assembly of the State of Vermont:

20	(a)(1) No person shall fly an unmanned aircraft for hobby or recreational
21	purposes at an altitude of less than 100 feet above privately owned real

1	property unless the person has obtained prior written consent from the property
2	owner.
3	(2) A person engaged in the business of selling unmanned aircraft shall
4	provide written notice to each purchaser of an unmanned aircraft system
5	required to be registered by the U.S. Department of Transportation that
6	Vermont law prohibits flying an unmanned aircraft for hobby or recreational
7	purposes at an altitude of less than 100 feet above privately owned real
8	property unless the person has obtained prior written consent from the property
9	owner.
10	(b) A person who violates subsection (a) of this section shall be assessed a
11	civil penalty of not more than:
12	(1) \$50.00 for a first violation; or
13	(2) \$250.00 for a second or subsequent violation.
14	(c) As used in this section:
15	(1) "Property owner" means a person who owns, leases, licenses, or
16	otherwise controls ownership or use of land, or an employee or agent of that
17	person.
18	(2) "Unmanned aircraft" is an aircraft that is:
19	(A) operated without the possibility of direct human intervention
20	from within or on the aircraft;
21	(B) capable of sustained flight in the atmosphere; and

1	(C) flown within the visual line of sight of the person operating the
2	aircraft.
