1	It is hereby enacted by the General Assembly of the State of Vermont:

3	§ 2030. IDENTITY THEFT
4	(a)(1) No person shall obtain, produce, possess, use, sell, give, or transfer
5	personal identifying information belonging or pertaining to another person
6	with intent to use the information to commit a misdemeanor or a felony.
7	(2) No person 18 years of age or older shall obtain, produce, possess,
8	use, sell, give, or transfer personal identifying information belonging or
9	pertaining to another person under 18 years of age and use the information to
10	create an Internet website account:
11	(A) in the name of the person under 18 years of age;
12	(B) without the consent of the person under 18 years of age; and
13	(C) for the purpose of concealing the name of the person 18 years of
14	age or older while accessing information or a website that is restricted to
15	<u>adults.</u>

17	(c) For the purposes of this section, "personal identifying information"
18	includes name, address, birth date, Social Security number, motor vehicle

5	(d) This section shall not apply when a person obtains the personal
6	identifying information belonging or pertaining to another person to

9	(e) It shall be an affirmative defense to an action brought pursuant to this
10	section, to be proven by a preponderance of the evidence, that the person had
11	the consent of the person to whom the personal identifying information relates
12	or pertains.
13	(f)(1) A person who violates subdivision (a)(1) or subsection (b) of this
14	section shall be imprisoned for not more than three years or fined not more
15	\$5,000.00, or both. A person who is convicted of a second or subsequent
16	violation of subdivision (a)(1) or subsection (b) of this section involving a
17	separate scheme shall be imprisoned for not more than 10 years or fined not
18	more than \$10,000.00, or both.
