11	It is hereby enacted by the General Assembly of the State of Vermont:

14	As used in this chapter:
15	(1) "Animal" means all living sentient creatures, not human beings.
16	(2) "Secretary" means the Secretary of Agriculture, Food and Markets.

18	(7) "Necessary medical attention" shall include medical treatment for
19	illness, injury, disease, excessive parasitism, or malformed or overgrown hoof.

1	(11) "Livestock" means cattle, bison, horses, sheep, goats, swine,
2	cervidae, ratites, and camelids.

4	(13) "Livestock and poultry husbandry practices" means the raising,
5	management, and using of animals to provide humans with food, fiber, or
6	transportation in a manner consistent with:
7	(A) husbandry practices recommended for the species by agricultural
8	colleges and the U.S. Department of Agriculture Extension Service;
9	(B) husbandry practices modified for the species to conform to the
10	Vermont environment and terrain; and

13	(19) "Bovine" means an animal of the family bovidae.
14	(20) "Tail docking" means a procedure in which the spinal cord part of
15	the tail of an animal is cut or removed for any purpose, including the
16	shortening of the tail.

18	<u>§ 367. TAIL DOCKING OF A BOVINE</u>
19	(a) Except as provided in subsection (b) of this section, a person shall not
20	perform a tail docking on a bovine.

1	(b) Subsection (a) of this section shall not apply to a person who performs a
2	tail docking on a bovine when a veterinarian licensed under 26 V.S.A. § 2425
3	determines that the tail docking is necessary to relieve pain or save the life of
4	the bovine, provided that the tail docking is performed:
5	(1) by a veterinarian licensed under 26 V.S.A. § 2425;
6	(2) after adequate anesthesia is administered to the bovine; and
7	(3) in a manner that minimizes long-term pain to the bovine.
8	(c) A person who violates this section shall be fined not more than \$500.00
9	per animal subject to the tail docking.
10	(d) Enforcement actions for violations of this section shall not require
11	consultation with the Secretary of Agriculture, Food and Markets pursuant to
12	section 354 of this title.
