Resolutions

H.C.R. 1.

House concurrent resolution recognizing January 8, 2015, as Homelessness Awareness Day at the State House

Offered by: Representatives Krowinski of Burlington and Head of South Burlington

<u>Whereas</u>, being deprived of a permanent place to live is an indignity that far too many Vermont families continue to endure, and

<u>Whereas</u>, the severe early-life impediments homeless children encounter may result in long-term consequences, and

<u>Whereas</u>, among homeless families are persons who have suffered a personal trauma such as job loss or domestic abuse, and

<u>Whereas</u>, the National Center on Family Homelessness (NCFH) reports that 29 percent of adults in homeless families are working, and

<u>Whereas</u>, the NCFH also documented that, in comparison with their peers, children experiencing homelessness are sick four times more often and have three times the rate of emotional and behavioral problems, and

<u>Whereas</u>, both the financial and human costs of homelessness strain public services, including education and physical and mental health care, and

<u>Whereas</u>, the Centers for Disease Control and Prevention's 2011 Youth Risk Behavior Survey found that homeless youths have a higher risk of being in a gang, using heroin, feeling depressed, or attempting suicide, and

<u>Whereas</u>, the Vermont Coalition to End Homelessness and the Chittenden County Continuum of Care's 2014 Point-in-Time count of the homeless in Vermont showed homelessness increased by 9.27% compared to 2013, and

<u>Whereas</u>, the U.S. Department of Housing and Urban Development's Annual Homeless Assessment Report reveals a 51 percent rise in homelessness in Vermont since 2007, the fifth highest increase among the 50 states, and

Whereas, the Emergency Solutions Grants Vermont Annual Report for State Fiscal Year 2014 documented 3,934 persons sheltered, of which 891 were minors, and

<u>Whereas</u>, according to this report, the number of families staying in ESG-funded homeless shelters increased from 517 in fiscal year 2012 to 713 in fiscal year 2014, and the majority of the increase in child homelessness was due to domestic violence, and

<u>Whereas</u>, the General Assembly believes it is imperative that no one, especially no child, should be homeless, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes January 8, 2015, as Homelessness Awareness Day at the State House, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Vermont Coalition to End Homelessness and to the Vermont Affordable Housing Coalition.

<u>Whereas</u>, Tim Corcoran was a life-long resident of Bennington and epitomized the political life of his hometown, and

<u>Whereas</u>, he was born in 1950 and graduated from both Bennington Catholic High School and Southern Vermont College, and

Whereas, Tim Corcoran served in the U.S. Army, and

<u>Whereas</u>, in March 1973, Tim Corcoran launched his public service career when he was elected to the Bennington Selectboard, and his tenure included terms as vice chair and chair, and

<u>Whereas</u>, in November 1980, the voters of his legislative district elected Tim Corcoran to his first of seven terms in the House of Representatives, and

<u>Whereas</u>, Representative Tim Corcoran's selectboard experience was drawn on during his service on the Municipal Corporations and Elections and Government Operations committees, and

<u>Whereas</u>, for several terms, he served on the important Appropriations Committee, and

<u>Whereas</u>, closer to home, Tim Corcoran was for many years the Bennington Assistant Town Clerk and in 1995 was elected Town Clerk, and

<u>Whereas</u>, Tim Corcoran was a dedicated town clerk as he devoted enormous amounts of time and energy to performing the office's duties to the best of his ability and, on a personal basis, touched the lives of so many, and

<u>Whereas</u>, despite his serious work responsibilities, Tim Corcoran maintained an active and vibrant sense of humor, and

<u>Whereas</u>, for many years, Tim Corcoran would organize memorable annual elementary school educational trips to the State House, and

Whereas, his fraternal organization memberships were numerous, and

<u>Whereas</u>, despite battling cancer, Tim Corcoran continued to serve as Bennington Town Clerk until his death on November 6, 2014, and

<u>Whereas</u>, his survivors include his wife, Linda; sons, David, Nathan, and Representative Tim Corcoran II; his granddaughter, Rylee; his father; three brothers; and a sister, now therefore be it

That the General Assembly extends its sincere condolences to the family of former Representative Timothy Corcoran of Bennington, and be it further

<u>Whereas</u>, after five years of employment with the Montpelier A&P grocery store, Rico Babic began a long career with the State of Vermont starting at the Department of Employment Security, and

Whereas, during his four decades as a State employee, Rico Babic held numerous positions, and for over a decade he worked as a business manager, and

Whereas, during World War II, he served in the U.S. Army as a classification specialist, and

<u>Whereas</u>, Rico Babic held both the Vermont Chapter presidency and the international treasurer's position with the International Association of Employment Security (now known as the IAWP), and

<u>Whereas</u>, upon his retirement from the State of Vermont in 1977, Rico Babic joined the Vermont State Retired Employees Association serving 11 years as its treasurer and a year as president, and

<u>Whereas</u>, Rico Babic is a life member of several fraternal organizations including the Elks, the American Legion, and the Knights of Columbus, and

<u>Whereas</u>, while living in retirement in Sarasota, Florida, Rico Babic served on various organizations' boards, including as treasurer of the American Slavic Club, and

<u>Whereas</u>, family has always been of prime importance to Rico Babic, and he is the father of five children, 13 grandchildren, and eight great-grandchildren, and

Whereas, January 20, 2015 marks 100 years since Rico Babic's birth and will be a day of great celebration for four generations of the Babic family, now therefore be it

<u>Whereas</u>, volunteer firefighters, and especially their chiefs, are among Vermont's unsung heroes and deserve special recognition for their round-the-clock availability to perform potentially dangerous but critical public safety duties, and

<u>Whereas</u>, during the past half century, two of Grafton's well-respected volunteer fire chiefs have been Ed McWilliam and Eric Stevens, whose combined firefighting service exceeds 90 years, and

Whereas, Ed McWilliam became a Grafton volunteer firefighter in 1955 and served as the department's chief from 1969–1984, and

<u>Whereas</u>, after concluding his tenure as chief, Ed McWilliam was president of the fire department's governing organization, the Grafton Firefighters Association, and

<u>Whereas</u>, Ed McWilliam is a founding member of the FAST/Rescue Squad and has served as a town lister, and

Whereas, he is a long-time member of the Grafton Church Council, and

<u>Whereas</u>, Eric Stevens began his illustrious Grafton volunteer firefighting career in 1982, rising through the ranks and serving for eight years as chief, and

<u>Whereas</u>, his public safety work has also included service as a FAST/Rescue Squad EMT, and he remains a responder, and

<u>Whereas</u>, in another community role, Eric Stevens is a veteran member of the Grafton Planning Commission, and

<u>Whereas</u>, in a musical context, Eric Stevens displays his instrumental talents as a member of the Grafton Cornet Band and other ensembles, and

<u>Whereas</u>, the firefighters of the Grafton Volunteer Fire Department will honor Ed McWilliam and Eric Stevens at a community dinner to take place on Saturday, January 24, 2015, at the Grafton Elementary School, in recognition of their stalwart leadership, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors former Grafton volunteer fire chiefs Ed McWilliam and Eric Stevens for their outstanding community service, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Ed McWilliam and to Eric Stevens.

H.C.R. 6.

House concurrent resolution congratulating Norwich University's Sullivan Museum and History Center on being designated as Vermont's first Smithsonian affiliate

Offered by: Representatives Grad of Moretown, Donahue of Northfield, and Lewis of Berlin

<u>Whereas</u>, in 1819, Captain Alden Partridge founded the American Literary, Scientific and Military Academy, now Norwich University, the nation's first private military college, and

<u>Whereas</u>, in 1902, Norwich University formally began collecting artifacts reflecting its history; in 2006–2007, The Sullivan Museum was created; and the collection is now housed in a state-of-the-art exhibition facility known as The Sullivan Museum and History Center, and

<u>Whereas</u>, the permanent collection includes over 11,000 items divided into several broad categories, including artwork, objects, and textiles, and

<u>Whereas</u>, complementing the permanent collection are outstanding special exhibits, including the recently concluded *1864: Some Suffer So Much*, telling the story of Norwich University alumni who have served as military surgeons from the Civil War to the present, and

<u>Whereas</u>, the Smithsonian, consisting of 19 diverse and distinctive national museums, the National Zoo, and nine research facilities, has a strong tie to Norwich University as alumnus George Colvocoresses participated in the Wilkes Expedition that gathered artifacts resulting in the establishment of the Smithsonian Institution and the core collection for its first museum known as the National Museum of Natural History, and

<u>Whereas</u>, the affiliates program of the Smithsonian enables local museums across the country to develop collaborative relationships with both the Smithsonian and the 196 affiliated museums and cultural institutions, and

<u>Whereas</u>, until 2014, no Vermont museum or other cultural organization had been awarded Smithsonian affiliation, and

<u>Whereas</u>, on September 2, 2014, Norwich University's Sullivan Museum and History Center was welcomed as Vermont's first Smithsonian affiliate at a festive ceremony featuring Harold Closter, the director of Smithsonian affiliations; U.S. Senator Leahy; Norwich University President Richard Schneider; and the Sullivan's Director and Norwich University Associate Professor Sarah E. Henrich, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates Norwich University's Sullivan Museum and History Center on being designated as Vermont's first Smithsonian affiliate, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to The Sullivan Museum and History Center at Norwich University.

Senate concurrent resolution congratulating the 2014 10- and 11-year-old Little League All-Star Vermont championship baseball team.

Whereas, baseball Little Leagues establish All-Star teams for different age groups, and these squads compete in postseason competition, and

Whereas, in 2014, the Mad River Valley Little League assembled a talented team of ten and eleven year olds whose well-practiced baseball skills challenged their peers from other Vermont communities, and

Whereas, Mad River defeated All-Star teams from Essex and Colchester to earn a berth in the championship round against Brattleboro, and

Whereas, because Mad River was the sole remaining undefeated team, Brattleboro was required to tally two consecutive victories in order to win the State championship, and

Whereas, although Mad River lost the first championship game, based on a walk-off hit, it bounced back to defeat Brattleboro 12–2 in the second game and was declared the 2014 Vermont Little League 10- and 11-year-old championship baseball team, the first State championship in 54 years of Mad River Little League competition, and

Whereas, the winning players included Cary Bond-Bardes, Angelo Cimminello, Clyden Heyward, Caleb Kingsbury, Gus Mosle, Anthony Pierce, Skylar Platt, Charlie Reilly, Vincent Spina, and Ethan Vierling, and Team Manager John Zimmerman and coaches Doug Mosle and Logan Cooke each contributed to the team's success, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the 2014 Mad River Valley 10- and 11-year-old Little League All-Star Vermont championship baseball team, *and be it further*

Senate concurrent resolution congratulating the Canadian Club Inc. of Barre on its 75th anniversary

Whereas, in the 1930s, the French Canadian community in Barre saw the need for a social organization to promote and retain the French Canadian culture in Barre, and

Whereas, to meet this objective, in 1939 a group of individuals gathered in Barre and created the French Canadian Club, and

Whereas, the Club began with 21 French Canadians, and its programs and administrative affairs were conducted in French, and

Whereas, the first officers were President Lucien Beaudoin, Vice President Raoul Maurice, Secretary Wilfred Langevin, and Auditor Antonio Pinard, and they had the assistance of Reverends Cray and Maloney, and

Whereas, some members sought to affiliate with other French Canadian clubs, but those wishing to remain independent prevailed, and

Whereas, in November 1940, the Club moved to larger space in the Blanchard Block that could accommodate social functions for 150 people, and

Whereas, on May 10, 1954, the Club was incorporated, and in 1955 it moved to temporary headquarters in the Paramount Theater Building, and

Whereas, in 1957 the now Canadian Club purchased the former Vermont Veterans Cooperative Workshop on East Montpelier Road and refurbished the facility as its permanent home, and

Whereas, the Club eventually opened its membership rolls to the broader public, beyond French speakers, although this was not an easy transition, and

Whereas, although a fire destroyed the building in January 1968, in just nine months a new structure was dedicated, and

Whereas, today the Canadian Club offers academic scholarships, social events, and a host of enjoyable activities, and

Whereas, the organization now has a membership of 1,200 and commemorated its 75th anniversary on September 27, 2014, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the Canadian Club on its 75th anniversary, *and be it further*
