**H. 15**

An act relating to approval of amendments to the charter of the Town of Colchester

**Rep. Devereux of Mount Holly**, for the Committee on **Government Operations**, recommends the bill be amended as follows:

First: In Sec. 2. 24 App. V.S.A. chapter 113, § 403, by redesignating the title to read:

§ 403. OATH; ~~BOND~~

Second: By striking out Sec. 3 in its entirety and inserting in lieu thereof the following:

Sec. 3. EFFECTIVE DATES

This act shall take effect on passage, except that Sec. 2. 24 App. V.S.A. chapter 113, § 702(a) and (b) (taxation penalty and interest) shall take effect on July 1, 2015.
