H.C.R. 18.

House concurrent resolution designating January 29, 2015, as Pharmacists Day in Vermont

Offered by: Representatives Clarkson of Woodstock and Till of Jericho

Whereas, pharmacists in Vermont's health care system work in partnership with physicians, health care clinics, hospitals, visiting nurses, hospice, and other individuals and organizations to reconcile patient medications, and

Whereas, an aging Vermont population requires that pharmacists apply their professional clinical skills to ensure that older patients are receiving medication counseling and the appropriate prescription and nonprescription drug dosages, and

Whereas, pharmacists provide Vermonters with easy access to immunizations, and

Whereas, due to increasingly complex health care and insurance systems, patients rely on pharmacists to make the connection between prescriber and patient to ensure timely dispensing of critical medicines, and

Whereas, pharmacists continue to be Vermont's most accessible health care professionals and play an essential role in the State's health care system, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates January 29, 2015, as Pharmacists Day in Vermont, and be it further

House concurrent resolution honoring departing Rutland City Police Chief James Baker for his superb leadership in challenging circumstances

Offered by: Representatives Russell of Rutland City, Cupoli of Rutland City, Fagan of Rutland City, and Gage of Rutland City

Offered by: Senators Collamore, Flory, and Mullin

Whereas, departing Rutland City Police Chief James Baker was concluding his distinguished tenure as a Vermont State Police Colonel and the State force's director, as the city of Rutland was experiencing a sharp rise in the amount of opiate addiction and a disturbing increase in crime, and

Whereas, simultaneously, a number of Rutland City police officers' extremely unprofessional conduct was embarrassing the department and lowering its morale, and

Whereas, in search of a person to overhaul the department, and to address the city's intertwined drug and law enforcement dilemmas, the city of Rutland persuaded Colonel Baker to accept this challenge, and

Whereas, unlike as a State Police Colonel, Chief Baker discovered the need for his direct involvement in many community and departmental issues, and

Whereas, for the department, he rewrote mission statements, core values, and policy manuals, and

Whereas, with respect to the city, Chief Baker endeavored to reestablish the department's credibility and effectiveness, and

Whereas, he had to engage directly with angry city residents who were upset with the city's crime problems, and

Whereas, on examining the city's situation, Chief Baker's views on the city's drug epidemic evolved to include supporting a methadone clinic for opiate addiction and assisting the addicted while still holding them legally accountable for their actions, and

Whereas, perhaps his most important initiative was devising a community intervention program that became Project Vision, encompassing nonprofit organizations, social service groups, and individuals, and

<u>Whereas</u>, as a first step, Chief Baker needed to serve a collaborative role to bring together organizations that were not necessarily on speaking terms, and

<u>Whereas</u>, although Chief Baker, who has recently accepted a senior position with the International Association of Chiefs of Police, assigned most of the credit for Project Vision's positive impact to others, he has stated that treating people with dignity and respect was essential, now therefore be it

Whereas, in his role as TRORC executive director, Peter Gregory supervises the commission's staff, serves as the organization's liaison with all levels of government, and is its leading public voice, and

Whereas, he currently serves as chair of the Vermont State Infrastructure Bank Program, and

Whereas, Peter Gregory is a past president of the Vermont Association of Planning and Development Agencies and was the 2013–2014 president of the National Association of Development Organizations, and

Whereas, in 2003, the New England Association of Regional Councils presented Peter Gregory its regional leadership award, and in 2012, the Vermont Planners Association honored him with its Mark Blucher Professional Planner of the Year Award, and

Whereas, Peter Gregory's leadership at TRORC preserving historic downtowns prompted the Preservation Trust of Vermont to present its 2014 Preservation Award to the commission, now therefore be it

Whereas, the Johnson family remains actively involved at SAPA-TV as Bruce Johnson's wife, Marita, now serves as its board's vice president, and

Whereas, greater Springfield greatly appreciates Bruce Johnson's contribution to improving access to community events and broadening the personal horizons of SAPA-TV's viewers, now therefore be it

Whereas, according to the Vermont Community Foundation, nonprofit organizations comprise 19.8 percent of Vermont's annual Gross State Product, and Vermonters donate millions of hours a year at these organizations, and

Whereas, the U.S. Department of Labor reported that in 2012 (the most recent data available), the nonprofit sector in Vermont included 44,131 employees with an average wage of \$44,882, and

Whereas, nonprofit organizations serve a vital role in facilitating charitable giving and social action, and

Whereas, Common Good Vermont helps these organizations to be more effective and efficient, through its delivery of online resources, training opportunities, partnerships, and signature events, and

Whereas, on February 5, 2015, under the auspices of Common Good Vermont, nonprofit organizations will gather in the State House to educate legislators concerning the activities of the nonprofit sector, now therefore be it

Whereas, former Representative Dominique Casavant was a native of Lewiston, Maine, graduated from Bates College with a degree in physics, and served in the U.S. Army, and

Whereas, Dom Casavant earned a master's degree from St. Michael's College and a second masters, and ultimately a Ph.D., at the University of Vermont, and

Whereas, for a remarkable 45 years, Dom Casavant was a respected faculty member at St. Michael's College where he taught physics, and

Whereas, the classroom and physics lab were not his only venue at St. Michael's College, as he enjoyed accompanying students to the snowy trails as the coach of the Nordic ski team, and

Whereas, Dom Casavant's interest in civic service led to his holding a number of positions in the Winooski city government, and

Whereas, his municipal roles included terms on the Winooski Development Committee, the Winooski Development Corporation, the Winooski Zoning Board, and the Winooski City Council, and

Whereas, the depth of experience he acquired while serving on different municipal panels persuaded the local voters to elect Dom Casavant to the Winooski mayoralty, an office he held with great pride from 1971–1975, and

Whereas, prior to the 1978 Adjourned Session of the General Assembly, Governor Snelling appointed Dom Casavant to a seat in the House of Representatives, he was elected in his own right for the 1979-1980 Biennium, and his wife, Lucille, served subsequently as a state legislator, and

Whereas, Domonique Casavant's physics expertise was called upon during his tenure on the Vermont State Nuclear Advisory Panel, and

Whereas, after retiring from the St. Michael's faculty, the Casavants returned to Maine, where Dom taught statistics at Central Maine Community College until May 2014, and

Whereas, former Representative Dom Casavant died on January 16, 2015, and survivors include his wife, their four children, Catherine, Thomas, Jay, and Andre, and the Casavant grandchildren, now therefore be it
