Whereas, in 1965 the General Assembly enacted Act 198, establishing the Vermont Student Assistance Corporation (VSAC) as an agency of the State "to provide opportunities for persons who are residents of Vermont to attend colleges or other institutions by awarding grants and guaranteeing loans," and

Whereas, VSAC guaranteed its first student loan in 1966 and the following year began administering Vermont Honor Scholarships, and

Whereas, a significant new facet of VSAC's work started in 1969 when it joined the federal Talent Search program for high school students belonging to families with low incomes or a minimal history of prior college attendance, and

Whereas, in 1981 VSAC began offering outreach services to adult learners and in 1982 expanded its grant-making to include funding for part-time study, and

Whereas, in 1984 Vermont became the first State to provide grants for nondegree study, increasing the opportunities for students to obtain the training and education needed for future careers, and

Whereas, in 1991 VSAC began participating in the federal Educational Opportunity Center program for adult learners, and

Whereas, in 1999 Vermont was one of the first states to participate in the GEAR UP Program that Senator Jeffords created based on the National Early Intervention Scholarship and Partnership that VSAC implemented, and

Whereas, also in 1999, VSAC established the Vermont Higher Education Investment Plan, enabling families to develop savings accounts for their children's college education, and

Whereas, in 2000 VSAC began offering career and education software to every middle and high school student, and

Whereas, by 2012 VSAC's total scholarships since its creation exceeded \$80 million and represented 47,000 awards to students, and

Whereas, VSAC has awarded 461,000 grants worth more than \$500 million for full-time, part-time, and nondegree students, and

Whereas, after half a century, VSAC remains a vital resource for assisting students in the financing of their higher education, now therefore be it

Whereas, his acquaintance with the town's wooded acreage also made him ideally suited to serve on the town's ancient road's committee in 2008–2009, and

Whereas, a special passion for Deryl Stowell was his involvement with the Cavendish Green Mountain Snow Fleas, a snowmobiling club, and

Whereas, as one of the club's founding members, he was instrumental in securing permission from landowners to allow snowmobiling trails on their property, and he served as the Snow Fleas' unofficial historian, and

Whereas, at his death at 83 years of age, on September 26, 2014, Deryl Stowell was serving as the club's vice president, and

Whereas, he graduated from Beeman Academy, having operated his family's farm as a high school student, and

Whereas, the Cloverset Farm continued to be the focus of Ken Sawyer's attention, and he and his wife, Suzanne, raised their four children on this homestead, and

Whereas, in 1971, Ken Sawyer was a proud cofounder of the New Haven Volunteer Fire Department and, for 19 years, he served as the department's second engineer, and

Whereas, in 1981, the Addison County Firefighters Association honored Ken Sawyer as its Company Officer of the Year Award recipient, and

Whereas, the importance that Ken Sawyer placed on his volunteer firefighting duties proved genetic as three of his four children and a granddaughter followed him in performing this special community service, and

Whereas, Ken Sawyer also gave his time to supporting public education as a school board member, and he gained great familiarity with the town's properties as a member of the zoning board of adjustment, and

Whereas, especially memorable in New Haven's town lore are the 19 years Ken Sawyer served as a justice of the peace, and

Whereas, aside from working at most elections and hearing tax appeals, Ken Sawyer presided at a most unusual wedding performed from a tractor seat, and this agriculturally set matrimonial union remains strong, and

Whereas, beyond the town of New Haven, Ken Sawyer served for 34 years on the Addison County committee of the federal Agricultural Stabilization Service (now the Farm Services Agency), and

Whereas, Ken Sawyer's death in 2014 marked the passing of a great husband, father, and grandfather, and the loss for New Haven of an irreplaceable citizen volunteer to whom the town has dedicated its 2014 annual report as a fitting memorial, now therefore be it

Whereas, these same NAEP test results showed that if Vermont were an independent nation, our State's student achievement scores would rank among the best in the world, including seventh internationally in eighth-grade mathematics, and

Whereas, unfortunately, when governmental funding is strained, expenditures for public education are often reduced, to the detriment of students and our state's economic future, and

Whereas, today, February 25, 2015, members of the Vermont-NEA are visiting the State House to explain to legislators why public education is vital to our state's future and to talk of the need for a sufficient number of highly-qualified and fairly-compensated teachers and other educators in our State's classrooms, and

Whereas, Ethan Duncan's compositional odyssey has coincided with his performance studies, and

Whereas, for the last two years, Ethan has composed in association with Music-COMP (the Music Composition Online Mentoring Program), a nonprofit organization supporting student composers, and

Whereas, Ethan Duncan's performed compositions include *Serenata*, *Scottish Sailor Song*, and *Arab March*, and

Whereas, in September 2014, he was honored as VPR Classical's Student Composer of the Month, and

<u>Whereas</u>, on January 21, 2015, at a Farmers' Night State House concert, an ensemble of Vermont Symphony Orchestra musicians performed the world premiere of Ethan Duncan's *A Year in Vermont*, a one-movement composition offering thematic musical interpretations of Vermont's contrasting seasons, and

Whereas, Ethan Duncan spoke to the capacity audience in the House chamber immediately prior to the work's premier, and then he followed the score in front of him as the musicians performed his piece, and

Whereas, Richard Werner was instrumental in the Dover Elementary School's completion of building renovations and an expansion of the school's campus, and

Whereas, his development of capital budget accounts financed the school's physical improvements, while the school district maintained stable tax rates, and

Whereas, Richard Werner led the town and school district in helping Dover become a solar powered community, and

Whereas, he also brought innovative and thoughtful leadership to his roles as vice chair and chair of the Windham Central Supervisory Union board, and

Whereas, for her first nine years on the Putney Central School's faculty, Kathleen Bartlett taught third grade, and

Whereas, seeking to work with students on a more individualized basis, in 1989, she completed a master's degree in counseling and consulting at Keene State College in nearby Keene, New Hampshire, and

Whereas, on earning her graduate degree, Kathleen Bartlett embarked on a new assignment at the Putney Central School as a guidance counselor, and

Whereas, aside from her classroom and guidance responsibilities, Kathleen Bartlett's other education roles in Putney have included serving as a student council advisor, a new teacher mentor, an advisor to the Putney school system's middle school leadership team, and an interim school principal, and

Whereas, the laudatory evaluations of Kathleen Bartlett's professional performance have cited her calm manner, sound judgment, continuing ability to inspire students, and her diagnostic skills and, in sum, have described her as an educator who displays "a level of competence most teachers only strive for," and

Whereas, the Bennington County Council on Aging was formed to provide similar services for senior citizens in neighboring Bennington County, and

Whereas, with respect to nutrition, SVCOA operates 37 meal sites and serves over 213,000 meals per year, and

Whereas, in an era of fewer public resources to finance its operations, SVCOA has created a fee-for-service division as a new revenue source, and

Whereas, in commemoration of the founding of the former Rutland County Council on Aging in 1974, the event that SVCOA considers to have marked its own establishment, the 2014 SVCOA annual meeting featured a special presentation entitled, "40 Years in Review," and

Whereas, SVCOA improves and brightens the lives of the many persons 60 years of age and older who avail themselves of the organization's diverse support services, now therefore be it

Whereas, in 1945, LCI realigned its jurisdictional map and transferred the Vermont Lions Clubs to a new District 44 with New Hampshire, and

Whereas, a momentous occasion occurred on June 5, 1955, when at a LCI District Convention, the Vermont Lions were reorganized into their own LCI District 45, and

Whereas, the District 45 Lions Clubs support the LCI Foundation's activities, including working to eradicate measles worldwide, providing glasses to Special Olympic athletes, facilitating international disaster relief, and supporting other activities that include the Sight First program and youth programs through the formation of Leo Clubs, and

Whereas, the Vermont Lions also sponsor many statewide programs that currently include the Lions Twin State Soccer Match, the Vermont Eye Bank at Porter Medical Center, and the Green Mountain Lions Camp for deaf and hard of hearing children, and

Whereas, individual Vermont Lions Clubs also conduct locally originated service projects including providing audiology equipment for schools,

financing corrective surgeries, offering student scholarships, and purchasing eyeglasses and hearing aids for needy Vermonters, and

Whereas, in 2015, LCI consists of 46,000 clubs and 1.3 million members worldwide, including the proud Lions of District 45, now therefore be it

Whereas, in approximately 1880, a significant number of Scottish immigrants arrived in Barre, and they aspired to establish their own church of the Presbyterian denomination, and

Whereas, at the direction of Elder John Gilchrist of the Presbyterian Church of South Boston, Massachusetts, the Reverend Charles K. Canfield of South Ryegate visited the Scottish community in Barre, and

*Whereas*, on Sunday, November 4, 1888, the Reverend Canfield conducted Barre's first Presbyterian service at the Barre Opera House, and

Whereas, on April 1, 1889, the First Presbyterian Church of Barre was established with 73 members, and Robert Kynoch and James Duncan were selected as the congregation's first Elders, and

Whereas, the first communion service was held on April 14, 1889, at the Park House, with the Reverend Wilmot Cummings presiding, and

Whereas, in 1891, the church society was incorporated as the First Presbyterian Church of Barre, and services continued to be held at interim sites, and

Whereas, on December 5, 1897, the First Presbyterian Church of Barre's own beautiful house of worship, located at the corner of Summer and South Seminary streets, was dedicated and, as expanded and modernized over the decades, remains its home in 2015, and

Whereas, during the past 125 years, the First Presbyterian Church of Barre has conducted an active ministry for congregants of all ages and has engaged in the denomination's mission programs both in the United States and internationally, and

Whereas, 2014 marked the First Presbyterian Church of Barre's 125th anniversary, and the celebratory events held to observe this historic occasion included the printing of special T-shirts, holding a commemorative service and big Scottish dinner on November 2, and the church's pastor, the Reverend Carl Hilton VanOsdall, delivering several sermons related to its history, now therefore be it
