H.C.R. 128.

House concurrent resolution designating April 29, 2015, as National Walk@Lunch Day in Vermont

Offered by: Representatives Frank of Underhill, McCullough of Williston, and Mrowicki of Putney

Whereas, National Walk@Lunch Day is a workplace walking event that encourages employees to walk during their lunch break, making exercise a convenient and easy choice during the day, and

Whereas, a brisk walk, even for only 30 minutes, five times a week, can result in significant health benefits, including lowering the risk of developing or dying from cardiovascular disease, hypertension, or type 2 diabetes, and it can improve one's muscles, bones, and joints, and

Whereas, walking is a fun activity that provides healthy exercise and an opportunity to enjoy the outdoors, and

Whereas, physical activity is vital to the well-being of all Americans, and National Walk@Lunch Day is an opportunity for Americans to carve time out of their busy work schedules to exercise and become healthier, and

Whereas, in 2015, National Walk@Lunch Day will be observed on April 29, and it provides a great chance for healthy, midday exercise, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates April 29, 2015, as National Walk@Lunch Day in Vermont, and be it further

House concurrent resolution recognizing April, 2015, as Fair Housing Month in Vermont

Offered by: House Committee on General, Housing and Military Affairs

Whereas, for generations, millions of Americans were denied the housing of their choice because of factors such as race, ethnicity, or religion, and

Whereas, on April 11, 1968, President Lyndon Johnson signed the Civil Rights Act of 1968, including Title VIII, known as the Fair Housing Act, and

Whereas, Vermont's Fair Housing Act, enacted in 1987 and expanded in subsequent legislative acts, now prohibits discrimination in the rental or sale of housing based on "race, sex, sexual orientation, gender identity, age, marital status, religious creed, color, national origin, or disability of a person, or because a person intends to occupy a dwelling with one or more minor children, or because a person is a recipient of public assistance," making this law more protective than the federal statutes and among the most comprehensive in the nation, and

Whereas, despite both these federal and State legal guarantees, the dilemma of housing discrimination in Vermont has not disappeared, and

Whereas, a recent HUD-funded Vermont Legal Aid investigation of housing practices documented some significant housing access barriers in Vermont for persons based on their race or national origin and for persons either living with children or who have disabilities, and

Whereas, 2012 Acts and Resolves No. 137 created new incentives for mobile home park development as a way to increase the availability of affordable housing, and

Whereas, this act strengthened the antidiscrimination requirements of mobile home park leases and

Whereas, the same act also added a new statutory provision banning municipal planning policies that discriminate against affordable housing, and

Whereas, the Governor's designation of April as Fair Housing Month highlights the crucial, but unfinished, effort to eliminate all vestiges of housing discrimination in Vermont, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes April, 2015, as Fair Housing Month in Vermont, and be it further

Whereas, the Honorable Amy Davenport's service to the people of Vermont in the Judicial Branch has been exemplary for 24 years as she presided in the Civil, Criminal, and Family Divisions of Vermont trial courts, and

Whereas, she was appointed as a Superior Court judge, specifically to preside in the new Family Court, a court she was instrumental in creating, and

Whereas, Judge Amy Davenport's exceptional talents led the Vermont Supreme Court to appoint her as Chief Administrative Judge in 2005, and

Whereas, in her role as Chief Administrative Judge, she shepherded the judiciary through a reorganization, assisting the Supreme Court in a successful legislative effort to consolidate and unify Vermont's trial courts into a Superior Court with five divisions: Civil, Criminal, Family, Probate, and Environmental, and

Whereas, Judge Amy Davenport provided exceptional assistance to the General Assembly as it created a new Juvenile Procedures Act that was sorely needed to protect the children of our State, and

<u>Whereas</u>, she was the recipient of the 2010 Distinguished Service Award from the National Center for State Courts, and

Whereas, professional excellence and attention to detail have marked her tenure on the bench and as an administrative judge, and

Whereas, Judge Amy Davenport has earned the respect and admiration of judges and employees of the judicial branch, now therefore be it

Whereas, this wonderful wife, mother of Annie and Christopher, grandmother of Zoe, Callin, and Emmett, sister of James, and a dear relative, colleague, and friend to many others died all too soon on March 7, 2015, now therefore be it
