H.C.R. 194.

House concurrent resolution designating January 8, 2016 as Martin St. Louis Day

Offered by: Representatives Krebs of South Hero, Beyor of Highgate, Brennan of Colchester, Connor of Fairfield, Deen of Westminster, Hubert of Milton, Jerman of Essex, Lefebvre of Newark, Lewis of Berlin, Macaig of Williston, McCullough of Williston, McFaun of Barre Town, Murphy of Fairfax, and Poirier of Barre City

<u>Whereas</u>, of all the players who have skated in a University of Vermont (UVM) Catamount hockey uniform, Laval, Quebec native Martin St. Louis ranks in a class all his own, and

<u>Whereas</u>, over the course of his 139-game UVM career (1993–1997), Martin St. Louis scored 91 goals, was responsible for 176 assists, and tallied 267 points, a still-standing Catamount scoring record, and

<u>Whereas</u>, as a junior, Martin St. Louis earned the Catamounts' team captaincy, and that season UVM won its first Eastern College Athletic Conference regular season title and appeared in the National Collegiate Athletic Association's (NCAA) Frozen Four hockey championship, and

<u>Whereas</u>, as a senior, Martin St. Louis again led the Catamounts to an NCAA championship tournament berth, and UVM awarded him the J. Edward Donnelly Award as the school's top male senior athlete, and

<u>Whereas</u>, Martin St. Louis was a three-time All American and a repeat contender for the NCAA's prestigious Hobey Baker Award, presented to the nation's top collegiate hockey player, and

Whereas, despite a grueling hockey schedule, Martin St. Louis graduated with a double major, and

<u>Whereas</u>, despite no National Hockey League (NHL) team's drafting him, Martin St. Louis proceeded to play an illustrious 16-season NHL career, scoring 391 goals, executing 642 assists; earning the Art Ross Trophy for NHL top scorer (twice) and the Hart Memorial Trophy for most valuable player; playing in six NHL All-Star games; and helping lead the 2004 Tampa Bay Lightning to the NHL championship and the Stanley Cup, and

<u>Whereas</u>, in 2007, UVM inducted Martin St. Louis into the university's athletic hall of fame, and, in 2012, the UVM Alumni Association presented him its alumni achievement award, and

<u>Whereas</u>, Martin St. Louis was a member of the 2014 Canadian Olympic championship hockey team, and

<u>Whereas</u>, in 2015, Martin St. Louis retired from the NHL, and the UVM hockey program will honor him, now the proud coach of his three sons' youth hockey teams, at Martin St. Louis Night festivities to be held at Gutterson Fieldhouse on Friday evening, January 8, 2016, now therefore be it

<u>Whereas</u>, Bill Aswad's World War II military service in Europe, with the 13th Armored Division, resulted in the U.S. Army's awarding him a bronze star for valor, and post-war, in the U.S. Army Reserve, he rose to the rank of major, and

<u>Whereas</u>, his career at General Electric started in Schenectady, New York as a chemical engineer and, for 35 years, he worked in Burlington, becoming manager of manufacturing engineering, and

<u>Whereas</u>, Bill Aswad's professional accomplishments highlight only one side of his long and active 93-year life, as his public service at all levels of government was a stellar example of personal civic engagement, and

Whereas, planning issues were especially important for Bill Aswad, and

<u>Whereas</u>, he served on and chaired the Burlington Planning Commission and the Chittenden County Regional Planning Commission, was president of both the Vermont Association of Planning and Development Agencies and the New England Association of Regional Councils, and sat on the National Association of Regional Council's board of directors, and

<u>Whereas</u>, Bill Aswad's municipal legislative service included chairing the Burlington City Council, and

<u>Whereas</u>, his eloquence as a speaker was demonstrated repeatedly when he offered opening remarks in the House, often focusing on American history, and

<u>Whereas</u>, railroads were Bill Aswad's passion, and he worked tirelessly to reestablish passenger rail service along Vermont's western corridor, and his efforts resulted in major strides toward this goal, and

<u>Whereas</u>, this conscientious public servant died on August 13, 2015, leaving his children, Dana, Marcy, Jon, and Scott, six grandchildren, his siblings, Kal, Sal, and Margaret, and companion, Mary Winn, now therefore be it

<u>Whereas</u>, a number of states and local communities throughout the country observe January as School Board Recognition Month in order to honor the special work of school boards, and this honor to Vermont's school boards and their members is well-deserved, now therefore be it

<u>Whereas</u>, Commissioner Reardon worked effectively with legislators of all political parties to assist in crafting a balanced budget, and he was known for working long hours to achieve this important objective, and

House concurrent resolution commemorating the 50th anniversary of the trail system and the 20th anniversary of the museum at Mount Independence

Offered by: Representatives Devereux of Mount Holly, Branagan of Georgia, Eastman of Orwell, and Jerman of Essex

<u>Whereas</u>, on July 7, 1776, following their military retreat from Canada, American generals convened a council of war at Crown Point, New York, and

<u>Whereas</u>, the generals agreed on the importance of developing a strong military presence on the eastern side of Lake Champlain, and upon further investigation settled on Rattlesnake Hill in Orwell, and

<u>Whereas</u>, on July 28, 1776, American military officers stationed at Rattlesnake Hill read aloud to their troops the newly issued Declaration of Independence, and the site became known as Mount Independence, and

<u>Whereas</u>, in the summer of 1777, American forces opted to abandon the extensive military fortification at Mount Independence and, following the Battle of Hubbardton that summer, British troops and their German allies occupied the site, and

<u>Whereas</u>, after an unsuccessful American raid to recapture Mount Independence and the British defeat at Saratoga, New York, the British departed, concluding the brief, but important, role of Mount Independence in the American Revolutionary War, and

<u>Whereas</u>, in 1961, the State of Vermont began to purchase parcels of land at Mount Independence in order to preserve this historical site for future generations, and

<u>Whereas</u>, in 1966, the State of Vermont opened four walking trails that pass historically significant Mount Independence archeological sites and offer vistas of Lake Champlain, and

<u>Whereas</u>, in 1996, the Division for Historic Preservation opened an architecturally unique history museum at Mount Independence designed "in the shape of a bateaux to symbolize the naval activities and strategic importance of Lake Champlain in the American Revolution," and

<u>Whereas</u>, Mount Independence's status as a national historic landmark is richly deserved, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 50th anniversary of the trail system and the 20th anniversary of the museum at Mount Independence, and be it further

House concurrent resolution honoring George Schenk of Warren for his contribution to Vermont's food and business communities

Offered by: Representatives Greshin of Warren, Grad of Moretown, and Jewett of Ripton

<u>Whereas</u>, in his youth, George Schenk watched attentively as his grandmother cooked over a wood fire, and recognized the advantages of this ancient process for baking grain-based food products, and

<u>Whereas</u>, after earning a degree in biology at Lycoming College in Pennsylvania, his life's path eventually led him to Vermont, and

<u>Whereas</u>, the origins of the American Flatbread Company (AFC) date to 1985, when George Schenk constructed a primitive, outdoor wood-fired oven on his property, and two years later, he built a larger one at Tucker Hill Lodge in Fayston, and

<u>Whereas</u>, the mission of AFC "is to provide good flavorful nutritious food that gives both joy and health, and to share this food with others in ways sustainable to all," and

Whereas, in 1990, AFC relocated to Lareau Farm in Waitsfield, and

<u>Whereas</u>, both restaurant and wholesale operations evolved, and AFC restaurants were started in Middlebury and later Burlington, as well as a separate franchising arrangement, the Flatbread Company, based in Amesbury, Massachusetts, and in 2006, AFC assumed ownership of the Inn at Lareau Farm, and

Whereas, a basic principle for AFC is purchasing and using local ingredients, and

<u>Whereas</u>, profit is hardly the sole motivation for George Schenk's business venture as his donation of thousands of flatbreads to the needy and annual benefit bakes for worthy causes attest, and

<u>Whereas</u>, George Schenk founded the Medicine Wheel Project and Organic Food for Public Schools, is an active member of Vermont Businesses for Social Responsibility, and serves on the Board of the Vermont Food Bank, and

<u>Whereas</u>, through his writings and activism, George Schenk promotes and supports increased reliance on local and organic foods, and

<u>Whereas</u>, through his generosity, deep commitment to community, and enduring love of high quality, locally sourced food, George Schenk has become a pillar of the economy and the spirit of the Mad River Valley, and

<u>Whereas</u>, Saturday, June 6, 2015 was the 30th anniversary of AFC, and the founding creative genius, local legend, and special Vermonter George Schenk was honored, now therefore be it

That the General Assembly honors George Schenk of Warren for his innovative roles in Vermont's food and business communities, and be it further
